We are pleased to inform that the Board of Directors of the Company at its meeting held today i.e. October 06, 2022, has *inter-alia*:

1. Considered and approved allotment of 5,00,000 Equity Shares of face value of Rs. 10/- each to the Promoters' Group, upon exercise of conversion of 5,00,000 convertible warrants into equal number of Equity Shares at a price of Rs. 105.20/- per share (including premium of Rs.95.20 /- per equity share) on receipt of Rs. 78.90 per warrant - being 75% of the balance warrant issue price of Rs 105.20 per warrant, which were allotted in terms of Shareholders' Special Resolution dated February 10, 2021 and pursuant to the Board Resolution dated April 09, 2021, in accordance with Chapter V (Preferential Issue) of SEBI (ICDR) Regulations, 2015, as amended.

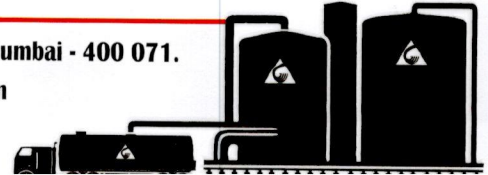

The Equity shares allotted as aforesaid shall rank pari passu with the existing Equity shares of the Company in all respects, including with respect to dividend and voting powers.
