Consequently, losses incurred due to additional cost of repair and maintenance of Plant &amp; machinery is shown as Exceptional Item and waste/rehabilitation cost of stock is reduced from closing stock value. Further, a corresponding insurance claim amounting to Rs. 2.93 crores is accounted as Other Income. The same is receivable from our company, however, the same is yet to be received.

4. The figures for the previous period has been regrouped/reclassified, wherever necessary, to conform to the current grouping/classification.
