कश्मीर में नहीं दिख रहा है सुधार

5 हजार अतिरिक्त अर्धसैनिक बलों की तैनाती

जम्मू। कश्मीर की स्थिति में सुधार होता नहीं दिख रहा है। हाल के दिनों में बढ़ती आतंकी घटनाओं के बाद इस केंद्र शासित प्रदेश में 5 हजार और अर्धसैनिक बलों की तैनाती की गई है। केंद्र ने हाल ही में प्रवासी श्रमिकों की हत्याओं के बाद कश्मीर में केंद्रीय अर्धसैनिक बलों के अतिरिक्त 5,000 जवानों की तैनाती का आदेश दिया है।



तेनात की जा रही है। 50 कंपनियों में से 30 को अकेले श्रीनगर में तेनात किया जा रहा है। जम्मू-कश्मीर में आतंकवाद रोधी अभियानों के लिए केंद्रीय रिजर्व पुलिस बल के लगभग 70,000 जवानों को पहले ही तेनात किया जा चुका है। हाल ही में, जम्मू-कश्मीर प्रशासन ने कर्मियों और उनके परिवारों के लिए स्थायी शिविर बनाने के लिए सीआरपीएफ को दक्षिण कश्मीर में आठ स्थानों पर जमीन आवंटित की है।

केंद्र सरकार बोली जम्मू कश्मीर को देंगे 18527 करोड़, अब तक दिए केवल 1809 करोड़, 12 विभागों को तो एक पैसा भी न मिला कश्मीर में पिछले दिनों हुई आतंकवादी हमलों में लगभग एक दर्जन नागरिक मारे गए हैं। इनमें से सात गैर-मुस्लिम थे। मरने वालों में पांच प्रवासी मजदूर भी थे। इसके अलावा एक प्रमुख कश्मीरी पंडित व्यापारी माखन लाल बिंदू का नाम भी मरने वालों में शामिल है। इनकी हत्या आतंकीयों ने टारगेट किलिंग के तहत की है। इन हत्याओं को अल्पसंख्यकों को घाटी से बाहर निकालने के लिए एक आतंकवादी साजिश के रूप में माना जा रहा है।

92 प्रतिशत से अधिक स्कूली शिक्षकों का हो चुका है टीकाकरण: धर्मद्र प्रधान

नई दिल्ली। केंद्रीय शिक्षा मंत्री धर्मद्र प्रधान ने मंगलवार को देश भर में शिक्षकों के टीकाकरण की स्थिति और स्कूलों को फिर से खोलने की समीक्षा की। उन्होंने रिक्लिंग इकोसिस्टम में टीकाकरण की स्थिति की भी समीक्षा की। प्रधान नियमित रूप से टीचिंग स्टाफ और नॉन टीचिंग स्टाफ के टीकाकरण की निगरानी कर रहे हैं ताकि स्कूलों को फिर से खोलने की दिशा में आगे बढ़ने के लिए एक सक्षम वातावरण सुनिश्चित किया जा सके।

उन्होंने देश में बड़े पैमाने पर हो रहे तेजी से टीकाकरण के मद्देनजर शैक्षणिक संस्थानों में सामान्य स्थिति और जीवंतता बहाल करने की आवश्यकता पर जोर दिया। आज तक, अधिकांश राज्यों ने सभी कक्षाओं के लिए स्कूल खोल दिए हैं। 92 प्रतिशत से अधिक शिक्षण कर्मचारियों को टीका लगाया गया है। केंद्र सरकार के अंतर्गत आने वाले संस्थानों में 96 प्रतिशत से अधिक टीचिंग स्टाफ का टीकाकरण किया जा चुका है।

भाजपा के विरुद्ध हो रहे हैं लोग: कांग्रेस

नई दिल्ली। कांग्रेस का दावा है कि जनता भाजपा के विरुद्ध हो चुकी है। पार्टी के वरिष्ठ नेता राजीव शुक्ला ने मंगलवार को कांग्रेस मुख्यालय में आयोजित एक प्रेस वार्ता को संबोधित करते हुए कहा कि देश भर में सम्पन्न हुए उपचुनावों के परिणाम अधिकतर भाजपा के विरुद्ध रहे हैं। उन्होंने कहा कि हिमाचल प्रदेश के उपचुनाव में कांग्रेस ने पूर्ण जीत हासिल की है। राजस्थान और कर्नाटक में भी मतदाताओं ने कांग्रेस को जीत दिलाई है। शुक्ला ने कहा कि यह समय है जब विपक्षी दलों को एक साथ मिलकर जनता के साथ खड़ा होना चाहिए। उन्होंने कहा कि देश में बढ़ रही महंगाई को रोकने में भाजपा पूरी तरह विफल रही है। यही कारण है कि आम जनता के जेब से सरकार जबरन पैसे निकाल रही है। डीजल-पेट्रोल के दाम आसमान छू रहे हैं। इसीलिए हर चीज महंगी होती जा रही है।

उपचुनाव के नतीजे भाजपा के लिए चेतवनी: किसान मोर्चा



नई दिल्ली। एजेंसियां/डेस्क संयुक्त किसान मोर्चा (एसकेएम) ने कहा कि देश भर में सम्पन्न हुए उपचुनाव में भारतीय जनता पार्टी (भाजपा) को काफी नुकसान हुआ है। खासकर हरियाणा और हिमाचल प्रदेश के चुनाव परिणाम भाजपा के लिए एक चेतवनी है।

मोर्चा ने मंगलवार को एक बयान जारी कर कहा कि अगर सरकार नीतियों को नागरिकों के हितों के अनुरूप नहीं बनाती है तो उन्हें परिणाम भुगतने पड़ेंगे। आज 3 सीटों पर हुए संसदीय उपचुनाव में भाजपा को 3 में से सिर्फ एक सीट मिली। 14 राज्यों की 30 विधानसभा सीटों पर हुए

विधानसभा उपचुनाव में विशेषकर हरियाणा, हिमाचल प्रदेश और राजस्थान में, जहां-जहां किसान आंदोलन ने अपनी ताकत लगाकर मतदाताओं से किसान विरोधी नीतियों के लिए भाजपा को दंडित करने का आग्रह किया था वह परिणाम भाजपा के खिलाफ गए हैं।

उल्लेखनीय है कि तीनों कृषि कानूनों के विरोध में आंदोलन कर रहे किसान संगठनों का दावा है कि किसानों की नाराजगी भाजपा को भारी पड़ रही है। अगर केंद्र सरकार तीनों कृषि कानूनों को वापस नहीं लेगी तो आने वाले चुनावों में भी भाजपा को हार का सामना करना पड़ेगा।
