## Sardar Patel was deprived of Bharat Ratna for long, efforts made to erase his legacy, says Amit Shah

NEW DELHI, OCTOBER 29

UNION HOME Minister Amit Shah said on Tuesday that efforts were made to erase and undermine Sardar Vallabhbhai Patel's legacy and he was deprived of Bharat Ratna for a long time.

Flagging off a 'Run for Unity', ahead of the birth anniversary of Patel, he said it was due to the foresightedness and acumen of the country's first home minister that over 550 princely states were merged with the Union of India and the country became united.

He said it was because of Sardar Patel that the Lakshadweep Islands, Junagarh, Hyderabad and all other princely states were merged with India. "But there were efforts to erase and undermine the legacy of Sardar Patel. He was also deprived of Bharat Ratna for a long time," Shah said while addressing the participants at the Major Dhyan Chand National Stadium here.

However, Prime Minister Narendra Modi (when he was the chief minister of Gujarat) had

installed the tallest statue of Patel in Kevadia and honoured him in a befitting manner, he said.

Sardar Patel was bestowed with Bharat Ratna -- the country's highest civilian award -- posthumously in 1991, 41 years after his death in 1950.

Shah said the people of the country are now united and have dedicated themselves to fulfilling the prime minister's dream of turning India into a fully developed nation by 2047.

"By 2047, India will be the leading country in the world in all parameters," he said.

## 7-year-old boy mauled to death by leopard in Surat

A SEVEN-year-old boy was allegedly mauled to death by a leopard in Surat district Monday night, said forest department officials, adding that the animal was caught on Tuesday morning.

The victim, identified as Ajay Valvi, was playing outside when he was attacked by the big cat, said the officials.

According to the information shared by the Surat district forest

department officials, for the last few days, a group of farm labourers from Maharashtra's Nandurbar district had been working in agricultural fields in Ushker village of Mandvi taluka. The officials said that the labourers used to stay in the temporary tents put up in the same fields after work. One of the labourers, Sangita -- also the victim's mother -- was also staying with the group. On Monday night, the boy was playing outside while his mother was taking a nap in the tent. ## SARDAR PATEL'S BIRTH ANNIVERSARY

# PM Modi set to launch projects worth Rs 280 cr

PRIME MINISTER Narendra Modi will be in Gujarat on Wednesday for a two-day visit to take part in the Rashtriya Ekta Diwas celebrations on the 149th birth anniversary of Sardar Vallabhbhai Patel.

He will also inaugurate and lay the foundation stone of various development projects worth over Rs 280 crore.

Modi will arrive in Vadodara on Wednesday evening and head to Ekta Nagar (formerly Kevadia) in Narmada district. The Prime Minister will also inaugurate Deepotsav on the banks of Narmada river in Gora village, across the Statue of Unity (SoU).

Modi is set to inaugurate and lay the foundation stone of multiple infrastructural and development projects, including a 1.5 kilometre walkway from the parking area to the SoU, a trauma centre in Kevadia for emergencies.

He will also lay the foundation stone of the much-delayed Museum of Royal Kingdoms, which is expected to showcase the history of 562 princely states that signed the treaty of accession

with the Union of India at the time of the Partition. The museum, slated to come up near Kevadia is estimated to be built at the cost of Rs 260 crore.

On Wednesday evening, Modi will also address the sixth edition of Aarambh -- the conclave of Officer Trainees of the 99th Common Foundation Course. The theme for this year's programme is "Roadmap for Atma Nirbhar and Viksit Bharat." The 99th Common Foundation Course includes 653 Officer Trainees from 16 civil services of India and three civil services of Bhutan.

The Prime Minister will stay over at the Circuit House in Kevadia and attend the Rashtriya Ekta Diwas celebrations on October 31 after paying floral tributes to Sardar Patel. In order to spruce up the circuit house for the PM's stay, Narmada District administration has roped in Padmashri Paresh Rathwa, a

tribal Pithora artist. An official said, "Pareshbhai has been making Pithora paintings for the last three decades and PM Modi has deep interest in this tribal art, so we decided to get a fresh art work done in the circuit house complex," an official told *The Indian Express*.

At the Ekta Diwas event, Modi will also administer the Ekta Diwas pledge and witness Ekta Diwas Parade comprising 16 marching contingents from nine states and one Union Territory police, four Central Armed Police Forces, National Cadet Corps and a marching band. Special attractions include 'Hell March' contingent of National Security Guard, daredevil show by Border Security Force and Central Reserve Police Force women and men bikers, a show on combination of Indian martial arts by BSF, piped band show by children and 'Surya Kiran' flypast by Indian Air Force, among others.

The area under the Statue of Unity Area Development and Tourism Governance Authority (SOUADTGA) has been declared a "no fly zone" in view of the security protocol for the Prime Minister.

## Ahmedabad-Keshod direct flight services launched for pilgrims visiting Somnath Temple

A DIRECT flight service between Ahmedabad to Keshod in Junagadh district was launched on Tuesday for pilgrims visiting the famous Somnath Temple in Gujarat, an official said.

Shree Somnath Trust, which manages the temple, has also started a free pickup bus service from Keshod airport to the temple for the pilgrims and devotees landing at the airport, Gujarat Pavitra Yatradham Vikas Board, a state government entity, stated in a release.

Keshod is nearly 55 km from the Somnath temple in Prabhas Patan town of neighbouring Gir Somnath district, nearly 400 km from Ahmedabad. Prime Minister Narendra Modi is the chairman of the Shree Somnath Trust.

According to the release, the Ahmedabad-Keshod direct flight service will operate three days a week, on Tuesday, Thursday and Saturday.

The flight will take off from Ahmedabad at 10.10 am and reach Keshod at 10.55 am. The same flight will again leave Keshod at 1.15 pm and return to Ahmedabad at 2.30 pm, the release said.
