We wish to provide the following information on a consolidated basis for the quarter ended December 31, 2023:

1. The consolidated AUM of the Company crossed the milestone of ₹ 10,000 Crore during the quarter and stood at approximately ₹ 10,225 Crore as on December 31, 2023, registering a strong growth of 27% YoY.
2. The Company continues to have adequate liquidity of approximately ₹ 800 Crore as on December 31, 2023.
3. In consonance with our policy of rewarding the shareholders the board has declared an Interim Dividend of 30.00 % @ ₹ 3.00 per share.
