BORROWERS FEEL THE PINCH

HDFC raises home loan rates by 30 bps

MORTGAGE LENDER HDFC Ltd on Saturday announced an increase in its benchmark lending rate by 30 basis points (bps), a move that will make loans dearer for both existing and new borrowers.

The move comes just days after several lenders, including ICICI Bank, Bank of Baroda and Bank of India, raised interest rates following the Reserve Bank of India's surprise repo rate hike on Wednesday.

"HDFC increases its Retail Prime Lending Rate (RPLR) on housing loans, on which its Adjustable Rate Home Loans (ARHL) are benchmarked, by 30 basis points, with effect from May 9, 2022," the housing finance company said.

The revised rates for new borrowers range between 7% and 7.45%, depending on credit and loan amount. The existing range is 6.70% to 7.15%. For existing customers, the rates would rise by 30 basis points or (0.3%).

Earlier this month, HDFC had increased its benchmark lending rate by 5 basis points making EMI for existing borrowers expensive. HDFC follows a three-month cycle for repricing its loans to existing customers. So, the loans will be revised in sync with increased lending rate based on the date of the first disbursement.

Govt aims to set up vehicle scrapping facilities within 150 km from city centres

UNION MINISTER NITIN Gadkari on Saturday said his aim is to develop at least one automobile scrapping facility within 150 kilometres from each city centre, while asserting that the country has the potential to become a vehicle scrapping hub of the entire South Asian region.

Addressing an event here, Gadkari said the National Vehicle Scrapping Policy is a key initiative in the Indian transport and sustainability sector, and this will enable the removal of older and unfit vehicles and introduction of new lesser-polluting vehicles in a phased manner. "My aim is to develop a vehicle scrapping centre within the reach of 150 km from all the city centres," the road transport and highways minister said. Gadkari noted that the road transport and highways ministry has designed the vehicle scrapping policy in a way that allows all types and sizes of investors to come and establish scrapping centres. "Developing a large number of vehicle scrapping centres, we can also develop



multiple authorised collection centres of vehicle scrapping units in one city, which will have the authority to deregister a vehicle and issue deposit certificates," he said.

Prime Minister Narendra Modi had launched the National Vehicle Scrapping Policy in August last year and had said it will help phase out unfit and polluting vehicles and also promote a circular economy. He had also said that the material recycling sector gives direct and indirect employment to 40 million people and this number is expected to go up to 50 million by 2025. Gadkari said: "India has potential to become a vehicle scrapping hub of the entire South Asian region."

India plans to reassess broadcast pricing as media competition heats up

INDIA IS PROPOSING changes including on how cable TV fees are calculated, following concerns that free services from the state broadcaster and rising popularity of over-the-top platforms is eroding viewership.

Direct-to-home active subscribers fell to 68.52 million in December from 70.99 million in March 2020. Industry representatives say implementation

of a new tariff order "will cause large scale disruptions," the Telecom Regulatory Authority of India said in a consultation paper posted on its website Saturday. The media and entertainment sector in India has become a hot-bed of competition in recent months. Global giants like Netflix and Amazon are battling Indian tycoons Gautam Adani and Mukesh Ambani in the only market which offers more than a billion customers. —BLOOMBERG

NGT imposes ₹41.21-crore fine on Singareni Collieries in Telangana

THE NATIONAL GREEN Tribunal has imposed a compensation of ₹41.21 crore on state-run Singareni Collieries Company in Telangana for violation of environmental clearance conditions and mining excess coal.

A bench of justices K Ramakrishnan and expert member Dr Satyagopal Korlapati directed the mining department to calculate the penalty payable for the excess mining, in view of directions issued by the Supreme Court.

"Singareni Collieries Company Limited (SCCL) is directed to pay a compensation of ₹41.21 crores... within a period of three months with the Telangana State Pollution Control Board, and if the amount is not paid within that time, the state pollution control board is directed to take steps to recover the amount from them by requesting the district collector to initiate revenue recovery proceedings," the bench said.

The green panel directed the Telangana State Pollution Control Board to identify people whose houses have been damaged, as observed by joint committee, partially due to vibrations caused on account of blasting during the initial stages. whose houses have been damaged, as observed by joint committee, partially due to vibrations caused on account of blasting during the initial stages. "The environment compensation amount will have to be utilised for the purpose of preparing a welfare scheme for protecting the welfare and interest of the people who are residing in and around the coal mining area who are likely to be affected by the project activities, and also a portion of the compensation will have to be utilised for meeting the welfare of the tribal settlement, if any, situated in Khammam district or nearby districts. Mode of welfare

scheme, etc., will have to be evolved by the committee appointed by this tribunal for this purpose," the bench said.

The NGT said the preparation of the scheme must be in consultation with the chief secretary of Telangana and the special chief secretary of the department of environment, science and technology, and that will have to be jointly implemented by the state pollution control board and the district collector concerned. "SCCL is directed to provide necessary greenbelt and other pollution control mechanism to avoid air and dust pollution being caused. They are also directed not to discharge any trade effluents or liquid waste generated during the operation of their mine, and they are directed to strictly implement the ZLD within their unit.

"SCCL is also directed to expedite the laying of railway tracks and complete the same, and take steps to transport the coal using the railway line instead of roads as directed to be complied with within the timeline specified in the environmental clearance (EC) granted," the bench said.

ED arrests CA linked to Jharkhand IAS officer in money laundering case

THE ENFORCEMENT Directorate Saturday arrested a chartered accountant under the anti-money laundering law in a case linked to alleged embezzlement of MGNREGA funds in Jharkhand's Khunti district as part of which state mining secretary and IAS officer Pooja Singhal and others were raided,



officials said. CA Suman Kumar was taken into custody under the Prevention of Money Laundering Act (PMLA) around 5 pm in Ranchi and he would be produced before a local court where the Enforcement Directorate (ED) would seek his further custody, they said. Officials alleged that the CA was "evasive in his replies" with regard to the alleged recovery of cash to

the tune of ₹17.79 crore from his premises in Ranchi after the agency conducted raids in this case.

The ED has alleged that Kumar, also a financial advisor, has links with IAS officer Pooja Singhal and her family.

The federal agency seized a total of ₹19.31 crore in cash after these raids and it also recorded the preliminary statement of Singhal during the searches.

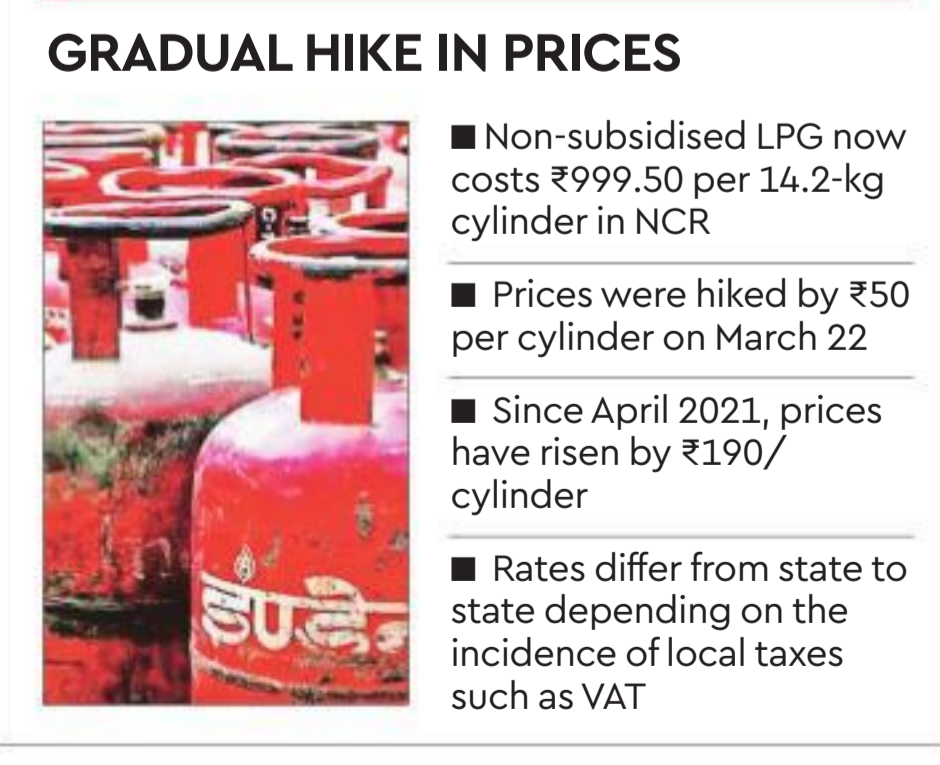
LPG prices hiked by ₹50 per cylinder

COOKING GAS LPG prices were on Saturday hiked by ₹50 per cylinder, the second increase in rates in just over six weeks following the firming of international energy rates.

Non-subsidised LPG now costs ₹999.50 per 14.2-kg cylinder in the national capital, up from ₹949.50 previously, according to a price notification of state-owned fuel retailers. This is the second increase in LPG rates in just over six weeks. Prices were hiked by ₹50 per cylinder on March 22. Since April 2021, prices have risen by ₹190 per cylinder.

Petrol and diesel prices however continue to be on freeze for over a month now. The pause followed rates being hiked by a record ₹10 per litre in a matter of 16 days beginning March 22.

who got free connection under the much-touted Ujjwala scheme, is the same as non-subsidised or market price LPG.

Non-subsidised LPG costs ₹999.50 per 14.2-kg cylinder in Mumbai while it is priced at ₹1,015.50 a bottle in Chennai and ₹1,026 in Kolkata.

Rates differ from state to state depending on the incidence of local taxes such as VAT. Prices are higher in states with higher taxes.

Earlier this month, the price of commercial LPG cylinders — the one used by establishments like hotels and restaurants — was increased. On May 1, the price of a 19-kg commercial LPG cylinder was increased by ₹102.50 to ₹2,355.50.

International oil prices have been on the rise this year. They jumped to a 13-year high of \$140 per barrel in March before shedding some of the gains. Brent was trading at \$109.77 per barrel on Saturday.

To compound things, the Indian rupee tumbled to a near ₹77 to a dollar.

India relies on overseas purchases to meet about 85% of its oil requirement, making it one of the most vulnerable in Asia to higher oil prices.
