**Subject : Mandatory furnishing of PAN, KYC details and Nomination by holders of Physical Securities**

Pursuant to Securities and Exchange Board of India circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated 16th March, 2023, as amended, it shall be mandatory for all holders of physical securities to furnish PAN, Nomination, Address, Mobile Number, Bank Account Details and Specimen Signature. As per the above SEBI circular, the folio wherein any one of the above details are not available on or before 1st October, 2023, the said folios shall be frozen.

Company shares are in demat mode and ISIN is : INE794W01014.

Investor shall submit PAN and other KYC details and use Form ISR-1, which is made available on the website of Company/RTA.

In case of mismatch of signature or no signature with RTA the investor shall furnish original cancelled cheque and banker's attestation of the signature as per form ISR-2. We request that you should send Form ISR-2 duly attested by bank, since your signature with the record of RTA is very old and may differ with present signature.

Investors shall mandatorily register nomination with RTA and use form SH-13 and SH-14 for declaration of nomination and change in nomination respectively. However, in case investor wants to opt-out of nomination form ISR-3 shall be filed.
