- c) to convene the Meeting of Unsecured Creditors of only Renewable Power Undertaking of the Company on Thursday, July 18, 2024 at 03:00 pm through physical mode at Registered office of the Company at "Samanvay", 600, Tapovan, Ambawadi, Ahmedabad – 380 015 in the state of Gujarat for the purpose of considering and approving the proposed Scheme, with or without modification(s).
