CM Uddhav Thackeray has full support of Congress, NCP: Sharad Pawar says situation improving in Mumbai

CP chief Sharad Pawar has said Maharashtra CM Uddhav Thackeray is fully backed by the Congress and the NCP in the state's battle against coronavirus, while adding that the situation has started showing signs of improvement in Mumbai.

The NCP chief said the Shiv Sena, the NCP and the Congress are working together against corona and there is not an iota of difference. "All three parties are working under the leadership of Uddhav Thackeray. Congress and NCP fully support his leadership and action," Sharad Pawar said.

Sharad Pawar added that he had suggested that areas outside Pune, Mumbai and Thane



should be reopened, which he said was backed by Uddhav Thackeray since he adopted a similar strategy. On allegations of virtually running the Maharashtra government, Sharad Pawar said, "I am not remote controlling the [Maharashtra] government. It is fully controlled by Uddhav Thackeray. I am not in the decision making process, but I contribute in other areas like the cyclone relief recently."

MP Congress MLA booked for making objectionable remarks against woman union minister

Vidisha: Congress MLA from Vidisha, Shashank Bhargava, has been booked on a complaint filed by the municipality chairperson and some BJP workers for allegedly making objectionable remarks against a woman union minister.

In a cycle rally called by Congress, Bhargava had earlier said, "There is a minister in the central government who wears a lot of bangles. I want to appeal through media that since she is very close to Prime Minister Narendra Modi, she can give her bangles to him and request him to roll back the hike in fuel prices."

Following Bhargava's highly objectionable comment, BJP leader and Vidisha municipality Chairman Mukesh Tandon along with other party workers registered an FIR against the Congress leader in the Vidisha Kowali police station.

New Delhi: Prime Minister Narendra Modi is set to launch 'Atma Nirbhar Uttar Pradesh Rojgar Abhiyan' on Friday (June 26) through video conferencing in the presence of Chief Minister Yogi Adityanath.

The initiative is intensely focused on providing employment, promote local entrepreneurship and create partnerships with industrial associations and other organisations to provide employment opportunities.

The scheme will include at least 31 districts of Uttar Pradesh, which are Prayagraj, Varanasi, Rae Bareilly, Ayodhya, Deoria, Amethi, Ghazipur, Siddharthnagar, Gonda, Maharajganj, Bahraich, Balrampur, Jaunpur,

Hardoi, Azamgarh, Basti, Gonda, Gorakhpur, Sultanpur, Kashi, Sant Kabir Nagar, Banda, Ambedkar Nagar, Sitapur, Pratapgarh, Lucknow, Ghazipur, Meerut, Ghazipur, Mirzapur, Jalaun and Kushinbhi. In Uttar Pradesh, nearly 30 lakh migrant workers have returned. Thirty-one districts of Uttar Pradesh have more than 25,000 returned migrant workers. These include five aspirational districts. India-China border dispute: When Atal Bihari Vajpayee drove 800 sheep to Chinese embassy was by fighting militants from Pakistan in Kashmir just three years ago. India had offered a humiliating deal to Pak. China was again threatening to 'load' another 952-like lesson to India. However, as it turned out in the end, China misinterpreted India's prepared this time around. China wrote a letter to the Indian government accusing Indian soldiers of stealing 800 sheep from the border. The Indian government abruptly withdrew back along the hazardous charge but the response that Vajpayee, then a 42-year-old Raj Singh leader, gave left China flustered. Vajpayee arranged for a herd of around 800 sheep and drove them to the Chinese embassy in New Delhi in late September. The sheep had placards that said, "Enter by force, leave by force."
