**Step 2:** Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.

- (i) The voting period begins on September 27, 2024 at 9.00 A.M. and ends on September 29, 2024 at 05.00 P.M. During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of September 23, 2024, may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process

## Financial Summary

The loss after tax for the year was Rs.1283.89 crores against Rs.900.09 crore for the previous year. The loss before exceptional items for the period increased by Rs 160.49Cr. The loss before impairment loss for the period increased by Rs 201.62 Crs mainly due to accounting of Rs. 231.32 Crs revision in energy norms from Oct 2020 to March 2023 in the previous year which is not there in the current year.

## Share Capital

The Paid-up Equity Capital of the Company as on March 31, 2024, is Rs.59,80,65,003/- consisting of 59,80,65,003 Equity Shares of Re.1/- each.

## Transfer to Reserves

There has been no transfer to General Reserves during the Financial Year 2023-2024 in view of losses incurred by the Company.

## Dividend

The Board of Directors of your company, after considering the operational performance and keeping in view the company's dividend distribution policy, has decided not to recommend any Dividend for the year under review.

## COMPANY' SAFFAIRS

### Plant Operations

#### Urea

Your Company during the financial year 2023-24 manufactured 13.102 LMT of urea as against 11.205 LMT in the previous year.

The production for the year 2023-24 is less compared to the usual level, owing to low load operation of the plants due to equipment limitations.

#### Micro-Irrigation

Micro Irrigation Division had achieved a production of 92.4 Lakhs Meters in FY 2023-24 against 109.59 Lakh Meters during the previous year out of which PVC pipes production of 1.75 Lakh Meters in FY 2023-24 against 3.71 Lakhs Meters during the previous year.

#### Marketing

##### Urea

Your Company achieved a sale of manufactured urea of 11.20 LMT compared to 9.18 LMT in the previous year.

The total urea sales for both manufactured and imported urea was 11.20 LMT compared to 9.18 LMT of previous year.

## Other Traded Products

### Traded Bulk Products

Your Company could not sell any of the Traded Bulk Products during the year. In the previous year also, there was no sale of Traded Bulk Products.

### Specialty Fertilizers

Your Company could sell 40.98 Mt of the Specialty Fertilizers during the year. In the previous year, there was no sale of Specialty Fertilizers.

### Micro-nutrients

Your Company could not sell any of the Micro-nutrients during the year. In the previous year also, there was no sale of Micro-nutrients.

## Supplements and OSR

Your Company could not sell any of the Supplements & OSR during the year. In the previous year also, there was no sale of Supplements & OSR.

## Customized Fertilizers

Your Company could not sell any of the Customized Fertilizers during the year in comparison with sales of 99 MT during the previous year.

## Nagarjuna Brand

The Company has been using Nagarjuna Brand/ Trademarks under a License Agreement dated January 29, 1998. The Company had defaulted in payment of royalty dues under the said License Agreement. The Grantor had sent a notice for cancellation of the Royalty Agreement as the Company has outstanding Royal payments. The grantor had also claimed dues with RP appointed by court in 2021 when the company was admitted to NCLT. However, upon stay from NCLAT, and Agreement on settlement of outstanding dues, the Grantor had allowed continuance of the Brand usage up to end of December, 2022.

Consequent to expiry of brand license, the Company is required to change the name of the Company.

## Environment and Safety

### Environment

Your Company continues its mission of protecting the environment and has inculcated the concept right down the organization. The statutory compliance on environmental matters is being complied from time to time.

### Health & Safety

By following the best practices and with adoption of international standards and procedures, Plant Operations continued. Your Company as on March 31, 2024, completed 1,03,01,232 accident free man-hours by employees and contractors of the Company.

Further to strengthen the procedures and practices, MAH inspection at Ammonia Storage Tanks and Cooling Towers Area, Safe Work Practices Audit, PPE Audit etc., were conducted. Refresher Training has been given to Rescue Squad and basic Fire Fighting techniques to Associates.

### Change in the nature of business

During the year, there was no change in the nature of business of the company.

### Material changes and commitments

The material changes and commitments affecting the financial position of the Company which have occurred as at and post March 31, 2024, has been elaborated in the following under Debt Resolution Proposal and SARFAESI Process by Assets Care and Reconstruction Enterprise Limited (ACRE), the Secured Creditor.

### Claims Against GAIL

After the GAIL pipeline accident in 2014, NFCL had initiated an Arbitration proceeding against GAIL with a claim that there was no force majeure event and that GAIL was liable for the financial losses suffered by the company on account of stoppage of natural gas supplies from 27.6.2014 basis miss representations and gross negligence by GAIL.



The company had unfortunately lost the arbitration case with GAIL on 13.3.2023 wherein the arbitrator concluded that that stoppage of gas was due to a force majeure event as represented by GAIL.

**Debt Resolution Proposal viz. sale of Ammonia/Urea and MI businesses with related assets and liabilities.**

NFCL a growing and profitable company in 2014 went into financial stress due to a GAIL pipeline accident\*. Subsequently the lenders and subsequently board and shareholders (as per section 180 of the Companies Act, 2013) approved rectification of account as a corrective action plan with funding to revive the company. The company could not be revived due to various factors including inadequate funding approved for rectification of account resulting in the lenders declaring default in 2018. The company had filed various cases since 2018 against lenders for not implementing CAP with funding (there is no order yet supporting the claims of the company). Various and significant efforts to revive the company since 2018 failed to yield any results. The company via press came to know that the erstwhile lenders of the company exited their debt through assignment of debt.

\*The Company initiated arbitration on GAIL claim losses incurred on account of GAIL pipeline accident which was dismissed by the arbitrator stating that it's a force majeure.

The Company received a mail correspondence along with a letter of intimation dated March 31, 2023 from M/s Assets Care & Reconstruction Enterprise Ltd (ACRE)(as a Trustee of ACRE-112-Trust)that all the consortium lenders have assigned to it, vide Assignment Agreement dated March 29, 2023, entire fund based outstanding loans/financial assets along with all its rights, titles, interest, underlying securities and guarantees thereof under the relevant Financing Documents under section 5 of the SARFAESI Act, 2002.

**SARFAESI Process by Assets Care and Reconstruction Enterprise Limited (ACRE), the Secured Creditor**

Consequently, ACRE, served notice under SARFAESI Act, on May 20, 2023, and the company, without prejudice to the debt disputes, replied to the SARFAESI notice on July 17, 2023. ACRE while disputing Company's claim had sought for a debt resolution vide letter dated July 25, 2023. ACRE while disputing the companies claims had sought debt resolution proposal from the company.

The company after failing to identify investors for the company for providing funding for debt repayment/settlement and funding for CAPEX and working capital to turn around the company, worked to identify strategic investors for core assets/business and non-core assets to fund OTS to repay lenders. As per section 180 if the company wants to voluntarily sell assets (without prejudice to the rights of the lenders), transfer, lease and / or otherwise dispose of any assets of the company exceeding 20% of its net worth or assets generating more than 20% income require members approval.

Consequently, the Board of Directors at their meeting held on August 14, 2023, and the Members at their 17th Annual General Meeting held on September 15, 2023, took note of ACRE's notice under the SARFAESI Act and approved:

- a) The sale of Ammonia/Urea and MI businesses with related assets and liabilities to M/s. AM Green Ammonia (India) Private Limited (purchaser company) via slump sale sub-

ject to certain Condition Precedents (CPs) and sale/lease/transfer dispose Non Core Assets.

- b) One Time Settlement (OTS) as debt resolution with Asset Care and Reconstruction Enterprise Limited (ACRE) for an amount not exceeding Rs 1500 Crores as full and final settlement towards of their total debts in Nagarjuna Fertilizers and Chemicals Limited.

The sale and settlement proposal is subject to approval of lenders and any other approvals and clearances required for the transaction.

Further, the company had enumerated various risks for fulfillment of the above approvals including initiation of SARFAESI process by lenders, delays in CP fulfillment for slump sale which included energy claim approval and disbursement, lender not agreeing for settling for lower amount than what's due while taking the approval from Board and Members/Shareholders for OTS and funding for OTS (Slump Sale and Sale of Non Core Assets).

ACRE, while engaging with the company for OTS, was continuing to pursue the SARFAESI process, consequent to serving notice under SARFAESI Act, on May 20, 2023., has subsequently taken symbolic possession of the scheduled assets of the Company in its favor on October 12, 2023.

Consequent to the approval of the Members/Shareholders for OTS and funding for OTS (Slump Sale and Sale of Non Core Assets), the company on October 24, 2023, has formally applied to ACRE without prejudice accepting the debt and sought permission to allow the company (1) sell the core business via slump sale of Urea and MI businesses (2) to sell the non-core assets as in line with and for the amount approved by Acre and (3) provide a One Time Settlement for an amount of Rs. 1500 crores as full and final settlement towards of their total debt in NFCL.

Basis the proposal of the company for One Time Settlement as a debt resolution, ACRE communicated to the company on October 31, 2023, that Settlement Amount proposed to be paid by the Company is based on an offer to sell the 'Urea' and 'Micro Irrigation Business' on a slump-sale basis which is subjective on several conditions' precedents required to be fulfilled by NFCL before effectuating the sale and that as the conditions precedents have either not been fulfilled as on that date by NFCL or are contingent on various other events that the Settlement Proposal submitted to ACRE therefore is tentative and not binding and therefore was unable to consider and/or appraise the Settlement Proposal extended by the company at that point in time and hence it will proceed with SARFAESI process initiated by it.

In relation to the CPs the most important CP is the energy claim reimbursement. The Company, based on the developments on the claim with Government (DOF), stated that it was optimistic and will continue to work to fulfill the Conditions Precedents (CPs) for Slump Sale Transaction, Sell Non Core Assets and raise funds for One Time Settlement (OTS). That company was optimistic and was working / pursuing on fulfilling the Conditions Precedents (CPs) for the closure of Slump Sale Transaction with M/s. AM Green Ammonia (India) Private Limited, Sell non core assets and to get ACRE to agree to One Time Settlement (OTS) for Rs 1500 Crs as debt resolution instead of Rs 3500 Crs plus being claimed by ACRE.

Notwithstanding despite efforts to speed up the energy claims the company could not succeed and the lenders continued with the SARFAESI process.

In view of the above, while asking the company to continue and speed up closure of CPs for the approved Slump Sale transaction, the Board of Directors on December 24, 2023, without prejudice, considered and approved the company's initiative to engage and work with ACRE on a One Time Settlement under SARFAESI/directly (or a combination of both) if any in parallel to the current efforts on the Slump Sale transaction to amicably settle debt.

The company had as part of CAP funding obtained the board and shareholders approval as per section 180 for obtaining loans and mortgage of assets. The company is obligated to service and repay debt once availed. Once the current and fixed assets are mortgaged to lenders the company does not have rights over assets if the company is unable to service and repay debt (and is in default) and the lenders require no approval of the company, its board or shareholders to recover their dues under the provisions of law if there is an event of default.

While Board or Member's approval was required to repay the debt as a matter of good governance the company obtained the approval for and the amount approved by the board for negotiations/debt settlement with ACRE is the amount equal to or lower than the amount realized from sale of core and non-core assets and lower than the amounts due to ACRE.

Accordingly, the company engaged with and agreed to cooperate with ACRE vide OTS Cooperation Agreement (Letter dated January 12, 2024) OTS amount is the amount realized from the sale of assets (Core assets Rs.1350/- Crs and Non-core assets Rs.200/- Crs), as sought by ACRE, without prejudice to the rights of the company and guarantors for a One Time Settlement (OTS) under SARFAESI/directly. The final OTS amount was yet to be determined and will be communicated by ACRE to the company as the sale process was yet to be completed.

Subsequently, ACRE, as part of the SARFAESI process after taking symbolic possession of assets, has issued a Public Notice for physical auction for sale of Movable and Immovable properties of the Company under SARFAESI Act, 2002, vide email to the company dated January 17, 2024.

Simultaneously, JLL was appointed for sale of non-core assets. As per the mandate of ACRE, JLL shortlisted the buyers for non-core assets and advances were deposited in to fixed deposits lien marked in favor of ACRE, as sought by ACRE.

Consequent to the issue of Public Notice for physical auction for sale of Movable and Immovable properties of the Company under SARFAESI Act, 2002, the Company has received email communication dated April 17, 2024, from ACRE that it has received an offer from a bidder above the reserve price and the bidder has submitted an upfront amount of 25% of the purchase consideration, in line with the terms of the sale and asked the company to deposit the proceeds/advances received from the sale of non-core assets as mandated by ACRE into fixed deposits lien marked in favor of ACRE.

While things stood thus, ACRE vide email dated May 31, 2024, has communicated to the Company that the bidder, AM Green Ammonia (India) Private Limited, has made payment of balance 75% of the total bid amount of INR.1685 Crores and in

terms of the provisions of SARFAESI Act read along with the Rules, ACRE has issued sale certificates in favor of the bidder AM Green Ammonia (India) Private Limited ("Bidder/Buyer") for all the secured assets forming part of the sale notice. The buyer has now become the legal and rightful owner of the assets listed and requested to provide assistance in handing over the physical possession of the secured assets sold to the buyer.

The company basis the approval of the Board of Directors on May 31, 2024 handed over the physical, vacant, quiet and peaceful possession of the Listed Secured Assets of the Company to AM Green Ammonia (India) Private Limited ("Bidder/Buyer")

ACRE, consequent to the sale of core assets wrote to the company for payment of the remaining amount due to its account from the sale of non-core assets. After obtaining NOC from ACRE, the company sought the payment of the remaining amount from the buyers of the non-core assets in the name of the ACRE. The buyers paid a total of Rs.221/- Crs from the sale of non-core assets to ACRE.

ACRE, consequent to recovery from sale of core assets (Urea and MI facilities), non-core assets (all assets other than Urea and MI assets) amounting to Rs.1685 Crores and Rs. 200 crores respectively totaling to Rs. 1885 crores and cutback due till June 30, 2024, towards full and final settlement of debt outstanding of Rs. 3858 Crores claimed by ACRE as of 10th December 2023, has issued a No Due Certificate dated 11th July 2024, confirming that NFCL stands unconditionally and irrevocably released and discharged of any liabilities, dues, demands or claims in respect of the outstanding debt, other amounts due and payable to ACRE, including release of all security created in favor of ACRE, personal guarantees and pledge of shares of NFCL held by promoter (Amlika Mercantile Private Limited).

NFCL does not have any term loans and working capital debt outstanding and is also not in default with any secured lenders.

#### **Company's Exit from Corporate Insolvency Resolution Process (CIRP) under IBC, 2016:**

Hon'ble NCLT Hyderabad Bench, vide order dated August 27, 2021, has initiated Corporate Insolvency Resolution Process (CIRP) against the company Amlika Mercantile Private Limited, one of the Promoters of the Company appealed against the said order of Hon'ble NCLT in Hon'ble NCLAT, Chennai. The Hon'ble NCLAT has since stayed the orders of the Hon'ble NCLT, Hyderabad vide its orders dt.14.09.2021.

Hon'ble NCLAT, Chennai, vide order dated October 05, 2023, has allowed the appeal filed by Amlika Mercantile Private Limited, Core Promoter of Nagarjuna Fertilizers and Chemicals Limited by setting aside "the impugned order dated August 27, 2021, passed by Hon'ble NCLT, Hyderabad Bench admitting the company into Corporate Insolvency Resolution Process (CIRP) under Insolvency and Bankruptcy Code, 2016

Consequently, the Company has exited Corporate Insolvency Resolution Process (CIRP) under Insolvency and Bankruptcy Code, 2016, effective from October 05, 2023.

#### **Subsidiaries, Joint Ventures or Associate Companies**

During the year under review the company has only one subsidiary viz., Jaiprakash Engineering and Steel Company Limited (JESCO) (a company incorporated under Companies Act, 1956 bearing CIN U00337KA1993PLC014694 having its Regis-



tered Office at 510, 3RD A Cross, 2nd Main, 3rd Block Rajmahal Vilas-II, Dollars Colony, Bangalore-560094, Karnataka.

JESCO couldn't implement the approved projects due to delayed approvals from Karnataka Industrial Area Development Board (KIADB) / Government of Karnataka (GOK).

Further, GOK had issued GO taking back the land and allotted the JESCO land to Navy Coast Guard. The matter is pending in the Court of Law.

In view of the non-execution of sale deeds and legal complications the Board of Directors of your company, as a prudent measure, had written off entire investment in its subsidiary during the Financial Year 2019-20 and the Members of the Company had approved to sell, transfer, lease and/or otherwise dispose of the whole or substantially the whole of the investment in JESCO.

After issuance of GO by Govt of Karnataka (KIADB) cancelling the allocation of land and after prolonged litigation (due to lack of cash flows to support operations and financial creditors), JESCO (a subsidiary of NFCL) with loans went into Voluntary Liquidation under IBC with effect from April 25, 2022. As per IND AS accounting standards shares of JESCO (part of non current assets) were accordingly fully provided for. The liquidator after completing all formalities of voluntary liquidation proceedings had filed the petition for dissolution of JESCO on 01.10.2023 with NCLT, Bangalore.

Subsequently, the company has been informed by JESCO that the Liquidator of JESCO is of the opinion that the JESCO will not be able to pay its debts in full from the proceeds of assets to be sold in the liquidation and accordingly, the liquidator has filed a Memo for withdrawal from Voluntary Liquidation Proceedings and the same is dismissed By NCLT Bangalore as withdrawn vide order dated 16/04/2024.

The Financial Statements for the year ended March 31, 2024, were prepared on Liquidation basis - the values of the Assets are stated at Liquidation Value. Post the sale of non-core assets on June 12, 2024 (which includes JESCO shares) NFCL is no longer is a shareholder in JESCO.

The company has an Associate Company viz., K V K Raju International Leadership Limited (a company incorporated under Companies Act, 1956 bearing CIN U51100TG1995PLC022410 and having its registered office at Nagarjuna Hills, Punjagutta Hyderabad - 500082, Telangana).

There are no changes in the status of subsidiaries or associates' companies during the year under review. Further, there are no material fact that requires mention on the performance and financial position of the Associate Companies.

#### Accounts of Subsidiaries

Consolidated financial statements incorporating the accounts of the Subsidiary Company are enclosed along with the financial statements of the Company. Jaiprakash Engineering And Steel Company Limited (JESCO) is not a material subsidiary whose income or net worth in the immediately preceding accounting year does not exceeds 20% of the consolidated income or net worth respectively of the Company and its subsidiaries as per the thresholds laid down under the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (hereinafter referred to as "Listing Regulations").

Statement containing salient features of the financial statement of Subsidiary / Associate Company appears as Annexure I to this Report.

Except mentioned above regarding implementation of Voluntary Liquidation Process by JESCO, effective from 25th April, 2022, and appointment of Insolvency Professional, as the Liquidator of JESCO and exit from the Liquidation Process, there are no material fact that requires mention on the performance and financial position of the Jaiprakash Engineering and Steel Company Limited.

The Financial Statements of the Subsidiary and Associate are available for inspection by the Members at the Registered Office of the Company pursuant to the provisions of Section 136 of the Companies Act 2013. The Company shall provide free of cost, a copy of the financial statements of its subsidiary companies to the Members upon request. In terms of Regulation 17(1A) SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the appointment / continuation of the appointment of Mr. Sudhakar Kudva, after the attainment of 75 years is subject to the approval of the Members by way of Special Resolution

Accordingly, the Board of Directors, considering the experience and expertise and so as to utilize his services for the Company, have proposed to continue Mr. Sudhakar Kudva (DIN: 02410695), as an Independent Director of the Company, after attaining the age of 75 years still the completion of the term of Independent Directorship till June 16, 2028, in compliance with Regulation 17(1A) SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The proposed appointment is being placed before the members at the 18th AGM for their approval.

During the year under review there is no change in the Composition of Board of Directors except mentioned above

Mr. K Rahul Raju was re-appointed as the Managing Director of the Company for a period of three years effective from August 01, 2020 and the term of appointment concluded on July 31, 2023.

The Board of Directors at their meeting held on August 14, 2023, based on the commendation of the Nomination and Remuneration Committee, have approved the re-appointment of Mr. K Rahul Raju, as Managing Director, of the Company for a further period of 3 years with effect from August 01, 2023 and payment of remuneration subject to the prior approval of the Secured Creditors and the approval of the members of the Company

The Members at their 17th Annual General Meeting held on September 15, 2023 have approved the reappointment of Mr. K Rahul Raju, for a further period of 3 years with effect from August 01, 2023.

Mr. Uday Shankar Jha, subject to the appointment as a Non-Executive Director at the ensuing Annual General Meeting, will attain the age of 75 years on June 16, 2025, during the term of his Non-Executive Directorship.

In terms of Regulation 17(1A) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the appointment / continuation of the appointment of Mr. Uday Shankar Jha, after the attainment of 75 years is subject to the approval of the Members by way of Special Resolution.

The Board of Directors considering the vast experience and expertise and so as to utilize his services for the Company, have proposed to appoint Mr. Uday Shankar Jha as a Non-Executive Director of the Company and continue the appointment as a Non-Executive Director, after attaining the age of 75 years in compliance with Regulation 17(1A) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Board of Directors recommend the reappointment of Mr. Uday Shankar Jha and his continuation after attaining the age of 75 years and Mr. Chandrapal Singh Yadav, as directors liable to retire by rotation, for the consideration of the Members of the Company.

#### Declaration by Independent Directors

The Risk Management Organization Structure consists of Risk Management Steering Committee (RMSC) at apex level, and at divisional level, Corporate Risk Management Committee (CRMC) and Plant Risk Management Committee (PRMC) were formed to facilitate monitoring and governance of the ERM process on an ongoing basis.

Periodical meetings of the CRMC and PRMC are being held wherein the critical, cautionary and acceptable risks are presented by the departments through web-based RMS application. During such presentations, various cross-functional deliberations take place on the contributing factors and the control measures to mitigate the risks. The outcome of CRMC and PRMC deliberations and the analysis of risks are presented to RMSC on a quarterly basis.

### Policy on Board Evaluation

The Policy on Board Evaluation was adopted with effect from October 01, 2014, by the Board of Directors in compliance of Companies Act, 2013 and Listing Regulations.

### Basis for Qualified Opinion:

Notes No: 14 and 26 in the standalone financial statements wherein the company explained that the lenders (Banks) of the company have not implemented the Corrective Action Plan (CAP) approved by them in the Joint Lenders Forum (JLF) meeting held in 2015 and though the company represented the matter to the lenders for necessary corrective action, the same has not been rectified till date.

### Management Explanation to Auditors' Qualification

Qualification on Note No. 14 & 26 to the standalone audited financial statements discussed in detail on implementation of Corrective Action Plan is self-explanatory and does not call for any further comments.

### Emphasis of Matters:

- a) Note No 20.1: The Company has recognised Income from Urea Operations, Income towards freight subsidy, Reimbursement claims towards additional fixed cost, Input escalation/de-escalation during the quarter in terms of new Urea policy (NUP)-2015 and Gas Pooling Policy for Fertilizer (Urea) Sector. Adjustments, if any, required will be considered on notification of final prices.
- b) Note No 31: The Plant and Machinery, buildings attached there to have been put to test for impairment as of 31st March 2024 and management perceive that there is no further impairment loss required to be recorded  
Impairment test of property (land) was carried out as of 30th June 2023 during the year and recorded an impairment loss of Rs. 63,407.20 Lakhs as per the Registered Valuer's Report dated 12th August 2023. The management is of the opinion that there is no further impairment of land as at 31.03.2024.
- c) Note No 32.1: The claims as per the International Arbitration Awards passed against the Company in September 2016 and October 2017, aggregating to USD 15,275,688, GBP 742,944 and EUR 455,000 and INR 221.39 Lakhs (equivalent Aggregate amount of Rs. 14,150.09 Lakhs) and interest thereon as applicable apart from costs, are

continued to be shown as a contingent liability since the matter being sub-judice.

- d) Note No 32.2 Claim from a related party asserting its right for Royalty for the period from 29.01.1998 onwards, is being negotiated with the granter for settlement.
- e) Note No 32.4: Hon'ble NCLT admitted a petition filed by an operational creditor to initiate the CIRP against the Company under the provisions of the IBC 2016, Amlika Mercantile Private Ltd (One the of Promoter of the Company) appealed against the order of Hon'ble NCLT. The NCLAT has set aside the this CIRP proceedings under IBC and currently the Company is out of CIRP. AMPL has claimed the legal expenses for the NCLAT appeal filed on behalf of the Company and the Company is liable to reimburse the legal expenses to AMPL.

Further we report that, as on 31st March, 2024 the Board of the company consists of 6 Directors. Of the Directors, 3 are Independent Directors, 1 Nominee Director, 1 Non-Executive Director and 1 Executive Director (including a women director as prescribed regulations under Companies Act and SEBI Regulations).

The Company was required to appoint one Independent Director on the Board in terms of Regulation 17 of SEBI (LODR) Regulations, 2015. The Board of Directors on June 17, 2023, and Members at their Annual General Meeting held on September 15, 2023, have approved the appointment Mr. Sudhakar Kudva, as an Independent Director on the Board of the Company effective from June 17, 2023.

- ii. Adequate notice is given to all directors to schedule the Board Meetings, agenda and detailed notes on agenda were sent at least seven days in advance, and a system exists for seeking and obtaining further information and clarifications on the agenda items before the meeting and for meaningful participation at the meeting.
- iii. Majority decision is carried through while the dissenting members' views are captured and recorded as part of the minutes if any.
- iv. There were no prosecution initiated or no other fines or penalties were imposed during the year under review under SCRA, Depositories Act, and Rules, Regulations and Guidelines framed under these Acts against / on the Company, its Directors and Officers.
- v. The Directors have complied with the disclosure requirements in respect of their independence and compliance with the Code of Business Conduct & Ethics for Directors and Management Personnel;
- vi. Hon'ble National Company Law Tribunal (NCLT), Hyderabad Bench, vide order dated August 27, 2021, had initiated Corporate Insolvency Resolution Process (CIRP) under Section 9 of Insolvency and Bankruptcy Code, 2016 (IBC, 2016) in respect of a claim of M/s Key Trade AG, Switzerland, Operational Creditor.

However, Hon'ble National Company Law Appellate Tribunal (NCLAT), Chennai, had vide order dated September 14, 2021, granted stay on the implementation of the order dated August 27, 2021, passed by the Hon'ble NCLT, Hyderabad Bench.

The Hon'ble National Company Law Appellate Tribunal (NCLAT), Chennai, on October 05, 2023 (copy made

available on October 07, 2023), has allowed the appeal filed by Amlika Mercantile Private Limited, Core Promoter of Nagarjuna Fertilizers and Chemicals Limited by setting aside the impugned order dated August 27, 2021, passed by Hon'ble NCLT, Hyderabad Bench admitting the company into Corporate Insolvency Resolution Process (CIRP) under Insolvency and Bankruptcy Code, 2016.

Consequently, the company exited NCLT, under IBC, 2016, effective from October 05, 2023.

- vii. We have been given to understand that IDBI Bank Ltd on behalf of consortium of Lenders had issued a web notice dated November 15, 2022 and December 15, 2022, intending to Transfer the Stressed Loan Exposure of Nagarjuna Fertilizers & Chemicals Limited (NFCL) on all cash basis to eligible permitted entities in line with the regulatory guidelines and Bank's policy on Transfer of Stressed Loan Exposure subject to final approval by the Competent Authority of the Lead Bank & Consortium lenders.

The transfer is on 'as is where is and as is what is' and without recourse basis with Lenders not assuming any operational, legal or any other type of risks relating to the loan exposure.

Accordingly, the Company has received a mail correspondence on March 31, 2023, along with a letter of intimation dated March 31, 2023, that all the consortium lenders have assigned to Assets Care & Reconstruction Enterprise Ltd (ACRE) (as a Trustee of ACRE-112-Trust), vide Assignment Agreement dated March 29, 2023, entire fund based outstanding loans/financial assets along with all its rights, titles, interest, underlying securities and guarantees thereof under the relevant Financing Documents under section 5 of the SARFAESI Act, 2002.

ACRE has issued the demand notice under section 13(2) of the SARFAESI ACT 20.05.2023. The company while objecting to ACRE claim requested for an opportunity to submit a resolution plan. Without prejudice to their rights under SARFAESI, ACRE advised the company to submit resolution plan.

NFCL after a lot of effort identified a purchaser AM Green Ammonia (India) Private Limited, (a company incorporated by the promoters of Greenko group, one of the largest renewable energy players in the country) who is willing to invest in the Urea and Micro Irrigation (MI) business by way of slump sale on a going concern basis. This will allow the company to realise fair value for its business (in the interest of all stakeholders) and also allow lender/s to release better value as compared to the process under the provisions SARFAESI ACT/IBC. The details of the slump sale transaction and OTS as a debt resolution were presented to the Board for their consideration.

The Board of Directors of NFCL at their Meeting held on August 14, 2023, and Members at their Annual General Meeting held on September 15, 2023, considered, approved the following:

1. The slump sale of Ammonia/Urea and MI businesses along with related assets and liabilities to M/s. AM Green Ammonia (India) Private Limited (purchaser company), for a gross consideration of Rs 1365 Crores in cash and 19.7% in equity in the purchaser's company (to be held by NFCL) as part of the transaction. With a call option

available to the purchaser/ nominee on 19.7% equity to be exercised by the purchaser within one year for Rs 335 Crores with premium of 12% per Annum. This transaction is subject to terms and conditions precedents (including lenders approval and recognition and reimbursement of energy claims submitted by the company by DoFGol). It is agreed to distribute Urea produced from the transferred Urea Business in India by Nagarjuna Fertilizers and Chemicals Limited (NFCL) on commercially reasonable terms (as per govt regulations). An agreement to the effect would be entered into along with the slump sale agreements.

2. One Time Settlement (OTS) as debt resolution for amount of Rs 1500 Crores to be paid through proceeds of slump sale of Ammonia/Urea and MI business and sale of other non-core assets.

- viii. The company while continuing to work and is optimistic on fulfilling the critical CP's for the closure of the slump sale transaction, ACRE has taken symbolic possession of the scheduled assets of the company in its favour on October 12, 2023 and has issued a public notice for physical auction for sale of Movable and Immovable properties of the company under SARFAESI Act, 2002, vide email to the company dated January 17, 2024.

The company while continuing to work and is optimistic on fulfilling the critical CP's for the closure of the slump sale transaction has formally applied to ACRE (without any prejudice to the rights of NFCL regards to ongoing debt disputes). ACRE has communicated that Settlement Proposal submitted to ACRE by the Company is not binding and tentative on fulfillment on CPs and therefore is unable to consider and/or appraise the Settlement Proposal extended by the company at this point in time. In view of the above circumstances, while asking the company to continue and speed up closure of CPs for the approved Slump Sale transaction, the Board of Directors on December 24, 2023, without prejudice, considered and approved the company to engage and work with ACRE on a One Time Settlement under SARFAESI/ directly (or a combination of both) if any in parallel to the current efforts on the Slump Sale transaction to amicably settle debt.

We have been informed by the Management that Company has received email communication dated April 17, 2024, from ACRE that it has received an offer from a bidder above the reserve price and the bidder has submitted an upfront amount of 25% of the purchase consideration, in line with the terms of the sale.

We were further informed that consequent to the issue of sale confirmation to the highest bidder by ACRE, in terms of the provisions of SARFAESI Act, 2002, read with rules made thereunder, a sale certificate shall be executed in favour of the successful bidder on payment of the balance consideration in accordance with the terms of SARFAESI Act, 2002 and the rules.

ACRE vide email dated April 24, 2024, asked the company to deposit the proceeds/advances received from the sale of non-core assets as mandated by ACRE into fixed deposits lien marked in favour of ACRE. The sale of non-core assets shall take effect along with or after receipt of sale consideration from the sale of Core Assets under SARFAESI Act, 2002, by ACRE. The borrower/NFCL shall

be depositing the proceeds/advances it received from the sale into the lien marked Fixed Deposits as mandated by ACRE.

Assets Care and Reconstruction Enterprise Limited (ACRE) Secured Creditor, vide email dated May 31, 2024, has communicated to the Company that:

"In furtherance to the same, the bidder, AM Green Ammonia (India) Private Limited, now has made payment of balance 75% of the total bid amount of INR.1685 Crores and in terms of the provisions of SARFAESI Act read along with the Rules, ACRE has issued sale certificates in favor of the bidder AM Green Ammonia (India) Private Limited ("Bidder/Buyer") for all the secured assets forming part of the sale notice (Core Assets). The buyer on becoming the legal and rightful owner of the assets as listed and notified the developments that the assets as listed have been sold to be the buyer upon receipt of the entire sale consideration and requested to provide assistance in handing over the physical possession of the secured assets sold to the buyer."

2. **Under the Securities Contracts (Regulation) Act, 1956, We report that**

The Company has complied with the requirements of Securities Contracts (Regulation) Act, 1956 and the Rules made under that Act.

3. **Under the Depositories Act, 1996, We report that**

The Company has complied with the provisions of the Depositories Act, 1996 and the Byelaws framed thereunder by the Depositories with regard to dematerialization / re-materialisation of securities and reconciliation of records of dematerialized securities with all securities issued by the Company.

4. **Under FEMA, 1999, We report that**

The Company has complied with the provisions of the FEMA, 1999 and the Rules and Regulations made under that Act to the extent applicable.

5. **Under Reserve Bank of India Act, 1934, we report that:**

We have given to understand that the company does not require complying any of the provisions under the Reserve Bank of India Act, 1934.

6. **Under the SEBI Act, We report that**

- a. The Company has complied with the requirements under the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 except as mentioned in this report.
- b. The Company has complied with the provisions of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeover) Regulations, 2011 with regard to disclosures and maintenance of records required under the Regulations and we note that there are no transactions falling under the purview of these regulations during the financial year under review.

- d. The Company is not required to comply with the provisions of the Securities and Exchange Board of India

(Employee Stock Options Scheme and Employee Stock Purchase Scheme) Guidelines, 1999 with regard to implementation of Employees Stock Option Scheme, Grant of Options and related disclosures and other aspects as no such transaction had arisen in this respect during the year under review.

- e. The Company is not required to comply with the provisions of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations 2009 as there was no issue and no allotment of convertible warrants on preferential basis to entities in the Promoters Group.
- f. We further report that, the company has complied the Secretarial Standards issued by The Institute of Company Secretaries of India with regard to Meeting of the Board Meeting (SS-1) and General Meeting (SS-2)
- g. We further report that there are adequate systems and processes in the company commensurate with the size and operations of the Company to monitor and ensure compliance with applicable laws, rules, regulations and guidelines.

#### 7. Responsibility for other information

The Company's Board of Directors is responsible for the preparation of the other information. The other information comprises the information included in the Management Discussion and Analysis, Board's Report including Annexures to Board's Report, Business Responsibility Report, Corporate Governance and Shareholder's Information,

including the standalone financial statements and the auditor's report thereon.

Our opinion does not cover the other information and we do not express any form of assurance conclusion thereon. In connection with our Secretarial Audit, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Secretarial Audit or the laws applicable to the Company or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

The said other information is expected to be made available to us after the date of this audit report. When we read the other information, when furnished to us, if we conclude that there is a material misstatement therein, we are required to communicate the matter to those charged with governance.

## ANNEXURE – VII

### Nomination and Remuneration Policy

#### Introduction

This policy shall act as a guideline for determining, inter-alia, qualifications, positive attributes and independence of a Director, matters relating to the remuneration, appointment, removal and evaluation of performance of the Directors, Key Managerial Personnel, Senior Management and other employees.

#### Objective

##### The objectives for adopting the policy are:

- a) To ensure that the level and composition of remuneration payable to KMP and others is reasonable and sufficient to attract, retain and motivate persons to join the Board of Directors of the company so as to provide the company the required strategic direction.
- b) To clarify that remuneration is linked to performance and there exists appropriate benchmarks
- c) To ensure that the remuneration to Directors, Key Managerial Personnel and Senior Management involves a balance between fixed and incentive pay reflecting short and long term performance objectives synchronizing the same to the working of the company and its goals
- d) To lay down criteria for identifying persons to be qualified to become Directors (Executive and Non-executive) and persons who may be appointed in Senior Management, Key Managerial positions and to determine their remuneration
- e) To carry out evaluation of Directors, Key Managerial Personnel and Senior Management
- f) To ensure that the remuneration is being paid across the organization based on prevailing trends in the industry to retain, motivate and promote talent and to ensure long term sustainability of talented managerial persons and create competitive advantage.

Senior Management Personnel' for this purpose shall mean employees of the company who are members of its core management team excluding Board of Directors. It would comprise all members of management one level below the executive director(s), including the functional heads.

#### Appointment of Directors, Key Managerial Personnel and Senior Management

- a) The Nomination and Remuneration Committee shall identify persons who are qualified to become Directors and who may be appointed as Key Managerial Personnel and Senior Management.
- b) The Committee shall ascertain the qualifications, expertise and experience of the persons to be appointed as Directors, KMP and Senior Management and recommend their appointment to the Board of Directors.
- c) The decision of the Board of Directors based on the recommendation of the Committee shall be final
- d) The appointment including tenure of Directors and KMP shall be subject to the policy of the company, provisions of Companies Act, 2013, Listing Agreement and other relevant laws.
- e) The Committee shall evaluate their performance on a yearly basis and recommend their removal to the Board, if required.

#### Remuneration of Directors, KMP, Senior Management and other employees

- a) The remuneration payable to the Whole Time Directors shall be as per the provisions of the Companies Act, 2013 and other relevant provisions.
- b) The remuneration payable to KMP and Senior Management shall be approved by the Committee on case to case basis.
  - c) The increments to the existing remuneration structure
    - 1) In relation to Board of Directors based on the evaluation of performance
    - 2) In relation to KMP and Senior Management shall be approved by the Committee based on the recommendation of the Managing Director
    - 3) In relation to others shall be approved by the Managing Director based on the market conditions, performance of the company and other relevant factors from time to time.

#### Remuneration to Non-Executive and Independent Directors

The Non-Executive and Independent Directors of the company shall only be paid sitting fees (as determined by the Board from time to time) for attending Board/ Committee meetings apart from reimbursement of expenses incurred for attending the meetings.

**Common and Simplified Norms for processing investor's service request by RTAs and norms for furnishing PAN, KYC details and Nomination**

The Securities and Exchange Board of India vide Circular No. SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/655, dated November 03, 2021, SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/687, dated December 14, 2021, read with SEBI/HO/MIRSD/MIRSD\_RTAMB/PoD-1/P/CIR/2023/37, dated March 16, 2023, to enhance the ease of doing business for investors in the securities market, as prescribed Standardized, simplified and common norms for processing investor service requests.

Accordingly, Members are requested to promptly intimate / update PAN, KYC details i.e., name, postal address, e-mail-address, telephone/mobile numbers, mandates, nominations, bank details such as, name of the bank and branch details, bank account number, MICR code, IFSC code, etc., to Depository Participants if the shares are held in electronic form and to the Company's RTA if the shares are held in physical form in prescribed form.

The said form are available on the Company's website under Investor's Desk → In-House RTA/STA.

Further, in terms of the said circular the members holding shares in physical form are requested to submit valid PAN only i.e., PAN linked with Aadhaar number..The RTA shall revert the frozen folios to normal status upon a) receipt of valid PAN, KYC details and Nomination or b) dematerialization of all the securities in such folios.

To mitigate unintended challenges on account of freezing of folios, SEBI vide its Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2023/181 dated November 17, 2023, has done away with the provision regarding freezing of folios not having PAN, KYC and Nomination details.

**Transfers/ Transmissions etc. of shares only in dematerialized form**

The SEBI vide its Notification dated June 8, 2018 notified Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) (Fourth Amendment) Regulations, 2018 wherein it mandated that except in case of transmission or transposition of securities, requests for effecting transfer of securities shall not be processed unless the securities are held in the dematerialized form with a depository. The period of seven-years as envisaged in the Companies Act and the rules made thereunder has expired during the month of September, 2019. The Company as required by law has sent notice of intimation of transfer of shares and dividends to the shareholders dated June 30, 2019, and published an advertisement in the newspapers as required by law requesting the shareholders to claim the unclaimed / unpaid dividend within the due date as mentioned in the notice.

The Company has transferred the unpaid / unclaimed dividend corresponding shares to Investor Education and Protection Fund during the month of October 2019.

**1) Policy on Corporate Governance**

The foreign exchange risk of the Company arises mainly out of import of fertilizers. The Company continuously monitors its foreign exchange exposure and hedges its foreign exchange risk exposure to the extent considered necessary through forward contracts and option structures.

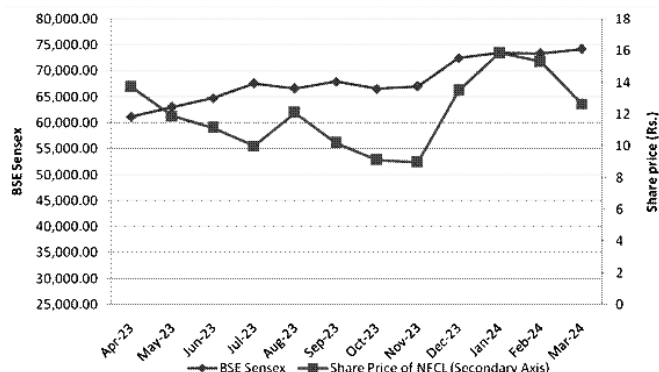

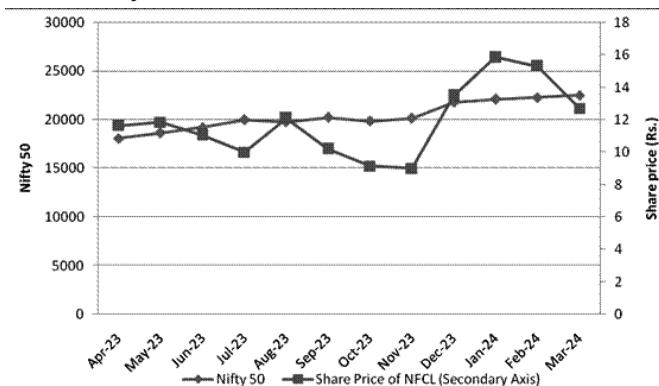

# Management Discussion and Analysis

## Global Economic Scenario

The world economy in 2024 is characterized by moderate growth, with significant regional variations. Inflationary pressures, geopolitical risks, and the energy transition are key drivers of the global economic landscape. While the long-term outlook points to continued technological innovation and a shift toward sustainability, the short-term challenges of inflation, trade tensions, and debt remain significant. Countries that can navigate these challenges effectively, particularly by investing in technology and green energy, are likely to emerge as leaders in the global economy.

Global economic growth is projected to moderate in 2024, with the International Monetary Fund (IMF) forecasting global GDP growth of around 3%. This marks a deceleration compared to pre-pandemic levels, influenced by a slowdown in advanced economies and uneven recovery in emerging markets. Advanced economies, are expected to see slower growth, while some emerging markets, such as India and parts of Southeast Asia, are poised for faster expansion. Sub-Saharan Africa and Latin America remain more vulnerable to economic shocks and slower growth.

Inflation remains a major concern in 2024, though it has begun to ease in some regions. Central banks are focused on balancing inflation control with economic growth. Inflation is driven by factors such as energy price fluctuations, labor shortages, and lingering supply chain disruptions.

Major central banks, including the U.S. Federal Reserve, European Central Bank (ECB), and Bank of England, are maintaining higher interest rates to tame inflation. The pace of rate hikes is slowing, but the high cost of borrowing is impacting consumer spending, business investments, and housing markets.

The war in Ukraine continues to have far-reaching effects, particularly on energy and food markets. Europe, in particular, has had to pivot away from Russian energy imports, accelerating its energy transition to renewables and LNG (liquefied natural gas) sources.

The war between Israel and Palestine has affected global logistics movement having impact on economy.

Governments and corporations are increasingly investing in renewable energy sources, such as wind, solar, and hydrogen, driven by climate goals and energy security concerns. The shift to a low-carbon economy is creating new industries and reshaping traditional energy markets.

Traditional fossil fuels, especially oil and natural gas, remain volatile due to geopolitical factors, such as sanctions on Russia and supply constraints from OPEC+ decisions. However, the growing adoption of green energy is beginning to stabilize long-term energy costs.

The global supply chain landscape has been undergoing structural changes since the COVID-19 pandemic, with many companies diversifying their suppliers away from China to mitigate risks. Regions like Southeast Asia and Mexico are benefiting from this shift.

New trade deals and regional agreements, particularly in Asia and Africa, are shaping the future of global commerce. These agreements are focusing on areas such as digital trade, sustainability, and technology.

## Indian Economic Scenario

India's economic scenario in 2024 is marked by resilience, growth opportunities, and ongoing challenges. The country is experiencing a mix of robust economic activity, policy reforms, and external factors influencing its growth trajectory.

India is expected to grow at a robust pace in 2024, with estimates of GDP growth hovering around 6-6.5%. This positions India as one of the fastest-growing major economies, driven by domestic demand, government investments, and expanding industries like technology and manufacturing. Key growth drivers include government-led infrastructure projects, increased private investment, consumer demand, and a growing services sector, especially in IT, finance, and healthcare.

Inflation remains a concern, but it is expected to moderate compared to the high levels seen in previous years. The Reserve Bank of India (RBI) continues to implement measures to keep inflation in check, balancing between supporting growth and controlling price increases. The RBI has maintained a cautious stance on interest rates, keeping them elevated to manage inflation but remaining accommodative enough to support growth.

The Indian government's focus on boosting domestic manufacturing through initiatives like the "Make in India" and Production-Linked Incentive (PLI) schemes has started to show results. Key sectors like electronics, pharmaceuticals, and automotive are seeing increased production, with India emerging as a competitive manufacturing hub. India's industrial growth is benefiting from policy reforms and increasing foreign direct investment (FDI) in sectors such as electronics, defense, and semiconductors. Manufacturing is becoming more diversified and tech-driven, creating job opportunities and improving export capabilities.

The Indian government's focus on infrastructure development remains a central pillar of its growth strategy. Major projects, including roads, railways, ports, and airports, are under development to enhance connectivity and boost economic productivity.

The agriculture sector, which remains vital to the Indian economy, is seeing mixed results. While productivity has increased, driven by better irrigation, technology, and crop diversification, challenges like climate change, erratic monsoons, and farm income disparities persist.

Government initiatives focusing on rural development, such as improving rural infrastructure, digital access, and financial inclusion, are helping lift the rural economy. However, rural distress remains a concern due to uneven income growth and agricultural dependency.

India is making substantial strides in renewable energy, particularly solar and wind. The government's ambitious targets aim to transition India towards a more sustainable energy mix, reducing reliance on coal and other fossil fuels. India is emerging as a leader in the global clean energy transition.



While renewable energy is expanding, India still relies heavily on coal for electricity generation. Balancing energy security with climate commitments is a key challenge, especially as demand for energy continues to grow.

India's economy in 2024 is on a solid growth path, benefiting from domestic demand, policy reforms, and investment in key sectors like infrastructure, manufacturing, and technology. India's global influence continues to rise, positioning it as a key player in the world economy, particularly in trade, technology, and sustainability.

### Agriculture Sector

The Indian agriculture sector continues to play a crucial role in the economy, contributing around 16-18% to the country's GDP and employing nearly 50% of its workforce. However, the sector is facing both opportunities and challenges as it transitions through modernization, climate impacts, and policy reforms.

The agriculture sector is expected to grow at a moderate pace, contributing to food security and rural livelihoods. While the overall contribution to GDP is decreasing as other sectors grow, agriculture remains vital for employment and sustenance, especially in rural areas.

MSP remains a central issue for farmers, with the government continuing to support key crops like rice and wheat. However, there is an increasing push toward reducing the dependence on MSP and encouraging diversification into other, more remunerative crops.

Technology is transforming Indian agriculture, with increased use of precision farming techniques. Technologies like drones, satellite imagery, and IoT-based sensors are helping farmers monitor crops, optimize irrigation, and improve yields.

The rise of digital platforms and mobile applications is providing farmers with real-time data on weather, crop prices, and farming practices. These platforms are also helping connect farmers to buyers, reducing intermediaries, and ensuring better price discovery.

The government and private sector are promoting sustainable agricultural practices, including organic farming, reduced chemical use, and conservation agriculture. Organic farming, though still a small part of Indian agriculture, is growing due to increased demand for organic products both domestically and internationally.

A large portion of Indian agriculture still relies heavily on monsoons, making the sector vulnerable to climate variability. While irrigation infrastructure has improved, only about half of the cultivated land is irrigated, leading to productivity challenges.

The government is investing in large-scale irrigation projects and promoting micro-irrigation techniques like drip and sprinkler systems to ensure more efficient water use, particularly in water-scarce regions like Rajasthan and Gujarat.

The agriculture supply chain in India is becoming more efficient, aided by investments in cold storage, transportation, and logistics. This is reducing post-harvest losses, particularly in perishable goods like fruits and vegetables.

The government's electronic National Agriculture Market (e-NAM) is helping farmers gain better access to markets, reducing the need for middlemen. However, full-scale adoption

of these platforms is still in progress, with many farmers continuing to rely on traditional local markets (mandis).

**PM-Kisan:** Direct income support continues to be provided under the PM-Kisan scheme, offering financial relief to small and marginal farmers. The scheme is expected to reach more farmers in 2024 as the government enhances its coverage.

**National Mission for Sustainable Agriculture (NMSA):** This program aims to promote sustainable farming techniques, better water management, and climate-resilient crops. The government is also supporting the development of infrastructure like cold storage, warehouses, and transportation to reduce post-harvest losses.

### Fertilizer Sector

Fertilizer consumption in India continues to rise steadily in 2024, driven by increasing agricultural output and the push for higher crop yields. India remains one of the largest consumers of fertilizers globally, with urea, DAP (diammonium phosphate), and MOP (muriate of potash) being the key fertilizers used.

The government is promoting the balanced use of fertilizers through campaigns to improve soil health and reduce the overuse of certain fertilizers like urea. This is a response to the long-standing issue of imbalanced fertilizer use, which has led to soil degradation in many parts of the country.

India has been focusing on increasing its domestic fertilizer production capacity to reduce its dependency on imports, particularly in the case of urea. Several new plants are being commissioned in 2024 under the government's self-reliance initiative (Atmanirbhar Bharat). This includes reviving older, defunct fertilizer plants and expanding existing ones.

Despite efforts to boost domestic production, India remains dependent on imports for certain key fertilizers like phosphate and potash. Global price volatility in raw materials and finished fertilizers impacts the domestic market, leading to fluctuations in availability and prices.

There is an increasing emphasis on organic and bio-fertilizers as part of India's sustainable agriculture initiatives. The government is promoting the use of organic inputs and bio-fertilizers to improve soil health, reduce chemical inputs, and lower the environmental impact of agriculture.

Programs such as the National Mission on Sustainable Agriculture (NMSA) are being leveraged to encourage farmers to adopt sustainable fertilizer practices, which include reducing excessive chemical fertilizer use and adopting integrated nutrient management practices.

The sector is highly regulated due to the critical nature of fertilizers in agriculture. The pricing of key fertilizers like urea is controlled by the government, while market-based pricing applies to others like DAP, though with government subsidies. Competition among players is intense, with a focus on maintaining supply chains and improving efficiency.

Global events, such as the Russia-Ukraine conflict, continue to impact the availability and pricing of key fertilizers in 2024. India, being a significant importer of phosphate and potash, is vulnerable to global price fluctuations. This has prompted India to explore long-term supply agreements with countries rich in these resources, such as Russia, Canada, and Morocco.

India is also looking to become a major exporter of fertilizers, particularly urea, as domestic production increases. Efforts to modernize plants and make them more efficient may help India become more competitive in the global fertilizer market.

One of the major challenges faced by the fertilizer industry is the rising cost of raw materials like natural gas (for urea production) and phosphoric acid (for DAP). These costs are largely driven by global market trends, making domestic production and pricing more difficult to manage.

Global supply chain issues continue to affect the availability of fertilizers, leading to price volatility. The sector is focusing on building more resilient supply chains and reducing dependence on imports through long-term partnerships.

As India pushes for a greener future, the fertilizer sector is expected to increasingly embrace sustainable practices, including the use of organic fertilizers and more efficient chemical fertilizers like nano urea. These developments will help reduce the environmental impact of the industry while supporting agricultural productivity.

### Government Policies

The Indian government continues to implement various fertilizer policies aimed at ensuring the availability of affordable fertilizers, promoting sustainable practices, and improving the efficiency of the sector.

- **Urea Subsidy Scheme:** Presently, Urea is being provided to the farmers at a statutorily notified Maximum Retail Price. Per bag of urea. Under the scheme, the difference between the delivered cost of urea at farm gate and net market realization by the urea units is given as subsidy to the urea manufacturer or importer.
- **Nutrient Based Subsidy Scheme:** Subsidy rates of P&K fertilizers under this scheme were increased on 20th May 2021 and 13th October 2021, and then further increased substantially for Kharif-2022, so that these fertilizers are available at affordable prices to the farmers.
- **Direct Benefit Transfer (DBT) project for fertilizer subsidy payment:** Department of Fertilizers (DoF) has implemented the scheme for fertilizer subsidy payment to improve fertilizer service delivery to farmers. Under the DBT system, 100% subsidy on various fertilizer grades is released to the fertilizer companies on the basis of actual sales made by the retailers to the beneficiaries.
- **Nano Urea:** The Government of India recently notified the specifications of Nano nitrogen under Fertilizer Control Order 1985. Nano fertilizers hold great promise for application in plant nourishment because of the size-dependent qualities, high surface volume ratio and unique optical properties.
- **One Nation One Fertilizers:** The Government decided to implement One Nation One Fertilizers by introducing Single Brand for fertilizers and Logo under fertilizer subsidy scheme namely "PradhanmantriBharatiyaUra-varakPariyogna". The single brand name for urea, DAP, MOP and NPKs etc would be Bharat Urea, Bharat DAP, Bharat MOP and Bharat NPK respectively for all fertilizer companies and importers. New Brand name and logo to be used by all fertilizer companies from 30th November, 2022 for imported urea, Indigenous Urea and Imported

PNK and from 31st December, 2022 for Indigenous PNK. The release of fertilizer subsidy to companies will be considered only for fertilizer dispatches in the new bags after the above-mentioned cut-off dates.

- **Pradhanmantri Kisan Samridhi Kendra (PMKSK):** The Government decided to convert the existing village, block/sub-district/taluk and district level fertilizer retail shops into Model Fertilizer Retail Shop or to establish new ones. Model fertilizer retail shop will act as One Stop Shop for all agriculture related inputs and services. The name of the Model Fertilizer Retail Shop would be Pradhanmantri Kisan Samridhi Kendra (PMKSK). As on date there are 3.3 Lakhs fertilizer retail shops at district, block/sub-district and village levels, all these shops will be converted into model retail shops. The timelines for conversion of these shops have also been prescribed.
- **Balanced Fertilizer Use:** The NBS scheme encourages the use of fertilizers based on the nutrient content, promoting a balanced application of nitrogen (N), phosphorus (P), and potassium (K). This is part of the government's effort to reduce the overuse of urea and ensure better soil health.
- **Soil Health Card Scheme:** The Soil Health Card scheme, which was launched earlier but continues in 2024, is aimed at providing farmers with detailed information about the nutrient status of their soils. This helps in the better application of fertilizers, reducing overuse and promoting balanced fertilization. The government is working to expand the reach of this scheme to more farmers.

### Company's Strengths and opportunities

The Company's main strength lies in an excellent track record of project execution, achieving high production levels and good safety record. The company has multiple advantages of having good brand image, nearness to raw material, and the market at its doorstep.

### Financial Performance vis a vis Operational Performance Financials

The Company recorded a loss after tax for the year was Rs. 1283.88 crores against Rs.900.09 crores for the previous year. The loss before exceptional items for the period increased by Rs 201.62 Crs mainly on account of accounting of Rs. 231.32 Crs revision in energy norms from Oct 2020 to March 2023 in the previous year which is not there in the current year

### Plant Operations

The Company during the financial year 2023-24 manufactured 13.102 LMT of urea as against 11.205 LMT in the previous year. The production for the year 2023-24 to low load operation of the plants due to equipment limitations

### Sales and Marketing

The Company achieved a sale of manufactured urea of 13.08 LMT compared to 11.20 LMT in the previous year. The total urea sales for both manufactured and imported urea was 13.08 LMT compared to 11.20 LMT of previous year.

- i. **Debtors Turnover Ratio:** Reduced due to lower turnover and reduction in average receivables.
- ii. **Inventory Turnover Ratio:** Increase in ratio due to higher inventory holdings being non-season at the year end and decrease in sales revenue due to lower subsidy value.
- iii. **Interest coverage Ratio:** Decreased due to increase in cash losses in the current year.

The Company is incurring losses for the last few years therefore Net Worth of the Company became negative from March 31, 2021.

**Human Resources and industrial Relations**

The Company during the previous year continued to have good industrial relations with all its employees. Various initiatives have been taken to impart training and development activities so that employees are prepared to take up new challenges for their own development and also for the overall wellbeing of the Company. There are 813 employees on the rolls of the Company as on 31.03.2024.

**Internal Control Systems.**

The Company has a strong internal control system comprising various levels of authorization, supervision, checks and balances and procedures through documented policy guidelines and manuals. The scope and authority of the Internal Audit function is defined in the Internal Audit Charter. With a view to maintaining independence and objectivity in its working, the Internal Audit function reports directly to the Audit Committee.

The internal financial controls within the Company are also commensurate with the size, scale and complexity of its operations. The controls were tested during the year and no reportable material weaknesses either in their design or operations were observed.

**Risks, issues and concerns**

Assets Care and Reconstruction Enterprise Limited (ACRE) has initiated SARFAESI process under SARFAESI Act, 2002, and issuance SARFAESI notice on 20th May, 2023, and took over the possession of all assets on Oct 12, 2023, the secured creditor.

ACRE recovered from sale of core assets (Urea and MI facilities), non-core assets (all assets other than Urea and MI assets) towards full and final settlement of debt outstanding of Rs. 3858 crores as claimed by ACRE as of 10th December 2023.

In this regard, ACRE has issued No Due Certificate dated 11th July, 2024, confirming that NFCL stands unconditionally and irrevocably released and discharged of any liabilities, dues, demands or claims in respect of the outstanding debt, other amounts due and payable to ACRE, including release of all security created in favour of ACRE, personal guarantees and pledge of shares of NFCL held by promoter.

Post the sale of assets, majority of the staff/associates of the company have been moved from the company for their b SARFAESI.

**Outlook / Future plans.**

The post assets sale of Urea and MI businesses, the company is exploring new business opportunities.

# INDEPENDENT AUDITOR'S REPORT

To the Members of **Nagarjuna Fertilizers and Chemicals Limited**

## Report on the Ind AS Standalone Financial Statements

### I. Qualified Opinion:

We have audited the accompanying Ind AS Standalone Financial Statements of M/s Nagarjuna Fertilizers and Chemicals Limited ("the Company"), which comprise the Standalone Balance Sheet as at 31st March, 2024, the Standalone Statement of Profit and Loss (including Other Comprehensive Income), the Standalone Statement of Cash Flows and the Standalone Statement of changes in equity for the year then ended, and a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, except for the possible effects of the matters described in the Basis for Qualified opinion section of our report, the aforesaid standalone financial statements give the information required by the Companies Act, 2013, as amended ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the State of Affairs of "the Company" as at March 31st, 2024, its Loss including other comprehensive income, Changes in Equity and its Cash flows for the year then ended.

### II. Basis for Qualified opinion:

We refer to Note No: 14 & 26 to ("the Standalone Financial Statements") wherein "the Company" explained that the lenders (Banks) of "the Company" have not implemented the Corrective Action Plan (CAP) approved by them in the Joint Lenders Forum (JLF) meeting held in 2015 and though "the Company" represented the matter to the lenders for necessary corrective action, the same has not been rectified till date. As a result, "the Company" filed cases against the lenders in the Hon'ble High Court of Telangana, which has restrained the lenders from taking any coercive action against the company. Currently in this regard Writ Appeal 708/2022, is pending before Telangana High Court. Further, there is no clear information on when the loans were declared as NPAs by the lenders. Due to these disputes, the lenders have not been sending the interest demands and the loan statements/ confirmation of balances to "the Company" since 6 years. In this background, "the Company" has been accounting the interest on the loans as per the terms of CAP funding sanction letters with a qualification of dispute and furnishing the default details as available with it in the financial statements.

We refer to Note No: 14.1 to ("the Standalone Financial Statements") wherein "the Company" stated that on 3rd April 2023, "the Company" received a letter dated 31st March 2023, copying to all the Lender (Secured Creditor), from Assets Care & Reconstruction Enterprise Ltd (ACRE) communicating the Assignment of Debt by all Consortium Lenders to ACRE (in its capacity as the trustee of the ACRE-112-TRUST) under section 5 of the SARFAESI Act. There

was no communication to the Company from the Lenders about the assignment of their loans / credit facilities / interest etc., as stated above to the ACRE-112-TRUST by 31.03.2023. Without prejudice to the rights of the company and guarantors, the company has accordingly recorded the communication from ACRE-112-TRUST.

In the absence of independent audit evidence from the lenders (Banks) on the date(s) from which the loan accounts have been classified as NPAs, outstanding amount of borrowings at the end of every year, interest accrued thereon, period and amount of default in repayment of loans and payment of interest thereon disclosed in the financial statements and continuing the outstanding borrowings with the existing lenders (Banks), we are unable to express an opinion whether any adjustments are required to be made to the outstanding balance of borrowings as at the year end, interest on the borrowings charged to the statement of profit and loss for the year and the period and amount of default in repayment of principal and payment of interest disclosed in the financial statements.

We conducted our audit of the standalone financial statements in accordance with the Standards on Auditing specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Standalone Financial Statements section of our report. We are independent of "the Company" in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the ethical requirements that are relevant to our audit of the standalone financial statements under the provisions of the Act and the Rules made thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion on the standalone financial statements.

### III. Material uncertainty related to going Concern:

1. We Refer to Note No.29 to the standalone financial statements, on the disclosure of Material Uncertainty on "the Company's" ability to continue as a Going Concern and appropriateness of use of Going Concern basis of accounting in preparation of financial statements.

"The Company" has been incurring recurring losses resulting in complete erosion of net worth and the company is facing liquidity issues. As at the Quarter/ Year ended 31st March, 2024, the Company's current liabilities exceeded the current assets by Rs.3,96,414.20 Lakhs.

The Company, during the year under review, continued to default in discharging its obligations for repayment of Loans and settlement of other financial and non-financial liabilities including statutory dues on the due dates. The lenders have been treating the loans to "the Company" as Non-Performing Assets since last six years.

We Refer to Note No.30 to “the Standalone Financial Statements” wherein “the Company” stated that it has received a demand notice dated 20th May 2023 u/s 13(2) of the SARFAESI Act from ACRE to repay total outstanding dues of Rs 3,344.37crores. ACRE, as part of the SARFAESI process after taking symbolic possession of assets (on October 12, 2023), has issued a Public Notice for auction of Sale of Movable and Immovable properties of the Company under SARFAESI Act, 2002, vide email to the company dated January 17,2024. ACRE in their public auction notice stated that as of December 2023 “the Company” owed ACRE around Rs. 3858 Crs including interest. The Company has received an email communication dated April 17, 2024, from ACRE that it has received an offer from a bidder above the reserve price and the bidder has submitted an upfront amount of 25% of the purchase consideration, in line with the terms of the sale. It was further stated in the said mail, that consequent to the issue of sale confirmation to the highest bidder by ACRE, a sale certificate shall be executed in favour of the successful bidder on payment of the balance consideration

The above events and conditions indicate material uncertainty which cast a significant doubt on “the Company's” ability to continue as a going concern, and therefore may be unable to realize its assets and discharge its liabilities including potential liabilities in the normal course of its business. The ability of “the Company” to continue as going concern is solely dependent on the successful restructuring/resolution plans and raising of the required additional funds.

However, the management is of the opinion that the preparation of the financial statements of “the Company” for the quarter and year ended 31st March, 2024 as going concern is still appropriate considering the uncertainties and final outcome of the results of the actions taken as discussed above by ACRE for sale of core and non-core assets, further taking of the future plans of the company for continuation of business operations and given the above background on its effort for OTS as Debt Resolution.

2. We Further refer to Note 30, that ACRE has taken symbolic possession to enable them to start auction process, but has not imposed any restrictions on the plant operations as on the date. There is no discontinuance of plant operations and usual operations are being carried out by the company. Revenue, both, sales from Urea & Micro Irrigation and subsidy on Urea are being generated in normal course of business. subsidy claims are being raised in the name of the company as per the procedures laid by the Government and subsidy amounts are also received / receivable in the name of the company. Considering the above facts and that the financial are prepared on a going concern basis, the Property, Plant and Equipment are continued to be disclosed as Non Current operating assets at its carrying value.

**Our opinion is not modified in respect of this matter.**

#### **IV. Emphasis of Matter Paragraph:**

Attention is invited to the following notes in the standalone financial statements:

- a. Note No 20.1: “the Company” has recognized Income from Urea Operations, Income towards freight subsidy, Reimbursement claims towards additional fixed cost, Input escalation/de-escalation during the year in terms of new Urea policy (NUP)-2015 and Gas Pooling Policy for Fertilizer (Urea) Sector. Adjustments, if any, required will be considered on notification of final prices.
- b. Note No 31: The Plant and Machinery, buildings attached there to have been put to test for impairment as of 31st March 2024 and management perceive that there is no further impairment loss required to be recorded  
  
Impairment test of property (land) was carried out as of 30th June 2023 during the year and recorded an impairment loss of Rs. 63,407.20 Lakhs as per the Registered Valuer’s Report dated 12th August 2023. The management is of the opinion that there is no further impairment of land as at 31.03.2024.
- c. Note No 32.1: The claims as per the International Arbitration Awards passed against “the Company” in September 2016 and October 2017, aggregating to USD 15,275,688, GBP 742,944 and EUR 455,000 and INR 221.39 Lakhs (equivalent Aggregate amount of Rs. 14,150.09 Lakhs) and interest thereon as applicable apart from costs, are continued to be shown as a contingent liability since the matter being sub-judice.
- d. Note No 32.2 Claim from a related party asserting its right for Royalty for the period from 29.01.1998 onwards, is being negotiated with the granter for settlement.
- e. Note No 32.4: Hon’ble NCLT admitted a petition filed by an operational creditor to initiate the CIRP against “the Company” under the provisions of the IBC 2016, Amlika Mercantile Private Ltd (One the of Promoter of “the Company”) appealed against the order of Hon’ble NCLT. The NCLAT has set aside the this CIRP proceedings under IBC and currently “the Company” is out of CIRP. AMPL has claimed the legal expenses for the NCLAT appeal filed on behalf of “the Company” and “the Company” is liable to reimburse the legal expenses to AMPL.

- If, based on the work we have performed, we conclude that there is a material misstatement of this other information; we are required to report that fact. We have nothing to report in this regard.

## VII. Management's Responsibility for the Standalone Financial Statements:

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act with respect to the preparation of these standalone financial statements that give a true and fair view of the financial position, financial performance, total comprehensive income, changes in equity and cash flows of the Company in accordance with the Ind AS and other accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the standalone financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the standalone financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The Board of Directors are also responsible for overseeing "the Company's" financial reporting process.

## VIII. Auditor's Responsibilities for the Audit of the Standalone Financial Statements:

Our objectives are to obtain reasonable assurance about whether the standalone financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these standalone financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the standalone financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the standalone financial statements, including the disclosures, and whether the standalone financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

Materiality is the magnitude of misstatements in the standalone financial statements that, individually or, in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the financial statements may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

## Notes forming part of the Financial Statements for the year ended March 31, 2024

**1 CORPORATE INFORMATION**

Nagarjuna Fertilizers & Chemicals Limited (The company/NFCL) is a public listed company domiciled in India, incorporated under the provisions of the Companies Act 1956. Its shares are listed on The Bombay Stock Exchange and The National Stock Exchange Of India. The registered office of the company is situated at D.No 8-2-248, Nagarjuna Hills, Punjagutta, Hyderabad - 500082. The Company is principally engaged in the business of manufacturing and marketing of Fertilizers and Micro Irrigation Equipments.

**2 SIGNIFICANT ACCOUNTING POLICIES****2.1. Basis of preparation:**

The Financial Statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under section 133 of the Companies Act, 2013 read with Companies (Indian Accounting Standards) Rules, 2015 as amended, on accrual basis under the historical cost convention, except for Derivative financial instruments and certain financial instruments, which are measured at fair value.

The Financial Statements are presented in INR and all values are rounded to two decimals to the nearest lakhs, except when otherwise indicated.

The financial statements have been approved for issue by the Board of Directors of the Company in its meeting held on May 20, 2024.

**2.2. Use of estimates:**

The preparation of Financial Statements requires management to make judgments, estimates and assumptions in the application of accounting policies that affect the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Continuous evaluation is done on the estimation and judgments based on historical experience and other factors, including expectations of future events that are believed to be reasonable. Revisions to accounting estimates are recognised prospectively. Information about critical judgments in applying accounting policies, as well as estimates and assumptions that have a significant effect on the carrying amounts of assets and liabilities within the next financial year, are included in the following notes:

- i. Measurement of defined benefit obligations - Note 25.1
- ii. Recognition of deferred tax asset/Liability- Note 17
- iii. Fair Value Measurement of financial Instruments - Note 35
- iv. Recognition of subsidy income - Note 20
- v. Provision for doubtful trade receivables - Note 7

**2.3. Current versus non-current classification**

An asset or liability is classified as current if it satisfies any of the following conditions:

- i. the asset/liability is expected to be realized/settled in the Company's normal operating cycle;
- ii. the asset is intended for sale or consumption;
- iii. the asset/liability is held primarily for the purpose of trading;
- iv. the asset/liability is expected to be realized/settled within twelve months after the reporting period;
- v. the asset is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least twelve months after the reporting date;
- vi. in the case of a liability, the Company does not have an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

All other assets and liabilities are classified as non-current.

Deferred tax assets and liabilities are classified as non-current assets and liabilities.

For the purpose of current/non-current classification of assets and liabilities, the Company has decided its normal operating cycle as twelve months. This is based on the nature of services and the time between the acquisition of assets or inventories for processing and their realization in cash and cash equivalents.

**2.4. Property, Plant and Equipment (PPE)**

Property, plant and equipment is stated at acquisition cost, net of accumulated depreciation and accumulated impairment losses, if any. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced.

All repairs and maintenance are charged to the Statement of Profit and Loss during the period in which they are incurred. Gains or losses arising on retirement or disposal of property, plant and equipment are recognised in the Statement of Profit and Loss.

Property, plant and equipment which are not ready for intended use as on the date of Balance Sheet are disclosed as Capital work-in-progress.

Depreciation is provided on pro-rata basis under the straight-line method based on estimated useful life prescribed under Schedule II to the Companies Act, 2013 with the following exception:

- Continuous Process Plants' are depreciated for 37 years based on the technical evaluation of useful life done by the management.

The residual values, useful lives and method of depreciation of property, plant and equipment is reviewed at each financial year end and adjusted prospectively, if appropriate.

Upon first-time adoption of Ind AS, the Company has elected to measure all its property, plant and equipment at the Previous GAAP carrying amount as its deemed cost on the date of transition to Ind AS i.e., April 1, 2015.

## 2.5. Intangible assets

Separately purchased intangible assets are initially measured at cost. Intangible assets acquired in a business combination are recognised at fair value at the acquisition date. Subsequently, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses, if any.

The useful lives of intangible assets are assessed as either finite or indefinite. Finite-life intangible assets are amortised on a straight-line basis over the period of their expected useful lives. Estimated useful lives by major class of finite-life intangible assets are as follows:

Trademarks and Services: 10 years

The amortisation period and the amortisation method for finite-life intangible assets is reviewed at each financial year end and adjusted prospectively, if appropriate.

Upon first-time adoption of Ind AS, the Company has elected to measure all its intangible assets at the previous GAAP carrying amount as its deemed cost on the date of transition to Ind AS i.e., April 1, 2015.

## 2.6. Impairment of non-financial assets

Assessment for impairment is done at each Balance Sheet date for any indication that a non-financial asset may be impaired. For the purpose of assessing impairment, the smallest identifiable group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows from other assets or groups of assets is considered as a cash generating unit.

If any indication of impairment exists, an estimate of the recoverable amount of the individual asset/cash generating unit is made. Asset/cash generating unit whose carrying value exceeds their recoverable amount are written down to the recoverable amount by recognizing the impairment loss as an expense in the Statement of Profit and Loss. Recoverable amount is the higher of an asset's or cash generating unit's fair value less cost of disposal and its value in use. Value in use is the present value of estimated future cash flows expected to arise from the continuing use of an asset or cash generating unit and from its disposal at the end of its useful life. Assessment is also done at each Balance Sheet date for any indication that an impairment loss recognised for an asset in prior accounting periods may no longer exist or may have decreased, in which case, a reversal of an impairment loss for an asset is recognised in the Statement of Profit and Loss account.

## 2.7. Inventories

Inventories are valued at the lower of cost and net realisable value. Materials and other supplies held for use in the production of inventories are not written down below cost if the finished products in which they will be incorporated are expected to be sold at or above cost.

Costs for different categories of inventories are as follows:

- Raw materials and Traded Products: Cost of purchase

and other costs incurred in bringing the inventories to their present location and condition.

- Finished goods and work in progress: Cost of direct materials and labour and a proportion of manufacturing overheads based on the normal operating capacity, but excluding borrowing costs.

Net realisable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and the estimated costs necessary to make the sale.

Net realisable value in the case of Urea is –

- the Group Concession Price notified by the Government of India in respect of finished goods lying at the factory, and

- the net sale price in respect of finished goods lying in the warehouses outside the factory.

Raw materials, work-in-progress, stores, spares, packing material and loose tools are valued at weighted average cost, less provision for depletion in value, if any.

## 2.8. Cash and Cash Equivalents

Cash and cash equivalents in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value. For the purpose of the statement of cash flows, cash and cash equivalents consist of cash and short-term deposits, as defined above, net of outstanding bank overdrafts as they are considered an integral part of the Company's cash management.

## 2.9. Financial instruments

Financial assets and liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument.

### A. Financial assets

#### (i) Initial recognition

On initial recognition, financial assets other than Trade Receivables are recognised at fair value. Transaction cost that are directly attributable to acquisition of financial assets that are not at fair value through profit and loss (FVTPL) are added to fair value on initial recognition.

#### ii) Subsequent measurement:

Financial assets which are debt instruments are subsequently measured on the following basis, depending on their classification

- amortized cost

- fair value through profit and loss (FVTPL)

- fair value through other comprehensive income (FVOCI)

Financial assets are not reclassified subsequent to their recognition, except if and in the period the Company changes its business model for managing financial assets.

#### (iii) When financial assets are Equity Instruments:

All equity investments in the scope of Ind AS 109 are measured at fair value. Equity instruments which are held for trading are classified as at FVTPL. For all other equity instruments, the Company may make an irrevocable elec-

tion to present in other comprehensive income (OCI) subsequent changes in the fair value. The Company makes such election on an instrument-by-instrument basis. Fair value changes on an equity instrument are recognised as other income in the Statement of Profit and Loss unless the Company has elected to measure such instrument at FVOCI.

Fair value changes excluding dividends, on an equity instrument measured at FVOCI are recognised in OCI. Amounts recognised in OCI are not subsequently reclassified to the Statement of Profit and Loss. Dividend income on the investments in equity instruments are recognised as 'other income' in the Statement of Profit and Loss.

**(iv) De-recognition:**

The Company derecognizes a financial asset when the contractual right to the cash flows from the financial asset expires or it transfers the financial asset and at the transfer qualifies for de-recognition under IND AS 109.

**(v) Trade Receivables and Loans:**

Trade receivables that do not contain a significant financing component are measured at transaction price. Subsequently, these assets are held at amortised cost, using the effective interest rate (EIR) method net of any expected credit losses. The EIR is the rate that discounts estimated future cash income through the expected life of financial instrument.

**(vi) Impairment:**

Expected credit losses are recognized for all financial assets subsequent to initial recognition other than financials assets in FVTPL category.

For financial assets other than trade receivables, as per Ind AS 109, the Company recognises 12 month expected credit losses for all originated or acquired financial assets if at the reporting date the credit risk of the financial asset has not increased significantly since its initial recognition. The expected credit losses are measured as lifetime expected credit losses if the credit risk on financial asset increases significantly since its initial recognition. The Company's trade receivables do not contain significant financing component and loss allowance on trade receivables is measured at an amount equal to life time expected losses i.e. expected cash shortfall. The impairment losses and reversals are recognised in Statement of Profit and Loss.

**B. Financial liabilities:**

Financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument.

**(i) Initial recognition and measurement:**

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss and financial liabilities at amortised cost as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of liabilities measured at amortised cost, net of directly attributable transaction costs.

**(ii) Subsequent measurement:**

All financial liabilities are subsequently measured at amortised cost using the effective interest method or at fair value through profit or loss.

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities at FVTPL are stated at fair value, with any gains or losses arising on remeasurement recognised in profit or loss.

Financial liabilities that are not held-for-trading and are not designated as at FVTPL are measured at amortised cost at the end of subsequent accounting periods. The carrying amounts of financial liabilities that are subsequently measured at amortised cost are determined based on the effective interest method. Interest expense that is not capitalised as part of costs of an asset is included in the 'Finance costs' line item.

**(iii) Derecognition:**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another financial liability on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the Statement of Profit and Loss.

**C. Derivative financial instruments**

The Company holds derivative financial instruments such as foreign exchange forward and options contracts to mitigate risk of changes in exchange rates on foreign currency exposure.

Such derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently re-measured at fair value at each reporting period. Any gains or losses arising from re-measurement are dealt in Statement of profit or loss.

This category has derivative financial assets or liabilities which are not designated as hedges. Although the company believes that these derivatives constitute hedges from an economic perspective, they may not qualify for hedge accounting under Ind AS109, Financial Instruments, and hence categorized as financial assets or liability at fair value through profit or loss.

**D. Offsetting of financial instruments**

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

**2.10. Fair value measurement**

The Company measures financial instruments, such as, derivatives at fair value at each balance sheet date.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- In the principal market for the asset or liability, or
- In the absence of a principal market, in the most advantageous market for the asset or liability

The principal or the most advantageous market must be accessible by the Company. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the Financial Statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – Quoted (unadjusted) market prices in active markets for identical assets or liabilities
- Level 2 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable
- Level 3 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the Financial Statements on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

For the purpose of fair value disclosures, the Group has determined classes of assets and liabilities on the basis of the nature, characteristics and risks of the asset or liability and the level of the fair value hierarchy as explained above.

## 2.11. Provisions, contingent liabilities and contingent assets

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the best estimate

of the expenditure required to settle the present obligation at the Balance Sheet date.

If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

Contingent assets are not recognised. They are disclosed only when an inflow of economic benefit is probable from such assets.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

## 2.12. Revenue recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured, regardless of when the payment is being made. Revenue towards satisfaction of a performance obligation is measured at the amount of transaction price (net of variable consideration) allocated to that performance obligation. The transaction price of goods sold and services rendered is net of variable consideration on account of various discount and the schemes offered of the company as part of the contract.

The specific recognition criteria described below must also be met before revenue is recognised.

### Sale of Goods:

Revenue from the sale of goods is recognised when the significant risks and rewards of ownership of the goods have passed to the buyer.

In case of goods which are shipped subject to installation and inspection, revenue is normally recognized when the buyer accepts delivery, and installation and inspection are complete.

### Subsidy:

Subsidy on Group Concession Price under Group Concession Scheme (GCS) and Freight are recognized in accordance with the norms prescribed by the Government of India – Fertiliser Industry Co-ordination Committee, with adjustments for escalation / de-escalation in the prices of inputs and other adjustments as estimated by the management in accordance with known policy parameters in this regard.

### Rendering of services:

Revenue from sale of services is recognised as per the terms of the contract with customers based on stage of completion when the outcome of the transactions involving rendering of services can be estimated reliably.

**Interest income:**

Interest income is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable using effective interest method .

**Dividends:**

Revenue is recognised when the Company's right to receive the payment is established, which is generally when shareholders approve the dividend.

**2.13. Employee benefits****(i) Gratuity:**

In accordance with the Payment of Gratuity Act, 1972 the Company provides gratuity as a defined benefit plan, to eligible Employees. Liability with regard to gratuity is determined by an independent actuary at every Balance Sheet date using the projected unit credit method.

The Company recognizes the net obligation of a defined benefit plan in the Balance Sheet as asset or liability. Gains or losses on re-measurements are recognized in Other Comprehensive Income (OCI). Remeasurement recognised in other comprehensive income is reflected immediately in retained earnings and is not reclassified to Statement of Profit and Loss.

All expenses represented by current service cost, past service cost, if any, and net interest on the defined benefit liability / (asset) are recognized in the Statement of Profit and Loss.

**(ii) Superannuation fund and provident fund:**

Superannuation and Provident Fund are in the nature of defined contribution plans.

The Company makes monthly contribution to approved superannuation fund covered by a policy with LIC of India. The Company has no further obligation beyond monthly contribution. The obligations under the said policy are accounted for on accrual.

The Company makes monthly contribution to the Provident Fund scheme and recognizes it as an expense, in the year in which employee renders the related service. The Company's Contribution towards Provident Fund is administered and managed by an approved trust. The Company has no obligation, other than the contribution payable to the Fund.

**(iii) Compensated absences:**

Liability for compensated absence is treated as a long term liability and is covered by a policy with Life Insurance Corporation (LIC). The estimated liability at each Balance Sheet date is determined by an independent actuary using the projected unit credit method and is recognised in the accounts accordingly.

**2.14. Taxes****(i) Current income tax:**

Income tax expense is recognised in the statement of profit or loss except to the extent that it relates to items recognized directly in equity or Other Comprehensive Income (OCI), in which case the tax is also recognized in equity or Other Comprehensive Income (OCI).

The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date. Current income tax asset/liability is measured at the amount expected to be recovered from or paid to the taxation authorities.

**(ii) Deferred tax:**

Deferred tax is provided using the liability method on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the Balance Sheet date.

Deferred tax assets are recognised to the extent it is probable that future taxable profit will be available against which the deductible temporary differences and tax losses can be utilised. The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent there is no longer probable that the related tax benefit will be realized. Unrecognised deferred tax assets are re-assessed at each reporting date and are recognised to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

**2.15. Government grants**

Government grants are recognised where there is reasonable assurance that the grant will be received and all attached conditions will be complied with.

When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the related costs, for which it is intended to compensate, are expensed. When the grant relates to an asset, it is recognised as income in equal amounts over the expected useful life of the related asset.

In the case of a loan or assistance provided by government or related institutions with an interest rate below the current applicable market rate, the effect of this favourable interest is regarded as a government grant. The Grant is initially recognised and measured at fair value and subsequently measured in accordance with the recognition and measurement principles of Ind AS 109, Financial Instruments (financial liabilities). The government grant is measured as the difference between the initial carrying value of the loan and the proceeds received and recognised as income on a systematic basis over the periods the related costs, for which it is intended to compensate, are expensed.

**2.16. Leases**

The Company, at the inception of a contract, assesses whether the contract is a lease or not. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a time in exchange for a consideration. This policy has been applied to contracts existing and entered into on or after 1 April 2019.

The Company recognises a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, less any lease incentives received.

The right-of-use asset is subsequently amortised using the straight-line method from the commencement date to the end of the lease term.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the Company's incremental borrowing rate. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, if there is a change in the Company's estimate of the amount expected to be payable under a residual value guarantee, or if the Company changes its assessment of whether it will exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The Company has elected not to recognise right-of-use assets and lease liabilities for short-term leases that have a lease term of 12 months or less and leases of low-value assets. The Company recognises the lease payments associated with these leases as an expense over the lease term.

### 2.17. Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the asset in the period in which they are incurred, until such time the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they occur. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs. Interest earned on temporary investments out of specific borrowings made for qualifying assets is deducted from the borrowing costs eligible for capitalisation to those assets.

### 2.18. Research and development costs

Expenditure relating to capital items is treated as fixed assets and depreciated at applicable rates. Revenue expenditure during research period is charged to Statement of Profit and Loss in the year in which it is incurred.

### 2.19. Foreign currency transactions

The Company's Financial Statements are presented in Indian Rupees, which is its functional currency.

On initial recognition, transactions in foreign currencies entered into by the Company are recorded in the functional currency by applying to the foreign currency amount, the spot exchange rate between the functional currency and the foreign currency at the date of the transaction. Exchange differences arising on foreign exchange transactions settled during the year are recognized in the Statement of Profit and Loss.

### Measurement of foreign currency items at reporting date:

Foreign currency denominated monetary assets and liabilities remaining unsettled at the end of the year are translated into functional currency at exchange rates prevailing at the Balance Sheet date. Exchange differences arising on translation of monetary items are recognised in Statement of Profit and Loss.

Non-monetary assets and liabilities denominated in foreign currency and measured at historical cost are translated using exchange rate prevalent on the date of transaction. Non-monetary assets and liabilities denominated in foreign currency and measured at fair value are translated using the exchange rates at the date when the fair value was determined.

The gain or loss arising on translation of non-monetary items measured at fair value is treated in line with the recognition of the gain or loss on the change in fair value of the item (i.e., translation differences on items whose fair value gain or loss is recognised in OCI or Statement of Profit and Loss are also recognised in OCI or Statement of Profit and Loss, respectively).

### 2.20. Earnings per share

Basic earnings per equity share is computed by dividing the net profit for the year attributable to the Equity Shareholders by the weighted average number of equity shares outstanding during the year.

Diluted earnings per share is computed by dividing the net profit for the year, adjusted for the effects of dilutive potential equity shares, attributable to the Equity Shareholders by the weighted average number of the equity shares and dilutive potential equity shares outstanding during the year except where the results are anti-dilutive.

### 2.21. Investments

Investments are classified as Non Current and Current. Non Current Investments are carried at cost less provision for other than temporary diminution, if any, in value of such investments. Current investments are carried at lower of cost and fair value.

### 2.22. Exceptional Items

Exceptional items of income and expense within profit or loss from ordinary activities are of such size, nature or incidence that their disclosure is relevant to explain the performance of the enterprise for the period, the nature and amount of such items are disclosed separately as exceptional items.

**4.1. JESCO went into Voluntary Liquidation under IBC with effect from April 25, 2022.**

After issuance of GO by Govt of Karnataka (KIADB) cancelling the allocation of land and after prolonged litigation (due to lack of cash flows to support operations and financial creditors), JESCO (a subsidiary of NFCL) with loans went into Voluntary Liquidation under IBC with effect from April 25, 2022. As per IND AS accounting standards shares of JESCO (part of non current assets) were accordingly fully provided for. The liquidator after completing all formalities of voluntary liquidation proceedings had filed the petition for dissolution of JESCO on 01.10.2023 with NCLT, Bangalore.

Subsequently, the company has been informed by JESCO and noted by the Board of Directors of NFCL on May 20, 2024, that the Liquidator of JESCO is of the opinion that the JESCO will not be able to pay its debts in full from the proceeds of assets to be sold in the liquidation and accordingly, the liquidator has filed a Memo for withdrawal from Voluntary Liquidation Proceedings and the same is dismissed By NCLT Bangalore as withdrawn vide order dated 16/04/2024. The financials of the subsidiary for the Quarter / Year ended 31st March 2024, received from JESCO have been consolidated. Sale of non core assets (non currents assets other than core assets) is part of the recovery process by secured lender for OTS.

These shares were pledged in favour of Banks / Financial Institutions for the term loans availed by the Company. The loans have been repaid in full, awaiting release of pledge of shares.

The Company received on 3rd April 2023 a letter dated 31st March 2023, copying to all the Lenders, from Assets Care & Reconstruction Enterprise Ltd (ACRE) communicating that the Assignment of Debt by all Consortium Lenders to ACRE (in its capacity as the trustee of the ACRE-112-TRUST) under section 5 of the SARFAESI Act. There was no communication to the Company from the Lenders about the assignment of their loans / credit facilities / interest etc., as stated above to the ACRE-112-TRUST by 31.03.2023. Without prejudice to the rights of the company and guarantors, the company has accordingly recorded the communication from ACRE-112-TRUST.

**14.6 Sales Tax Deferral Loan:**

The Government of Andhra Pradesh sanctioned Sales Tax deferral facility to the Company with a final eligibility of Rs.1,01,746.56 lakhs, subject to the restriction of loan to the actual Sales Tax collected on the sale of the products manufactured by the Company during the period of 14 years from 19.03.1998 to 18.03.2012. The Sales Tax deferred in a year should be repaid at the end of 14th year without interest. Repayment of this loan was commenced on March 19, 2012. The deferred Sales Tax outstanding as on March 31,2024 is Rs. 2,343.49 Lakhs (Previous Year Rs.3,354.48Lakhs). As at the balance sheet date, the Company has defaulted in payment of instalment due on 19.03.2024 amounting to Rs. 1000Lakhs for a period of 13days (Previous year Rs 837.16 lakhs for a period of 13 days).

**14.7** The company is in default of principal and interest during the year on the borrowings from various lenders on account of non implementation of CAP. To overcome the financial stress caused due to disruption of production and losses, the company approached its lenders for a Corrective Action Plan (CAP) and the lenders formed Joint Lenders Forum (JLF) in 2015 and assessed Rs. 3,05,000 lakhs (Rs.85,000 lakhs under Fund Based & Rs.2,20,000 lakhs under Non-Fund Based) and Rs.80,000 lakhs of Working Capital Term Loan under CAP to shore up the working capital and to enable the company to run. This funding for rectification of account is called Corrective Action Plan 2015 (CAP). Due to non sanction / release of assessed funds by the lenders (non implementation of CAP), the company's account after the GAIL Pipe Line accident could not be rectified in 2015-16 and went into severe financial stress increasing indebtedness and losses resulting in defaults. Upgrading of account without releasing of the assessed funds for rectification of account (CAP) is in violation of RBI CAP regulations of 2014 and 2015, resulting in the account becoming NPA in 2015 itself as per RBI regulations instead of 2018 after CAP implementation as being claimed by Banks. The debt in the books (CAP loans) are disputed and are sub-judice. Pending resolution of the CAP loans and disputes (working capital and term loans in the books of the Company), the Company has been accounting for the interest / penal interest during the year on the borrowings as per the rate of interest mentioned in the sanction letters and as per CAP and other loan arrangements. This is not confirmation of dues. Adjustments, if any, for the principal, interest and penal interest accounted will be dealt on the outcome of the Debt Resolution Plan agreed by the company and lenders.

The lenders (Banks) of the company have not implemented the Corrective Action Plan (CAP) approved by them in the Joint Lenders Forum (JLF) meeting held in 2015. Though the company represented the matter to the lenders for necessary corrective action, the same has not been rectified till date. As a result, the company filed cases against the lenders in the Hon'ble High Court of Telangana, which has restrained the lenders from taking any coercive action against the company. Further, there is no clear information on when the loans were declared NPAs by the lenders. Due to these disputes, the lenders have not been sending the interest demands and the loan statements/ confirmation of balances to the company since 6 years. The company has also been disclosing CAP debt disputes since 2018. In this background, the company has been accounting the interest on the loans as per the terms of CAP funding sanction letters with a qualification of dispute and furnishing the default details as available with it in the financial statements. This is not confirmation of dues.

Without prejudice to the rights of the company and guarantors, the company has accordingly recorded the communication from ACRE-112-TRUST.



The 100% cash margin of Rs. 8,550.00 lakhs deposited for providing Bank Guarantee for gas supplies, has been adjusted by the lenders unilaterally without informing or taking approval from the company Rs 1,723.78 lakhs and Rs 6,826.22 lakhs against outstanding during FY 2021-22 and FY 2020-21 respectively along with interest. While the company has reduced the amount from the outstanding loans, the adjustment and the outstanding have been disputed by the company. Details of appropriation of the margin money adjusted Bank-wise were also not made available to the Company.

During the year the above Bank Guarantee issued to GAIL had been invoked and honoured by IDBI Bank Limited. Accordingly the balances in the Cash Credit account of IDBI Bank Limited has been increased by Rs. 8,550.00 Lakhs.

(c) As at the end of the year, the Company has a total unabsorbed loss and depreciation of Rs. 1,45,441.52 Lakhs (March 31, 2023: Rs1,14,385.38 Lakhs). Deferred tax asset in respect of unabsorbed depreciation and carried forward loss under the Tax Laws are recognised only if there is reasonable certainty that there will be sufficient future taxable income available to realise such assets.

**29. Material Uncertainty on the Holding Company's ability to continue as a going concern and appropriateness of use of going concern basis of accounting in preparation of financial statements :**

The Company is operating in a regulated environment under the Essential Commodities Act, 1955, supported by Government Subsidy. On account of an accident in the GAIL Pipeline which supplies Gas to the company during 2014, the production of the company was disrupted for long time and as a result, the company suffered losses. To overcome the financial stress caused due to disruption of production and losses, the company approached its lenders for a Corrective Action Plan (CAP) and the lenders formed Joint Lenders Forum (JLF) in 2015 and assessed Rs. 3050 Crs (Rs.850 Cr under Fund Based + Rs.2200 Cr. Under Non-Fund Based) and Rs.800 Cr. Working Capital Term Loan under CAP to shore up the working capital and to enable the company to run. This funding for rectification of account is called Corrective Action Plan 2015 (CAP). Due to lack of assessed funds from lenders (non-implementation of CAP), the company's account after the GAIL Pipe Line accident could not be rectified in 2015-16 and went into severe financial stress increasing indebtedness and losses resulting in defaults in 2018. Upgrading of account without releasing of the assessed funds for rectification of account (CAP) is in violation of RBI CAP regulations of 2014 and 2015, resulting in the account becoming NPA in 2015 itself as per RBI regulations instead of 2018 after CAP implementation as being claimed by Banks. The company has been reporting the disputes on CAP debt (Working capital Term Loans and Working Capital Loans in the books of the company) to the lenders and in the annual reports. The debt in the books (CAP loans) are disputed and are sub-judice.

The lenders approved 'Holding on Operations' (HOO) from December 2018 to amicably resolve the debt issues with the company in the interest of all stakeholders (valid till June 30, 2024). Due to inadequate working capital, financial stress and continued losses on account of stoppage of production of the plants during 2018, without prejudice to the interest, the company had taken up long-term financial Resolution Plan (RP) with its Lenders. The lenders held series of Joint Lenders Meetings (JLM) for consideration and suggestions on the RP. Consequent to the lenders meetings, a resolution plan was unanimously approved by the lenders in March 2020, which amongst other things, include segregation of debt into sustainable and unsustainable, reduction in the rate of interest,

infusion of fresh equity and sanction of additional debt etc. However, post conclusion of the Resolution Plan, the lenders made arbitrary changes in the said RP on 4th June 2020. The company has filed a Writ Petition in the Hon'ble High court of Telangana, on the arbitrary actions of the lenders against the RBI Regulations. The Hon'ble High Court granted stay against any proceedings that may be initiated by the lenders against the company until further orders and the matter is awaiting final orders. Further, the company had filed contempt cases against 3 lenders who have filed petitions under IBC in violation of the above stay orders of High Court and the matter is disposed of without cost by the court.

In view of operating only one plant (out of the two plants) due to lack of working capital, the losses continued, resulting in substantial erosion of net worth and the company faced liquidity issues. As a result of continuous losses, the company's financial position has become very weak, and it is unable to meet its commitments to the financial and other creditors including statutory dues on the due dates. Due to default in paying the instalments and interest, the lenders have declared the loans to the company as Non-Performing Assets in 2018 (instead of 2015) and the status is continuing till date. As a result of treating the loans as NPAs by the lenders, all the borrowings, with a qualification of dispute, have been recorded as current liabilities in the Books / Financial statements of the company, leading to the situation that the current liabilities are in excess of current assets in the last four financial years. As at the year end, the company's current liabilities exceeded current assets by Rs. 3,96,414.20 Lakhs.

All the above events / conditions indicate material uncertainty which cast a significant doubt on the company's ability to continue as a Going Concern.

However, the company's management assessed the company's ability to continue as a Going Concern in which the company considered the following events / conditions, which individually / collectively have contributed in concluding that use of Going Concern basis of accounting is appropriate for this year.

- The company is continuously pursuing with the lenders for resolution of all the disputes amicably and for an acceptable resolution plan to make the company functional successfully.
- Despite the weak financial condition of the company, the company continued the production and supply of goods and able to produce Urea during the year is 13.10 LMT as against 11.20 LMT in 2022-23
- The lenders, to enable the company to generate the Cash flows, have approved the facility of 'Holding on Operations' (HOO) in December 2018 and have been extending the same from time to time, in the interest of all the stakeholders. The last extension is valid till June 30, 2024.
- The management has no intention to close the plants.
- There is no change in law, regulation or government policy which is adversely affecting the company.
- All the Key management personnel in all the operating areas are continuing and no loss of personnel at any level in the company.
- The Product of the company is administered under the essential commodities Act 1955. The production, distribution, pricing are controlled by the Department of Fertilizers, Government of India. As such, there is no loss of market / customers for the company's product.
- With such a weak financial position, the company, during the year 2023-24 could still sell 13.08 lakh MT as against 11.20 lakh MT of Urea in 2022-23
- The major supplier of Gas, which is the Raw Material and Power and Fuel, M/s GAIL (India) Limited continue to supply Gas under the Gas Purchase and Sale Agreement which is effective from 07th July 2021 and is valid till 06th July 2026 under liberal terms of payment.
- The Company maintained good relationship with the personnel at all levels and there are no issues with the Labour.
- The company has been paying all the statutory dues, though with some delay and complying with all the applicable Laws.
- There is no entry of fresh competitors to the product of the company despite the fact that the India's requirement of Urea is about 36 Million Tons which is far in excess of production capacity of the country at 28 Million Tons and the Government of India continue to import Urea at a very high price. Hence, there is no issue of lack of marketability or competition for the product of the company which is covered under the administered pricing mechanism of the Government.
- There is no under insurance for the assets of the company in the events of major catastrophe.
- The company's industry is a major capital-intensive Industry with highly regulated operations. The Government cannot afford to close the operations of the company as the demand for the product is huge and any shortage would affect the food security of the country.
- The company is exploring various avenues to resolve the financial crisis and sought the help of the Government of India for revision of energy norms and hoping for positive response from the Government.



- The Government of India has made an arrangement wherein the GAIL would supply the required Gas for which part payment only will be made by the company and the lenders also would get part payment of their dues.
- The company is confident of running the operations as the government has allowed the Gas supply to continue till 30.09.2024 vide their Office Memorandum dated 8th March 2024.

In the light of all the above, the Management concluded that the company is a Going Concern and accordingly use of the Going Concern basis of accounting in the preparation of the financial statements for the year ended 31, March 2024 is appropriate.

**30.** The Company has received a demand notice dated 20th May 2023 U/s 13(2) of the SARFAESI Act from Lender (Secured Creditor) to repay total outstanding dues of Rs 3,344.37 Crs, failing which Lender (Secured Creditor) will take appropriate action in accordance with the Law. The Company has replied to the said notice on 17th July 2023 explaining the disputes with the lenders and matter is being sub-judice and sought time for submission of Debt Resolution plan/ OTS. In response to the company reply, the Lender (Secured Creditor) reverted on 25th July 2023 disputing objections raised by the company and advised the company to expedite submission of Debt Resolution Plan/ OTS.

Accordingly, the Board of Directors at their meeting held 14th August 2023 and members in AGM held on 15th September 2023 approved the proposal of slump sale transaction of Ammonia / Urea and MI businesses along with related assets and liabilities, subject to fulfilment of Conditions Precedents (CP's), Sale of non-core assets of the company and Debt Resolution / OTS along with funding.

Subsequently, the Board of Directors at their Meeting held on October 09, 2023, have noted 1) order of the Hon'ble NCLAT, Chennai, dated October 05, 2023, setting aside the order dated August 27, 2021, passed by Hon'ble NCLT, Hyderabad Bench, 2) the CP's needed for Slump Sale transaction, 3) Sale of non-core assets of the company and 4) Debt Resolution / OTS. Further, the Company is working towards fulfilment of CPs.

ACRE subsequently taken symbolic possession of the scheduled assets of the Company in its favour on October 12, 2023.

The company while continuing to work and was optimistic on fulfilling the critical CPs for the closure of the slump sale transaction has formally applied to ACRE for OTS as approved by the Board and Shareholders (without any prejudice to the rights of NFCL regards to ongoing debt disputes). ACRE on the 31st of October 2023 replied to the company's OTS proposal that the Settlement Proposal submitted to ACRE is not binding and tentative on fulfilment on CPs (which was tentative amongst other things energy claim approval/disbursal by Govt) and therefore was unable to consider and/or appraise the Settlement Proposal and communicated that it would continuing to pursue the SARFAESI process.

Given the uncertainties of energy claim approval/reimbursement by GOI, the consequences of SARFAESI process in case the lender is unable to recover the total amounts due and to ensure an amicable debt resolution to ensure continuation of operation post debt resolution The Board of Directors on December 24, 2023, while asking the company to continue and speed up closure of CPs for the approved Slump Sale transaction, without prejudice, considered and approved the company to engage and work with ACRE on a One Time Settlement (OTS) under SARFAESI/directly (or a combination of both) if any in parallel to the current efforts on the Slump Sale transaction to amicably settle debt.

The OTS amount as benchmark provided by the Board for negotiations with ACRE on December 24, 2023, was the amount equal to or lower than the amount realised from sale of core and non-core assets and lower than the amounts due to ACRE. In terms of the mandate of the Board of Directors the company engaged with and vide letter agreement dated 12th January agreed to cooperate with ACRE, without prejudice to the rights of the company and guarantors for a One Time Settlement (OTS) under SARFAESI/directly. The OTS amount is the amount recovered by ACRE under SARFAESI through sale of core assets plus Rs 200 Crores through sale of non-core assets (non-current assets of the company). While the current assets are also fully charged to the secured creditor in case the OTS with ACRE is successful the current assets including energy claims would be primarily utilised by the company to settle operating creditors dues.

The Board of Directors on January 26, 2024, took note of the updates on slump sale process, SARFAESI process by Assets Care and Reconstruction Enterprise Limited (ACRE). ACRE, as part of the SARFAESI process after taking symbolic possession of assets, has issued a Public Notice for physical auction for sale of Movable and immovable properties of the Company under SARFAESI Act, 2002, vide email to the company dated January 17, 2024. ACRE in their public auction notice stated that as of December 2023 the company owed ACRE around Rs 3858 Crs including interest.

The Company has received an email communication dated April 17, 2024, from ACRE that it has received an offer from a bidder above the reserve price and the bidder has submitted an upfront amount of 25% of the purchase consideration, in line with the terms of the sale.

It was further stated in the said mail, that consequent to the issue of sale confirmation to the highest bidder by ACRE, in terms of the provisions of SARFAESI Act, 2002, read with rules made thereunder, a sale certificate shall be executed in favour of the successful bidder on payment of the balance consideration in accordance with the terms of SARFAESI Act, 2002 and the rules.

ACRE vide email dated April 24, 2024, asked the company to deposit the proceeds/advances received from the sale of non-core assets as mandated by ACRE into fixed deposits lien marked in favour of ACRE. The sale of non-core assets shall take effect along with or after receipt of sale consideration from the sale of Core Assets under SARFAESI Act, 2022, by ACRE. The borrower/NFCL has since deposited the proceeds/advances it received from the sale into the lien marked Fixed Deposits as mandated by ACRE.

Considering the uncertainties and final outcome of the result of the actions taken as discussed above by ACRE for sale of core and non-core assets, further taking into account of the future plans of the company for continuation of business operations post debt settlement and given the above background on its efforts for OTS as Debt Resolution, the management is of the opinion that the preparation of the financial statements for the year ended 31st March 2024 as a Going Concern basis is still appropriate.

ACRE has taken symbolic possession to enable them to start the auction process, but has not imposed any restrictions on the operations of the company as on the date. There is no discontinuance of plant operations and usual operations are being carried out by the company. Revenue, both, sales from Urea & Micro Irrigation and subsidy on Urea are being generated in the normal course of business. Subsidy claims are being raised in the name of the company as per the procedures laid by the Government and Subsidy amounts are also received / receivable in the name of the company. Considering the above facts and that the financial statements are prepared on a going concern basis, the Property, Plant and Equipment are continued to be disclosed as non-current operating assets at its carrying value.

### 31. Impairment of Property Plant & Equipment

Basis the economic indicators on performance of Plant and Machinery, buildings attached there to have been put to test for impairment as of 31st March 2024 by the management and perceive that there is no further impairment loss required to be recorded as there are no changes in the conditions prevalent as on the date of this balance sheet compared to the Balance Sheet as at 31 March 2023 (Previous year impairment loss of Rs. 67,519.40 Lakhs accounted for Plant & Machinery located at Kakinada Rs.63,224.23 lakhs, Micro Irrigation Plants at Nacharam Rs. 379.01 Lakhs, Sadasivpet Rs. 30.98 Lakhs and Halol Rs. 203.18 Lakhs and Buildings of Urea plant at Kakinada Rs. 3,509.40 lakhs and Corporate Office Rs. 172.60 Lakhs).

Impairment test of property (land) was carried out as of 30th June 2023 during the year and recorded an impairment loss of Rs. 63,407.20 Lakhs as per the Registered Valuer's Report dated 12th August 2023. The management is of the opinion that there is no further impairment of land as at 31.03.2024.

**32.1 (a)** In relation to some of the contracts for purchase of fertilisers, an international Arbitration Award has been passed against the Holding Company in September 2016 for USD 14,398,188 and GBP 690,630 and interest as applicable apart from costs based on a claim filed by one of the Suppliers of Fertilizers to the Company.

The Company is of the view that the Award has been obtained based on documents tampered with and mis-representations of facts by said supplier. The Company is contesting the enforcement of the Award in the Courts in India and has also filed a Criminal Complaint before the Metropolitan Magistrate of Hyderabad against the supplier and its officials. Judgement came in favour of the Company, aggrieved by the Judgement, supplier made an appeal to the Supreme Court of India. Matter yet to be heard.

(b) The Company entered into two Contracts dated December 15, 2012 on Early Works, Offshore and Onshore towards certain engineering drawings to be utilised towards its plant for third ammonia and urea project on conditions that balance amounts payable only upon (a) the announcement of a fertilizer policy and (b) that the fertilizer policy being found favorable for the Project of the Company. The Company could not proceed further as the policy was not conducive for the project.

The service provider raised invoices for the balance amounts claiming that the work carried out was per contract. As the amounts were not paid the service provider invoked arbitration. The arbitral Tribunal passed an award on October 23, 2017 for USD 877,500, GBP 52,314, EUR 455,000 and INR 221.39 Lakhs and interest as applicable apart from costs in favour of the claimant. NFCL challenged the Awards by filing two petitions separately for each case under section 34 of Arbitration & Conciliation Act as the tribunal ignored vital evidence such as Govt communication dt 9th May 2013 where in the industries we're asked not to proceed further without necessary approvals from Govt, amongst other grounds. Matter yet to be listed for hearing.

Based on the current legal progress, the management has provided for 25% of the claim made on the Offshore contract and deposited 15% of the onshore contract value with the court. The Company continues to proceed legally and hence the balance claims have been disclosed as contingent liabilities.

**32.2** The Holding Company has been using the Nagarjuna Brand / Trademarks for its urea and other products under a license agreement Dt 29/01/1998 with the grantor, a related party. The company, during the year 2021-22, received a claim from the grantor asserting its right for royalty for the period from 29/01/1998 to 31/12/2021. The said claim is being negotiated with the grantor for settlement.

### **32.3 Cases / Petitions filed against the company in NCLT / Courts / Other Tribunals:**

Few other creditors have filed petitions against the company in various Courts / Tribunals for recovery of dues / claims for compensation for their services / supplies and all these matters are at various stages in the respective courts. The legal counsel confirmed that the cases / petitions filed against the company are not tenable and are of the view that these cases may not have any impact on the financials of the company.

The management is of the view that the pending litigations will not have any adverse impact on the financial position of the company as at the year end.

**32.4** Amlika Mercantile Private Limited (AMPL), Core Promoter of the Company had preferred an appeal before Hon'ble National Company Law Appellate Tribunal (NCLAT), Chennai, against the Order' dated 27.08.2021, passed by the 'National Company Law Tribunal', Hyderabad Bench, admitting the Nagarjuna Fertilizers and Chemicals Limited (NFCL) into Corporate Insolvency Resolution Process (CIRP) under Insolvency and Bankruptcy Code, 2016.

Basis the appeal of AMPL, Hon'ble NCLAT, Chennai, vide order dated October 05, 2023, has allowed the appeal by setting aside the impugned order dated August 27, 2021, passed by Hon'ble NCLT, Hyderabad Bench. Thereby, the Company exited CIRP under IBC, 2016 effective October 05, 2023.

AMPL has claims the legal expenses for the NCLAT appeal filed on behalf of the Company and the company is liable to reimburse the legal expenses to AMPL.

### 37. Financial risk management objectives and policies

#### Financial Risk Management Framework

The Company's principal financial liabilities, other than derivatives, comprise loans and borrowings, trade and other payables. The main purpose of these financial liabilities is to finance the Company's operations. The Company's principal financial assets include loans and advances, trade and other receivables, and cash and cash equivalents that derive directly from its operations.

The Company is exposed primarily to Credit Risk, Liquidity Risk and Market risk (fluctuations in foreign currency exchange rates and interest rate), which may adversely impact the fair value of its financial instruments. The Company's senior management oversees the management of these risks. The Company assesses the unpredictability of the financial environment and seeks to mitigate potential adverse effects on the financial performance of the Company based on the policies agreed by the Company's senior management. The same are summarised below:

#### A. Credit Risk

Credit risk is the risk that counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. Credit risk encompasses of both, the direct risk of default and the risk of deterioration of creditworthiness as well as concentration of risks. The Company is exposed to credit risk from its operating activities (primarily trade receivables) and from its financing activities, including deposits with banks and financial institutions, foreign exchange transactions and other financial instruments. Financial instruments that are subject to concentrations of credit risk principally consist of trade receivables, investments, derivative financial instruments, cash and cash equivalents, bank deposits and other financial assets. None of the financial instruments of the Company result in material concentration of credit risk except trade receivables where more than 50% is due from Government of India and various State Governments. The same are realisable in due course.

To manage this, the Company periodically assesses the financial reliability of customers, taking into account the financial condition, current economic trends, and analysis of historical bad debts and ageing of accounts receivable. Individual risk limits are set accordingly.

The company considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk the company compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers reasonable and supportive forwarding-looking information such as :

- (i) Actual or expected significant adverse changes in business,
- (ii) Actual or expected significant changes in the operating results of the counterparty,
- (iii) Financial or economic conditions that are expected to cause a significant change to the counterparty's ability to meet its obligations,
- (iv) Significant increases in credit risk on other financial instruments of the same counterparty,
- (v) Significant changes in the value of the collateral supporting the obligation or in the quality of third-party guarantees or credit enhancements.

Financial assets are written off when there is no reasonable expectation of recovery, such as a debtor failing to engage in a repayment plan with the company. The company categorises a loan or receivable for write off when a debtor fails to make contractual payments greater than 2 years past due. Where loans or receivables have been written off, the Company continues to engage in enforcement activity to attempt to recover the receivable due. Where recoveries are made, these are recognised in profit or loss.

**Excessive risk concentration**

Concentrations arise when a number of counterparties are engaged in similar business activities, or activities in the same geographical region, or have economic features that would cause their ability to meet contractual obligations to be similarly affected by changes in economic, political or other conditions. Concentrations indicate the relative sensitivity of the Company's performance to developments affecting a particular industry.

In order to avoid excessive concentrations of risk, the Company's policies and procedures include specific guidelines to focus on the maintenance of a diversified portfolio. Identified concentrations of credit risks are controlled and managed accordingly.

**C. Market Risk**

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk for the entity comprises two types of risk: interest rate risk and currency risk. - The sensitivity of the relevant profit or loss item is the effect of the assumed changes in respective market risks. This is based on the financial assets and financial liabilities held at March 31, 2024 and March 31, 2023.

**Interest rate risk**

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. Under the Composite Scheme of Arrangement and Amalgamation approved by the Hon'ble High Courts at Bombay and Andhra Pradesh in FY 2011-12, the Company was vested with the land of 736.13 acres situated in Nellore, AP together with buildings constructed therein, which was actually purchased from Nagarjuna Aqua Exports Limited (NAEL) way back in 2001 for a consideration of Rs. 317 Lakhs (towards land). Of these lands, 340.11 acres were not registered in the name of the company as the same were found to be defective titles.

Despite the Company's continuous persuasion, these lands could not be registered in the name of the company as title of all these lands is defective and the original owners who sold the land are not traceable.

Based on the legal opinion wherein it was opined that as these lands are in excess of the limit specified under the Andhra Pradesh Land Reforms (Ceiling on Agricultural Holdings) Act 1973, it was concluded that these lands are not transferable on to the name of the Company. Accordingly, considering the restriction under the applicable Law to hold these lands, the passage of over two decades of time since original acquisition, non-traceability of original owners who sold these lands and defective titles, the Company has impaired the entire carried value of these lands during FY 2020-21, along with some other lands, aggregating to Rs 11,777 lakhs. (Refer Note no: 3).

# INDEPENDENT AUDITOR'S REPORT

To the Members of **Nagarjuna Fertilizers and Chemicals Limited**

**Report on the Audit of the Consolidated Financial Statements**

## I. Qualified Opinion:

We have audited the accompanying Consolidated Financial Statements of Nagarjuna Fertilizers and Chemicals Limited ("the Holding Company") and its subsidiary ("the Holding Company" and its subsidiary together referred to as "the Group") and its associate, which comprise the consolidated Balance Sheet as at March 31st, 2024, the consolidated Statement of Profit and Loss (including other comprehensive Income), the consolidated Statement of Changes in Equity and the consolidated Statement of Cash Flows for the year then ended, and notes to the consolidated financial statements, including a summary of the Significant Accounting Policies and other Explanatory Information ("the Consolidated Financial Statements").

The Consolidated Financial statements includes the following entities

- a) Nagarjuna Fertilizers and Chemicals Limited (Holding)
- b) Jaiprakash Engineering and Steel Company Limited (Subsidiary)
- c) KVK Raju International Leadership Limited (Associate)

In our opinion and to the best of our information and according to the explanations given to us and based on the consideration of the reports of the other auditor on separate financial statements of subsidiary, except for the possible effects of the matters described in the Basis for Qualified opinion section of our report, the aforesaid Consolidated Financial Statements give the information required by the Companies Act, 2013, as amended ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the State of Affairs of the Group as at March 31st, 2024, its Loss including other comprehensive Income, changes in Equity and its cash flows for the year then ended.

## II. Basis for Qualified Opinion

We refer to Note No: 14 & 26 to "the Consolidated Financial Statements" wherein "the Holding Company" Stated that the lenders (Banks) have not implemented the Corrective Action Plan (CAP) approved by them in the Joint Lenders Forum (JLF) meeting held in 2015 and though "the Holding Company" represented the matter to the lenders for necessary corrective action, the same has not been rectified till date. As a result, "the Holding Company" filed cases against the lenders in the Hon'ble High Court of Telangana, which has restrained the lenders from taking any coercive action against the company. Currently in this regard Writ Appeal 708/2022, is pending before Telangana High Court. Further, there is no clear information on when the loans were declared as NPAs by the lenders. Due to these disputes, the lenders have not been sending the interest demands and the loan statements/ confirmation of balances to "the Holding Company" since 6 years. In this background "the Holding Company" has been accounting the interest on

the loans as per the terms of CAP funding sanction letters with a qualification of dispute and furnishing the default details as available with it in the consolidated financial statements.

We refer to Note No: 14.1 to "the Consolidated Financial Statements" wherein "the Holding Company" stated that on 3rd April 2023, it has received a letter dated 31st March 2023, copying to all the Lenders, from Assets Care & Reconstruction Enterprise Ltd (ACRE) communicating the Assignment of Debt by all Consortium Lenders to ACRE (in its capacity as the trustee of the ACRE-112-TRUST) under section 5 of the SAR-FAESI Act. There was no communication to the Company from the Lenders about the assignment of their loans / credit facilities / interest etc., as stated above to the ACRE-112-TRUST by 31.03.2023. Without prejudice to the rights of the company and guarantors, the company has accordingly recorded the communication from ACRE-112-TRUST.

In the absence of independent audit evidence from the lenders on the date(s) from which the loan accounts have been classified as NPAs, outstanding amount of borrowings at the end of every year, interest accrued thereon, period and amount of default in repayment of loans and payment of interest thereon disclosed in "the Consolidated Financial Statements" and continuing the outstanding borrowings with the existing lenders (Banks), we are unable to express an opinion whether any adjustments are required to be made to the outstanding balance of borrowings as at the year end, interest on the borrowings charged to the consolidated statement of profit and loss for the year and the period and amount of default in repayment of principal and payment of interest disclosed in "the Consolidated Financial Statements".

We conducted our audit of the financial statements of "the Group" in accordance with the Standards on Auditing specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of Financial Statements of "the Group" section of our report. We are independent of "the Group" in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the ethical requirements that are relevant to our audit of the financial statements of "the Group" under the provisions of the Act and the Rules made thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion on the financial statements of "the Group"

## III. Material uncertainty related to going Concern:

1. We Refer to Note No.29 to "the Consolidated Financial Statements", wherein "the Holding Company" stated that it has been incurring recurring losses resulting in complete erosion of net worth and the company is facing liquidity issues. As at the Quarter/ Year ended 31st March, 2024, the Company's current liabilities exceeded the current assets by Rs.3,96,547.86 Lakhs.

"The Holding Company", during the year under review, continued to default in discharging its obligations for re-



payment of Loans and settlement of other financial and non-financial liabilities including statutory dues on the due dates. The lenders have been treating the loans to "the Holding Company" as Non-Performing Assets since last six years.

We Refer to Note No.30 to "the Consolidated Financial Statement" wherein "the Holding Company" stated that it has received a demand notice dated 20th May 2023 u/s 13(2) of the SARFAESI Act from ACRE to repay total outstanding dues of Rs 3,344.37crores. ACRE, as part of the SARFAESI process after taking symbolic possession of assets (on October 12, 2023), has issued a Public Notice for auction of Sale of Movable and Immovable properties of the Company under SARFAESI Act, 2002, vide email to the company dated January 17,2024. ACRE in their public auction notice stated that as of December 2023 "the Holding Company" owed ACRE around Rs. 3858 Crs including interest. "the Holding Company" has received an email communication dated April 17, 2024, from ACRE that it has received an offer from a bidder above the reserve price and the bidder has submitted an upfront amount of 25% of the purchase consideration, in line with the terms of the sale. It was further stated in the said mail, that consequent to the issue of sale confirmation to the highest bidder by ACRE, a sale certificate shall be executed in favour of the successful bidder on payment of the balance consideration.

The above events and conditions indicate material uncertainty which cast a significant doubt on "the Group" ability to continue as a going concern, and therefore may be unable to realize its assets and discharge its liabilities including potential liabilities in the normal course of its business. The ability of "the Group" to continue as going concern is solely dependent on the successful restructuring/resolution plans and raising of the required additional funds.

However, the management is of the opinion that the preparation of the financial statements of "the Group" for the quarter and year ended 31st March, 2024 as going concern is still appropriate considering the uncertainties and final outcome of the results of the actions taken as discussed above by ACRE for sale of core and non-core assets, further taking of the future plans of the company for continuation of business operations and given the above background on its effort for OTS as Debt Resolution.

2. We Further refer to Note 30, that ACRE has taken symbolic possession to enable them to start auction process, but has not imposed any restrictions on the plant operations as on the date. There is no discontinuance of plant operations and usual operations are being carried out by the company. Revenue, both, sales from Urea & Micro Irrigation and subsidy on Urea are being generated in normal course of business. subsidy claims are being raised in the name of the company as per the procedures laid by the Government and subsidy amounts are also received / receivable in the name of the company. Considering the above facts and that the financial are prepared on a going concern basis, the Property, Plant and Equipment are continued to be disclosed as Non-Current operating assets at its carrying value.

**Our conclusion is not modified in respect of this matter.**

#### IV. Emphasis of Matter Paragraph:

We refer to the following notes to "the Consolidated Financial Statement":

- a) Note No.2: Initially the wholly owned subsidiary, JAIPRAKASH ENGINEERING AND STEEL COMPANY LIMITED (JESCO), went into Voluntary Liquidation under IBC with effect from 25th April, 2022 and later the Liquidator has filed a memo for withdrawal of Voluntary Liquidation proceedings on 05.04.2024 and the same is been dismissed by NCLT, Bangalore. The financials of the subsidiary for the quarter/ year ended 31st March 2024, have been considered into consolidation.
- b) Note No.20.1: "The Holding Company" has recognised Income from Urea Operations, Income towards freight subsidy, Reimbursement claims towards additional fixed cost, Input escalation/de-escalation during the quarter in terms of new Urea policy (NUP)-2015 and Gas Pooling Policy for Fertilizer (Urea) Sector. Adjustments, if any, required will be considered on notification of final prices
- c) Note No.31: The Plant and Machinery, buildings attached there to have been put to test for impairment as of 31st March 2024 and management perceive that there is no further impairment loss required to be recorded.  
  
Impairment test of property (land) was carried out as of 30th June 2023 during the year and recorded an impairment loss of Rs. 63,407.20 Lakhs as per the Registered Valuer's Report dated 12th August 2023. The management is of the opinion that there is no further impairment of land as at 31.03.2024.
- d) Note No.32.1: The claims as per the International Arbitration Awards passed against "the Holding Company" in September 2016 and October 2017, aggregating to USD 15,275,688, GBP 742,944 and EUR 455,000 and INR 221.39 Lakhs (equivalent Aggregate amount of Rs. 14,150.09 Lakhs) and interest thereon as applicable apart from costs, are continued to be shown as a contingent liability since the matter being sub-judice.
- e) Note No.32.2: Claim from a related party asserting its right for Royalty for the period from 29.01.1998 onwards, is being negotiated with the granter for settlement.
- f) Note No.32.4: Hon'ble NCLT admitted a petition filed by an operational creditor to initiate the CIRP against "the Holding Company" under the provisions of the IBC 2016, Amlika Mercantile Private Ltd (One the of Promoter of "the Holding Company") appealed against the order of Hon'ble NCLT. The NCLAT has set aside the this CIRP proceedings under IBC and currently "the Holding Company" is out of CIRP. AMPL has claims the legal expenses for the NCLAT appeal filed on behalf of "the Holding Company" and "the Holding Company" is liable to reimburse the legal expenses to AMPL.

**Our conclusion is not modified in respect of the above matters.**

adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of "The Group" and its Associates and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of "the Consolidated Financial Statements" that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing “the Consolidated Financial Statements”, management of “the Holding Company” is responsible for assessing “the Group’s” ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Group or to cease operations, or has no realistic alternative but to do so.

The respective Board of Directors of “the Holding Company” are responsible for overseeing the financial reporting process of “the Group”

## VII. Auditor’s Responsibility for the audit of the Consolidated Ind AS Financial Statements

Our responsibility is to conduct an audit of “the Group’s” “Consolidated Ind AS Financial Statements” in accordance with Standards on Auditing and to issue an auditor’s report. However, because of the matter described in the “Basis of Qualified Opinion” section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these “Consolidated Ind AS Financial Statements”.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the Consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal financial controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under section 143(3)(i) of the Act, we are also responsible for expressing our opinion on whether the Group has adequate internal financial controls system in place and the operating effectiveness of such controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management’s use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on “the Group’s” ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor’s report to the related disclosures in the Consolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor’s report. However, future events or conditions may cause “the group” to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

Materiality is the magnitude of misstatements in the Consolidated Ind AS Financial Statements that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the financial statements may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the “Consolidated Financial Statements” of the current period and are therefore the key audit matters. We describe these matters in our auditor’s report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

## VIII. Report on Other Legal and Regulatory Requirements:

1. As required by Section 143(3) of the Act, based on our audit, we report that:
  - a) We have sought and except for the matters described in the Basis for Qualified Opinion Section, obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit of the accompanying “Consolidated Financial Statements”;
  - b) Except for the possible effects of the matters described in the Basis for Qualified Opinion Section, in our opinion, proper books of account as required by law have been kept by “the Group” so far as it appears from our examination of those books;
  - c) “The Consolidated Financial Statements” dealt with by this report are in agreement with the relevant books of account;
  - d) Except for the possible effects of the matters described in the Basis for Qualified Opinion Section, in our opinion, “the Consolidated Financial Statements” comply with the Ind AS specified under Section 133 of the Act and the rules made thereunder;
  - e) The matters described under the Basis for Qualified Opinion section, material uncertainty related to going concern section and emphasis of matter section, in our opinion may have an adverse effect on the functioning of “the Group”;

- f) On the basis of the written representations received from the directors as on March 31, 2024 taken on record by the Board of Directors of each company, none of the directors of the Group is disqualified as on March 31, 2024 from being appointed as a director in terms of Section 164 (2) of the Act;
- g) The qualifications relating to the maintenance of accounts and other matters connected therewith are as stated in the “Basis for Qualified Opinion” section.
- h) With respect to the adequacy of the internal financial controls with reference to financial statements of “the Group” and the operating effectiveness of such controls, refer to our separate report in “Annexure A”.
- i) With respect to the statement to be included in the Auditor’s Report pursuant to section 197(16) of the Act, as amended, we report that:

Based on the examination of documents and records of “the Group” and as per the information and explanations furnished to us, “the holding company” has paid the remuneration of 69.45 Lakhs to its managing director during the year by obtaining the approvals from the lenders in terms of third proviso to sub-section (1) of section 197 of the Act.

- 2. With respect to the other matters to be included in the Auditor’s Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, as amended, in our opinion and to the best of our information and according to the explanations given to us:
  - a. “The Group”, as detailed in Note No. 32 in “the Consolidated Financial Statements”, has disclosed the impact of pending litigations on its financial position as at 31st March 2024.
  - b. “The Group” did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses as at 31st March 2024.
  - c. There has been no requirement to transfer any amounts, to the Investor Education and Protection Fund by “the Group” during the year ended 31st March 2024.
  - d. (i) The management has represented that, to the best of its knowledge and belief, other than as disclosed in the notes to the accounts, no funds have been advanced or loaned or invested (either from borrowed funds or share premium or any other sources or kind of funds) by “the group” to or in any other person(s) or entity(ies), including foreign entities (“Intermediaries”), with the understanding, whether recorded in writing or otherwise, that the Intermediary shall, whether, directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the group (Ultimate Beneficiaries”) or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries;
  - (ii) The management has represented, that, to the best of its knowledge and belief, other than as disclosed in the notes to the accounts, no funds have been received by “the group” from any person(s)

or entity(ies), including foreign entities (“Funding Parties”), with the understanding, whether recorded in writing or otherwise, that “the group” shall, whether, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party (“Ultimate Beneficiaries”) or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries; and

- (iii) Based on such audit procedures that we have considered reasonable and appropriate in the circumstances, nothing has come to our notice that has caused us to believe that the representations under sub-clause (i) and (ii) above contain any material mis-statement.

- e. None of the Companies included in “the Group” has declared or paid any dividend during the year.
- f. Based on our examination, which included test checks, “the Holding Company” has used accounting softwares for maintaining its books of account for the financial year ended March 31, 2024 which has a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the softwares. Further, during the course of our audit we did not come across any instance of the audit trail feature being tampered with.

The financial statements of the subsidiary have been audited by other auditor under the provisions of the Act as of the date of this report. Consequently, as the other auditor has not commented thereon, we are unable to comment on the reporting requirement under Rule 11(g) of the Companies (Audit and Auditors) Rules, 2014 in respect of the subsidiary.

## IX. Other Matters

- (i) We did not audit the financial statements / financial information of the subsidiary, and, whose financial statements / financial information reflect total assets (before consolidation adjustments) of Rs.0.24 lakhs as at 31st March, 2024, total revenues (before consolidation adjustments) of Rs. NIL, total net loss after tax (before consolidation adjustments) of Rs.10.42 Lakhs and net cash outflows (before consolidation adjustments) amounting to Rs. 10.66 Lakhs for the year ended on that date, as considered in the consolidated financial statements. The financial statements of the aforesaid Subsidiary have been audited by other auditors whose reports have been furnished to us by the management and our opinion, in so far as it relates to the amounts and disclosures included in respect of the said Subsidiary and our report in terms of sub-sections (3) and (11) of Section 143 of the Act, in so far as it relates to the aforesaid subsidiary, is based solely on the reports of the other auditors.

Our opinion on the statement is not modified in respect of the above matters with respect to our reliance on the work done and the reports of the other auditors

The “Opinion”/“Material uncertainty relating to Going Concern”/“Emphasis of Matter Paragraph” in such audit reports are reproduced below:

a) **Jaiprakash Engineering and Steel Company Limited**

**Emphasis of Matter Paragraph**

We draw attention to the following matters in the notes to the financial statements:

The company went into Voluntary Liquidation vide resolution passed by the Members on 25th April, 2022, Shri. Kranthi Kumar Kedari, Insolvency Professional, had been appointed as the Liquidator. The liquidator after completing all formalities of voluntary liquidation proceedings had filed the petition for dissolution of the company on 01.10.2023 with NCLT, Bangalore.

Consequent to the letter dated 17th February 2024 received from Amlika Mercantile Private Limited (AMPL), a sole Creditor, the Liquidator of the JESCO has filed a memo for withdrawal of Voluntary Liquidation Proceedings on 05.04.2024. The Liquidator of the Petitioner Company has inter alia stated that Petitioner Company is not in a position to pay for the outstanding liability of Rs. 1,06,82,828/- to AMPL and seeks permission to withdraw the instant Petition and to hand over the management of the Petitioner Company back to its directors. Considering the aforesaid submissions and taking into record the Memo for withdrawal filed by the Liquidator the instant Petition bearing CP (IB) No.164/BB/2023 for Voluntary Liquidation Proceedings of the company is dismissed By NCLT Bangalore as withdrawn on 16/04/2024.

Our opinion on the consolidated financial statements is not modified in respect of the above matters with respect to our reliance on the work done and the reports of the other auditors.

# Notes forming part of the Consolidated Financial Statements for the year ended March 31, 2024

## 1 CORPORATE INFORMATION

Nagarjuna Fertilizers and Chemicals Limited (the holding company/NFCL) is a public listed company domiciled in India, incorporated under the provisions of the Companies Act 1956. Its shares are listed on The Bombay Stock Exchange and The National Stock Exchange Of India. The registered office of the company is situated at D.No 8-2-248, Nagarjuna Hills, Punjagutta, Hyderabad - 500082.

The holding company is principally engaged in the business of manufacturing and marketing of Fertilizers, Micro Irrigation Equipments and Agri Informatic Services.

## 2 SIGNIFICANT ACCOUNTING POLICIES

### Principles of Consolidation:

The Consolidated Financial Statements relate to Nagarjuna Fertilizers and Chemicals Limited and its subsidiary companies (together referred to herein as "the Group"), and have been prepared on the following basis:

- The Financial Statements of the holding company and its subsidiary companies have been consolidated on a line-by-line basis by adding together the book values of like items of assets, liabilities, income and expenses, after fully eliminating intra group balances and unrealised profits or losses on intra group transactions as per Indian Accounting Standard (Ind AS) 110 – Consolidated Financial Statements notified by the Companies (Accounts) Rules, 2014.
- In case of associates where the holding company directly or indirectly through its subsidiaries holds more than 20% of Equity, Investments in Associates are accounted under

the equity method as per Indian Accounting Standard (Ind AS) 110 – Consolidated Financial Statements notified by the Companies (Accounts) Rules, 2016.

- The Financial Statements of the subsidiaries and the associates used in the consolidation are drawn up to the same reporting date as that of the holding company, i.e., March 31, 2024
- The excess of the cost to the holding company of its investment in the subsidiaries over the Company's share of equity is recognized in the Financial Statements as Goodwill and tested for impairment annually.
- The excess of the holding company's share of equity of the subsidiaries on the acquisition date, over its cost of investment is treated as Capital Reserve.
- Non-controlling interest in the net assets of the consolidated subsidiaries is identified and presented in consolidated balance sheet separately from current liabilities and equity of the Group.

Non-controlling Minority interest in the net assets of consolidated subsidiaries consists of:

- The amount of equity attributable to non-controlling interest at the date on which investment in a subsidiary is made; and
  - The non-controlling interest's share of movements in the equity since the date the parent subsidiary relationship came into existence.
- Non-controlling interest in the net profit / (loss) for the year of consolidated subsidiaries is identified and adjusted against the profit after tax of the group.
  - Intra-group balances and intra-group transactions and resulting unrealized profits / losses have been eliminated.
  - In case of foreign subsidiaries being non integral foreign operations, revenue items are consolidated at monthly average of exchange rate prevailing during the year. All assets and liabilities are converted at the rates prevailing at the end of the year. Any exchange difference arising on consolidation is recognized in "Foreign Currency Translation Reserve".
  - The consolidated Financial Statements are prepared to the extent possible using uniform accounting policies for like transactions and other events in similar circumstances and are presented to the extent possible, in the same manner as the holding company's separate Financial Statements.

### Voluntary Liquidation of subsidiary:

The Subsidiary went into voluntary liquidation vide resolution passed by its Members on 25th April 2022.

The Financial Statement of the subsidiary for the year ended March 31, 2024 were prepared on Liquidation Basis. Value of Assets and liabilities are stated at Liquidation Value and these statements have been consolidated.

The company went into Voluntary Liquidation vide resolution passed by the Members on 25th April, 2022, Shri. Kranthi Kumar Kedari, Insolvency Professional, had been appointed as the Liquidator.

After issuance of GO by Govt of Karnataka (KIADB) cancelling the allocation of land and after prolonged litigation (due to lack of cash flows to support operations and financial creditors), JESCO (a subsidiary of NFCL) with loans went into Voluntary Liquidation under IBC with effect from April 25, 2022. As per IND AS accounting standards shares of JESCO (part of non current assets) were accordingly fully provided for. The liquidator after completing all formalities of voluntary liquidation proceedings had filed the petition for dissolution of JESCO on 01.10.2023 with NCLT, Bangalore.

Subsequently, the company has been informed by JESCO and noted by the Board of Directors of NFCL on May 20, 2024, that the Liquidator of JESCO is of the opinion that the JESCO will not be able to pay its debts in full from the proceeds of assets to be sold in the liquidation and accordingly, the liquidator has filed a Memo for withdrawal from Voluntary Liquidation Proceedings and the same is dismissed By NCLT Bangalore as withdrawn vide order dated 16/04/2024. The financials of the subsidiary for the Quarter / Year ended 31st March 2024, received from JESCO have been consolidated. Sale of non core assets (non current assets other than core assets) is part of the recovery process by secured lender for OTS.

### 2.1. Basis of preparation:

The Financial Statements of the group have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under section 133 of the Companies Act, 2013 read with Companies (Indian Accounting Standards) Rules, 2015 as amended, on accrual basis under the historical cost convention, except for Derivative financial instruments and certain financial instruments, which are measured at fair value.

The Financial Statements are presented in INR and all values are rounded to two decimals to the nearest lakhs, except when otherwise indicated.

The financial statements have been approved for issue by the Board of Directors of the holding company in its meeting held on 20th May, 2024

### 2.2. Use of estimates:

The preparation of Consolidated Financial Statements requires management to make judgments, estimates and assumptions in the application of accounting policies that affect the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Continuous evaluation is done on the estimation and judgments based on historical experience and other factors, including expectations of future events that are believed to be reasonable. Revisions to accounting estimates are recognised prospectively. Information about critical judgments in applying accounting policies, as well as estimates and assumptions that have a significant effect on the carrying amounts of assets and liabilities within the next financial year, are included in the following notes:

- i. Measurement of defined benefit obligations - Note 25.1
- ii. Recognition of deferred tax asset/Liability- Note 17

- iii. Fair Value Measurement of financial Instruments - Note 35
- iv. Recognition of subsidy income - Note 20
- v. Provision for doubtful trade receivables - Note 7

### 2.3. Current versus non-current classification

An asset or liability is classified as current if it satisfies any of the following conditions:

- i. the asset/liability is expected to be realized/settled in the Group's normal operating cycle;
- ii. the asset is intended for sale or consumption;
- iii. the asset/liability is held primarily for the purpose of trading;
- iv. the asset/liability is expected to be realized/settled within twelve months after the reporting period;
- v. the asset is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least twelve months after the reporting date;
- vi. in the case of a liability, the Group's does not have an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

All other assets and liabilities are classified as non-current.

Deferred tax assets and liabilities are classified as non-current assets and liabilities.

For the purpose of current/non-current classification of assets and liabilities, the Group has decided its normal operating cycle as twelve months. This is based on the nature of services and the time between the acquisition of assets or inventories for processing and their realization in cash and cash equivalents.

### 2.4. Property, Plant and Equipment (PPE)

Property, plant and equipment is stated at acquisition cost, net of accumulated depreciation and accumulated impairment losses, if any. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced.

All repairs and maintenance are charged to the Statement of Profit and Loss during the period in which they are incurred. Gains or losses arising on retirement or disposal of property, plant and equipment are recognised in the Statement of Profit and Loss.

Property, plant and equipment which are not ready for intended use as on the date of Balance Sheet are disclosed as Capital work-in-progress.

Depreciation is provided on pro-rata basis under the straight-line method based on estimated useful life prescribed under Schedule II to the Companies Act, 2013 with the following exception:

- Continuous Process Plants' are depreciated for 37 years based on the technical evaluation of useful life done by the management.

The residual values, useful lives and method of depreciation of property, plant and equipment is reviewed at each financial year end and adjusted prospectively, if appropriate.

Upon first-time adoption of Ind AS, the Group has elected to measure all its property, plant and equipment at the Previous GAAP carrying amount as its deemed cost on the date of transition to Ind AS i.e., April 1, 2015.

## 2.5. Intangible assets

Separately purchased intangible assets are initially measured at cost. Intangible assets acquired in a business combination are recognised at fair value at the acquisition date. Subsequently, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses, if any.

The useful lives of intangible assets are assessed as either finite or indefinite. Finite-life intangible assets are amortised on a straight-line basis over the period of their expected useful lives. Estimated useful lives by major class of finite-life intangible assets are as follows:

Trademarks and Services: 10 years

The amortisation period and the amortisation method for finite-life intangible assets is reviewed at each financial year end and adjusted prospectively, if appropriate.

Upon first-time adoption of Ind AS, the Group has elected to measure all its intangible assets at the previous GAAP carrying amount as its deemed cost on the date of transition to Ind AS i.e., April 1, 2015.

## 2.6. Impairment of non-financial assets

Assessment for impairment is done at each Balance Sheet date for any indication that a non-financial asset may be impaired. For the purpose of assessing impairment, the smallest identifiable group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows from other assets or groups of assets is considered as a cash generating unit.

If any indication of impairment exists, an estimate of the recoverable amount of the individual asset/cash generating unit is made. Asset/cash generating unit whose carrying value exceeds their recoverable amount are written down to the recoverable amount by recognizing the impairment loss as an expense in the Statement of Profit and Loss. Recoverable amount is the higher of an asset's or cash generating unit's fair value less cost of disposal and its value in use. Value in use is the present value of estimated future cash flows expected to arise from the continuing use of an asset or cash generating unit and from its disposal at the end of its useful life. Assessment is also done at each Balance Sheet date for any indication that an impairment loss recognised for an asset in prior accounting periods may no longer exist or may have decreased, in which case, a reversal of an impairment loss for an asset is recognised in the Statement of Profit and Loss account.

## 2.7. Inventories

Inventories are valued at the lower of cost and net realisable value. Materials and other supplies held for use in the production of inventories are not written down below cost

if the finished products in which they will be incorporated are expected to be sold at or above cost.

Costs for different categories of inventories are as follows:

- Raw materials and Traded Products: Cost of purchase and other costs incurred in bringing the inventories to their present location and condition.

- Finished goods and work in progress: Cost of direct materials and labour and a proportion of manufacturing overheads based on the normal operating capacity, but excluding borrowing costs.

Net realisable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and the estimated costs necessary to make the sale.

Net realisable value in the case of Urea is –

- the Group Concession Price notified by the Government of India in respect of finished goods lying at the factory, and

- the net sale price in respect of finished goods lying in the warehouses outside the factory.

Raw materials, work-in-progress, stores, spares, packing material and loose tools are valued at weighted average cost, less provision for depletion in value, if any.

## 2.8. Cash and Cash Equivalents

Cash and cash equivalents in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value. For the purpose of the statement of cash flows, cash and cash equivalents consists of cash and short-term deposits, as defined above, net of outstanding bank overdrafts as they are considered an integral part of the Group's cash management.

## 2.9. Financial instruments

Financial assets and liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument.

### A. Financial assets

#### (i) Initial recognition

On initial recognition, financial assets other than Trade Receivables are recognised at fair value. Transaction cost that are directly attributable to acquisition of financial assets that are not at fair value through profit and loss (FVT-PL) are added to fair value on initial recognition.

#### (ii) Subsequent measurement:

Financial assets which are debt instruments are subsequently measured on the following basis, depending on their classification

- amortized cost
- fair value through profit and loss (FVTPL)
- fair value through other comprehensive income (FVOCI)

Financial assets are not reclassified subsequent to their recognition, except if and in the period the Company changes its business model for managing financial assets.

**(iii) When financial assets are Equity Instruments:**

All equity investments in the scope of Ind AS 109 are measured at fair value. Equity instruments which are held for trading are classified as at FVTPL. For all other equity instruments, the Group may make an irrevocable election to present in other comprehensive income (OCI) subsequent changes in the fair value. The Group makes such election on an instrument-by-instrument basis. Fair value changes on an equity instrument are recognised as other income in the Statement of Profit and Loss unless the Group has elected to measure such instrument at FVOCI.

Fair value changes excluding dividends, on an equity instrument measured at FVOCI are recognised in OCI. Amounts recognised in OCI are not subsequently reclassified to the Statement of Profit and Loss. Dividend income on the investments in equity instruments are recognised as 'other income' in the Statement of Profit and Loss.

**(iv) De-recognition:**

The Group derecognizes a financial asset when the contractual right to the cash flows from the financial asset expires or it transfers the financial asset and at the transfer qualifies for de-recognition under IND AS 109.

**(v) Trade Receivables and Loans:**

Trade receivables that do not contain a significant financing component are measured at transaction price. Subsequently, these assets are held at amortised cost, using the effective interest rate (EIR) method net of any expected credit losses. The EIR is the rate that discounts estimated future cash income through the expected life of financial instrument.

**(vi) Impairment:**

Expected credit losses are recognized for all financial assets subsequent to initial recognition other than financial assets in FVTPL category.

For financial assets other than trade receivables, as per Ind AS 109, the Company recognises 12 month expected credit losses for all originated or acquired financial assets if at the reporting date the credit risk of the financial asset has not increased significantly since its initial recognition. The expected credit losses are measured as lifetime expected credit losses if the credit risk on financial asset increases significantly since its initial recognition. The Company's trade receivables do not contain significant financing component and loss allowance on trade receivables is measured at an amount equal to life time expected losses i.e. expected cash shortfall. The impairment losses and reversals are recognised in Statement of Profit and Loss.

**B. Financial liabilities:**

Financial liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument.

**(i) Initial recognition and measurement:**

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss and financial liabilities at amortised cost as appropriate. All financial liabilities are recognised initially at fair value and, in the case of liabilities measured at amortised cost, net of directly attributable transaction costs.

**(ii) Subsequent measurement:**

All financial liabilities are subsequently measured at amortised cost using the effective interest method or at fair value through profit or loss.

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities at FVTPL are stated at fair value, with any gains or losses arising on remeasurement recognised in profit or loss.

Financial liabilities that are not held-for-trading and are not designated as at FVTPL are measured at amortised cost at the end of subsequent accounting periods. The carrying amounts of financial liabilities that are subsequently measured at amortised cost are determined based on the effective interest method. Interest expense that is not capitalised as part of costs of an asset is included in the 'Finance costs' line item.

**(iii) Derecognition:**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another financial liability on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the Statement of Profit and Loss.

**C. Derivative financial instruments**

The Group holds derivative financial instruments such as foreign exchange forward and options contracts to mitigate risk of changes in exchange rates on foreign currency exposure.

Such derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently re-measured at fair value at each reporting period. Any gains or losses arising from re-measurement are dealt in Statement of profit or loss.

This category has derivative financial assets or liabilities which are not designated as hedges. Although the company believes that these derivatives constitute hedges from an economic perspective, they may not qualify for hedge accounting under Ind AS109, Financial Instruments, and hence categorized as financial assets or liability at fair value through profit or loss.

**D. Offsetting of financial instruments**

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

**2.10. Fair value measurement**

The Group measures financial instruments, such as, derivatives at fair value at each balance sheet date.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- In the principal market for the asset or liability, or
- In the absence of a principal market, in the most advantageous market for the asset or liability

The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the Financial Statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – Quoted (unadjusted) market prices in active markets for identical assets or liabilities
- Level 2 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable
- Level 3 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the Financial Statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by re-assessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

For the purpose of fair value disclosures, the Group has determined classes of assets and liabilities on the basis of the nature, characteristics and risks of the asset or liability and the level of the fair value hierarchy as explained above.

#### **2.11. Provisions, contingent liabilities and contingent assets**

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the best estimate of the

expenditure required to settle the present obligation at the Balance Sheet date.

If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

Contingent assets are not recognised. They are disclosed only when an inflow of economic benefit is probable from such assets.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

#### **2.12. Revenue recognition**

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured, regardless of when the payment is being made. Revenue towards satisfaction of a performance obligation is measured at the amount of transaction price (net of variable consideration) allocated to that performance obligation. The transaction price of goods sold and services rendered is net of variable consideration on account of various discount and the schemes offered of the company as part of the contract.

The specific recognition criteria described below must also be met before revenue is recognised.

##### **Sale of Goods:**

Revenue from the sale of goods is recognised when the significant risks and rewards of ownership of the goods have passed to the buyer.

In case of goods which are shipped subject to installation and inspection, revenue is normally recognized when the buyer accepts delivery, and installation and inspection are complete.

##### **Subsidy:**

Subsidy on Group Concession Price under Group Concession Scheme (GCS) and Freight are recognized in accordance with the norms prescribed by the Government of India – Fertiliser Industry Co-ordination Committee, with adjustments for escalation / de-escalation in the prices of inputs and other adjustments as estimated by the management in accordance with known policy parameters in this regard.

##### **Rendering of services:**

Revenue from sale of services is recognised as per the terms of the contract with customers based on stage of completion when the outcome of the transactions involving rendering of services can be estimated reliably.



**Interest income:**

Interest income is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable using effective interest method .

**Dividends:**

Revenue is recognised when the Group's right to receive the payment is established, which is generally when shareholders approve the dividend.

**2.13. Employee benefits****(i) Gratuity:**

In accordance with the Payment of Gratuity Act, 1972 the Group provides gratuity as a defined benefit plan, to eligible Employees. Liability with regard to gratuity is determined by an independent actuary at every Balance Sheet date using the projected unit credit method.

The Group recognizes the net obligation of a defined benefit plan in the Balance Sheet as asset or liability. Gains or losses on re-measurements are recognized in Other Comprehensive Income (OCI). Remeasurement recognised in other comprehensive income is reflected immediately in retained earnings and is not reclassified to Statement of Profit and Loss.

All expenses represented by current service cost, past service cost, if any, and net interest on the defined benefit liability / (asset) are recognized in the Statement of Profit and Loss.

**(ii) Superannuation fund and provident fund:**

Superannuation and Provident Fund are in the nature of defined contribution plans.

The Group makes monthly contribution to approved superannuation fund covered by a policy with LIC of India. The Group has no further obligation beyond monthly contribution. The obligations under the said policy are accounted for on accrual.

The Group makes monthly contribution to the Provident Fund scheme and recognizes it as an expense, in the year in which employee renders the related service. The Group's Contribution towards Provident Fund is administered and managed by an approved trust. The Group has no obligation, other than the contribution payable to the Fund.

**(iii) Compensated absences:**

Liability for compensated absence is treated as a long term liability and is covered by a policy with Life Insurance Corporation ('LIC'). The estimated liability at each Balance Sheet date is determined by an independent actuary using the projected unit credit method and is recognised in the accounts accordingly.

**2.14. Taxes****(i) Current income tax:**

Income tax expense is recognised in the statement of profit or loss except to the extent that it relates to items recognized directly in equity or Other Comprehensive Income (OCI), in which case the tax is also recognized in equity or Other Comprehensive Income (OCI).

The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date. Current income tax asset/liability is measured at the amount expected to be recovered from or paid to the taxation authorities.

**(ii) Deferred tax:**

Deferred tax is provided using the liability method on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the Balance Sheet date.

Deferred tax assets are recognised to the extent it is probable that future taxable profit will be available against which the deductible temporary differences and tax losses can be utilised. The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent there is no longer probable that the related tax benefit will be realized. Unrecognised deferred tax assets are re-assessed at each reporting date and are recognised to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

**2.15. Government grants**

Government grants are recognised where there is reasonable assurance that the grant will be received and all attached conditions will be complied with.

When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the related costs, for which it is intended to compensate, are expensed. When the grant relates to an asset, it is recognised as income in equal amounts over the expected useful life of the related asset.

In the case of a loan or assistance provided by government or related institutions with an interest rate below the current applicable market rate, the effect of this favourable interest is regarded as a government grant. The Grant is initially recognised and measured at fair value and subsequently measured in accordance with the recognition and measurement principles of Ind AS 109, Financial Instruments (financial liabilities). The government grant is measured as the difference between the initial carrying value of the loan and the proceeds received and recognised as income on a systematic basis over the periods the related costs, for which it is intended to compensate, are expensed.

**2.16. Leases**

The Group, at the inception of a contract, assesses whether the contract is a lease or not. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a time in exchange for a consideration. This policy has been applied to contracts existing and entered into on or after 1 April 2019.

The Group recognises a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, less any lease incentives received.

The right-of-use asset is subsequently amortised using the straight-line method from the commencement date to the end of the lease term.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the Group's incremental borrowing rate. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, if there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or if the Group changes its assessment of whether it will exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The Group has elected not to recognise right-of-use assets and lease liabilities for short-term leases that have a lease term of 12 months or less and leases of low-value assets. The Group recognises the lease payments associated with these leases as an expense over the lease term.

### 2.17. Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the asset in the period in which they are incurred, until such time the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they occur. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs. Interest earned on temporary investments out of specific borrowings made for qualifying assets is deducted from the borrowing costs eligible for capitalisation to those assets.

### 2.18. Research and development costs

Expenditure relating to capital items is treated as fixed assets and depreciated at applicable rates. Revenue expenditure during research period is charged to Statement of Profit and Loss in the year in which it is incurred.

### 2.19. Foreign currency transactions

The Group's Financial Statements are presented in Indian Rupees, which is its functional currency.

On initial recognition, transactions in foreign currencies entered into by the Group are recorded in the functional currency by applying to the foreign currency amount, the spot exchange rate between the functional currency and the foreign currency at the date of the transaction. Exchange differences arising on foreign exchange transactions settled during the year are recognized in the Statement of Profit and Loss.

### Measurement of foreign currency items at reporting date:

Foreign currency denominated monetary assets and liabilities remaining unsettled at the end of the year are translated into functional currency at exchange rates prevailing at the Balance Sheet date. Exchange differences arising on translation of monetary items are recognised in Statement of Profit and Loss.

Non-monetary assets and liabilities denominated in foreign currency and measured at historical cost are translated using exchange rate prevalent on the date of transaction. Non-monetary assets and liabilities denominated in foreign currency and measured at fair value are translated using the exchange rates at the date when the fair value was determined.

The gain or loss arising on translation of non-monetary items measured at fair value is treated in line with the recognition of the gain or loss on the change in fair value of the item (i.e., translation differences on items whose fair value gain or loss is recognised in OCI or Statement of Profit and Loss are also recognised in OCI or Statement of Profit and Loss, respectively).

### 2.20. Earnings per share

Basic earnings per equity share is computed by dividing the net profit for the year attributable to the Equity Shareholders by the weighted average number of equity shares outstanding during the year.

Diluted earnings per share is computed by dividing the net profit for the year, adjusted for the effects of dilutive potential equity shares, attributable to the Equity Shareholders by the weighted average number of the equity shares and dilutive potential equity shares outstanding during the year except where the results are anti-dilutive.

### 2.21. Investments

Investments are classified as Non Current and Current. Non Current Investments are carried at cost less provision for other than temporary diminution, if any, in value of such investments. Current investments are carried at lower of cost and fair value.

### 2.22. Exceptional Items

Exceptional items of income and expense within profit or loss from ordinary activities are of such size, nature or incidence that their disclosure is relevant to explain the performance of the enterprise for the period, the nature and amount of such items are disclosed separately as exceptional items.

**14.6 Sales Tax Deferral Loan:** The Government of Andhra Pradesh sanctioned Sales Tax deferral facility to the Company with a final eligibility of Rs 1,01,746.56 lakhs, subject to the restriction of loan to the actual Sales Tax collected on the sale of the products manufactured by the Company during the period of 14 years from 19.03.1998 to 18.03.2012. The Sales Tax deferred in a year should be repaid at the end of 14th year without interest. Repayment of this loan was commenced on March 19, 2012. The deferred Sales Tax outstanding as on March 31,2024 is Rs. 2,343.49 Lakhs (Previous Year Rs.3,354.48Lakhs). As at the balance sheet date, the Company has defaulted in payment of instalment due on 19.03.2024 amounting to Rs. 1000Lakhs for a period of 13days (Previous year Rs 837.16 lakhs for a period of 13 days).

**14.7** The company is in default of principal and interest during the year on the borrowings from various lenders on account of non implementation of CAP. To overcome the financial stress caused due to disruption of production and losses, the company approached its lenders for a Corrective Action Plan (CAP) and the lenders formed Joint Lenders Forum (JLF) in 2015 and assessed Rs. 3,05,000 lakhs (Rs.85,000 lakhs under Fund Based & Rs.2,20,000 lakhs under Non-Fund Based) and Rs.80,000 lakhs of Working Capital Term Loan under CAP to shore up the working capital and to enable the company to run. This funding for rectification of account is called Corrective Action Plan 2015 (CAP). Due to non sanction / release of assessed funds by the lenders (non implementation of CAP), the company's account after the GAIL Pipe Line accident could not be rectified in 2015-16 and went into severe financial stress increasing indebtedness and losses resulting in defaults. Upgrading of account without releasing of the assessed funds for rectification of account (CAP) is in violation of RBI CAP regulations of 2014 and 2015, resulting in the account becoming NPA in 2015 itself as per RBI regulations instead of 2018 after CAP implementation as being claimed by Banks. The debt in the books (CAP loans) are disputed and are sub-judice. Pending resolution of the CAP loans and disputes (working capital and term loans in the books of the Company), the Company has been accounting for the interest / penal interest during the year on the borrowings as per the rate of interest mentioned in the sanction letters and as per CAP and other loan arrangements. This is not confirmation of dues. Adjustments, if any, for the principal, interest and penal interest accounted will be dealt on the outcome of the Debt Resolution Plan agreed by the company and lenders.

The lenders (Banks) of the company have not implemented the Corrective Action Plan (CAP) approved by them in the Joint Lenders Forum (JLF) meeting held in 2015. Though the company represented the matter to the lenders for necessary corrective action, the same has not been rectified till date. As a result, the company filed cases against the lenders in the Hon'ble High Court of Telangana, which has restrained the lenders from taking any coercive action against the company. Further, there is no clear information on when the loans were declared NPAs by the lenders. Due to these disputes, the lenders have not been sending the interest demands and the loan statements/ confirmation of balances to the company since 6 years. The company has also been disclosing CAP debt disputes since 2018. In this background, the company has been accounting the interest on the loans as per the terms of CAP funding sanction letters with a qualification of dispute and furnishing the default details as available with it in the financial statements. This is not confirmation of dues.

Without prejudice to the rights of the company and guarantors, the company has accordingly recorded the communication from ACRE-112-TRUST.

The 100% cash margin of Rs. 8,550.00 lakhs deposited for providing Bank Guarantee for gas supplies, has been adjusted by the lenders unilaterally without informing or taking approval from the company Rs 1,723.78 lakhs and Rs 6,826.22 lakhs against outstanding during FY 2021-22 and FY 2020-21 respectively along with interest. While the company has reduced the amount from the outstanding loans, the adjustment and the outstanding have been disputed by the company. Details of appropriation of the margin money adjusted Bank-wise were also not made available to the Company.

During the year the above Bank Guarantee issued to GAIL had been invoked and honoured by IDBI Bank Limited. Accordingly the balances in the Cash Credit account of IDBI Bank Limited has been increased by Rs. 8,550.00 Lakhs.

**20.1. Group Concession Scheme – (GCS) Subsidy**

- Nitrogenous fertilizers (Urea) are under the Group Concession Subsidy scheme of Government of India (GOI), Department of Fertilizers. GOI has notified New Urea Policy (NUP)-2015 from 1st June, 2015 to 31st March, 2019. GOI vide its notification dated 14th May, 2019 has extended the duration of NUP-2015 from 1st April, 2019 till further orders. Gas Pooling Policy applicable to Fertilizer industry effective from June 1, 2015. Concession rates for Plant-1 and Plant 2 for the period April 1, 2023 to December 31, 2023 have been recognized based on notified rates as per respective policies.

Further De-escalations Rs.8,790.77 Lakhs (Previous year De-escalations Rs. 20,732.96 Lakhs), have been accounted for during the year as per the gas pool prices and provisions applicable under NPS-III, Modified NPS-III, NUP-2015 and Letter dated March 30, 2020 related to Modified NPS-III policy. Adjustments, if any, required will be considered on notification of final prices.

- ii. Government of India / Department of Fertilizers has implemented Direct Benefit Transfer (DBT) in Fertilizer Sector in all the States of the Country from 1st March, 2018. The subsidy income for the period April, 2023 to March, 2024, has been recognized in the accounts for the entire quantities received in the States under DBT scheme.

(c) As at the end of the year, the Company has a total unabsorbed loss and depreciation of Rs. 1,45,441.52 Lakhs (March 31, 2023: Rs1,14,385.38 Lakhs). Deferred tax asset in respect of unabsorbed depreciation and carried forward loss under the Tax Laws are recognised only if there is reasonable certainty that there will be sufficient future taxable income available to realise such assets.

**29. Material Uncertainty on the Holding Company's ability to continue as a going concern and appropriateness of use of going concern basis of accounting in preparation of financial statements :**

The holding company is operating in a regulated environment under the Essential Commodities Act, 1955, supported by Government Subsidy. On account of an accident in the GAIL Pipeline which supplies Gas to the company during 2014, the production of the company was disrupted for long time and as a result, the company suffered losses. To overcome the financial stress caused due to disruption of production and losses, the company approached its lenders for a Corrective Action Plan (CAP) and the lenders formed Joint Lenders Forum (JLF) in 2015 and assessed Rs. 3050 Crs (Rs.850 Cr under Fund Based + Rs.2200 Cr. Under Non-Fund Based) and Rs.800 Cr. Working Capital Term Loan under CAP to shore up the working capital and to enable the company to run. This funding for rectification of account is called Corrective Action Plan 2015 (CAP). Due to lack of assessed funds from lenders (non-implementation of CAP), the company's account after the GAIL Pipe Line accident could not be rectified in 2015-16 and went into severe financial stress increasing indebtedness and losses resulting in defaults in 2018. Upgrading of account without releasing of the assessed funds for rectification of account (CAP) is in violation of RBI CAP regulations of 2014 and 2015, resulting in the account becoming NPA in 2015 it self as per RBI regulations instead of 2018 after CAP implementation as being claimed by Banks. The company has been reporting the disputes on CAP debt (Working capital Term Loans and Working Capital Loans in the books of the company) to the lenders and in the annual reports. The debt in the books (CAP loans) are disputed and are sub-judice.

The lenders approved 'Holding on Operations' (HOO) from December 2018 to amicably resolve the debt issues with the company in the interest of all stakeholders (valid till June 30, 2024). Due to inadequate working capital, financial stress and continued losses on account of stoppage of production of the plants during 2018, without prejudice to the interest, the company had taken up long-term financial Resolution Plan (RP) with its Lenders. The lenders held series of Joint Lenders Meetings (JLM) for consideration and

suggestions on the RP. Consequent to the lenders meetings, a resolution plan was unanimously approved by the lenders in March 2020, which amongst other things, include segregation of debt into sustainable and unsustainable, reduction in the rate of interest, infusion of fresh equity and sanction of additional debt etc. However, post conclusion of the Resolution Plan, the lenders made arbitrary changes in the said RP on 4th June 2020. The company has filed a Writ Petition in the Hon'ble High court of Telangana, on the arbitrary actions of the lenders against the RBI Regulations. The Hon'ble High Court granted stay against any proceedings that may be initiated by the lenders against the company until further orders and the matter is awaiting final orders. Further, the company had filed contempt cases against 3 lenders who have filed petitions under IBC in violation of the above stay orders of High Court and the matter is disposed of without cost by the court.

In view of operating only one plant (out of the two plants) due to lack of working capital, the losses continued, resulting in substantial erosion of net worth and the company faced liquidity issues. As a result of continuous losses, the company's financial position has become very weak, and it is unable to meet its commitments to the financial and other creditors including statutory dues on the due dates. Due to default in paying the instalments and interest, the lenders have declared the loans to the company as Non-Performing Assets in 2018 (instead of 2015) and the status is continuing till date. As a result of treating the loans as NPAs by the lenders, all the borrowings, with a qualification of dispute, have been recorded as current liabilities in the Books / Financial statements of the company, leading to the situation that the current liabilities are in excess of current assets in the last four financial years. As at the year end, the company's current liabilities exceeded current assets by Rs. 3,96,547.86 Lakhs.

All the above events / conditions indicate material uncertainty which cast a significant doubt on the company's ability to continue as a Going Concern.

However, The company's management assessed the company's ability to continue as a Going Concern in which the company considered the following events / conditions, which individually / collectively have contributed in concluding that use of Going Concern basis of accounting is appropriate for this year.

- The company is continuously pursuing with the lenders for resolution of all the disputes amicably and for an acceptable resolution plan to make the company functional successfully.
- Despite the weak financial condition of the company, the company continued the production and supply of goods and able to produce Urea during the year is 13.10 LMT as against 11.20 LMT in 2022-23
- The lenders, to enable the company to generate the Cash flows, have approved the facility of 'Holding on Operations' (HOO) in December 2018 and have been extending the same from time to time, in the interest of all the stakeholders. The last extension of HOO facility is valid till June 30, 2024.
- The management has no intention to close the plants.
- There is no change in law, regulation or government policy which is adversely affecting the company.
- All the Key management personnel in all the operating areas are continuing and no loss of personnel at any level in the company.
- The Product of the company is administered under the essential commodities Act 1955. The production, distribution, pricing are controlled by the Department of Fertilizers, Government of India. As such, there is no loss of market / customers for the company's product.
- With such a weak financial position, the company, during the year 2023-24 could still sell 13.08 lakh MT as against 11.20 lakh MT of Urea in 2022-23.
- The major supplier of Gas, which is the Raw Material and Power and Fuel, M/s GAIL (India) Limited continue to supply Gas under the Gas Purchase and Sale Agreement which is effective from 07th July 2021 and is valid till 06th July 2026 under liberal terms of payment.
- The Company maintained good relationship with the personnel at all levels and there are no issues with the Labour.
- The company has been paying all the statutory dues, though with some delay and complying with all the applicable Laws.
- There is no entry of fresh competitors to the product of the company despite the fact that the India's requirement of Urea is about 35 Million Tons which is far in excess of production capacity of the country at 25 Million Tons and the Government of India continue to import Urea at a very high price. Hence, there is no issue of lack of marketability or competition for the product of the company which is covered under the administered pricing mechanism of the Government.
- There is no underinsurance for the assets of the company in the events of major catastrophe.
- The company's industry is a major capital-intensive Industry with highly regulated operations. The Government cannot afford to close the operations of the company as the demand for the product is huge and any shortage would affect the food security of the country.
- The company is exploring various avenues to resolve the financial crisis and sought the help of the Government of India for revision of energy norms and hoping for positive response from the Government.

- The Government of India has made an arrangement wherein the GAIL would supply the required Gas for which part payment only will be made by the company and the lenders also would get part payment of their dues.

The company is confident of running the operations as the government has allowed the Gas supply to continue till 30.09.2024 vide their Office Memorandum dated 8th March 2024.

In the light of all the above, the Management concluded that the company is a Going Concern and accordingly use of the Going Concern basis of accounting in the preparation of the financial statements for the year ended 31, March 2024 is appropriate.

**30.** The Company has received a demand notice dated 20th May 2023 U/s 13(2) of the SARFAESI Act from Lender (Secured Creditor) to repay total outstanding dues of Rs 3,344.37 Crs, failing which Lender (Secured Creditor) will take appropriate action in accordance with the Law. The Company has replied to the said notice on 17th July 2023 explaining the disputes with the lenders and matter is being sub-judice and sought time for submission of Debt Resolution plan/OTS. In response to the company reply, the Lender (Secured Creditor) reverted on 25th July 2023 disputing objections raised by the company and advised the company to expedite submission of Debt Resolution Plan/OTS.

Accordingly, the Board of Directors at their meeting held 14th August 2023 and members in AGM held on 15th September 2023 approved the proposal of slump sale transaction of Ammonia / Urea and MI businesses along with related assets and liabilities, subject to fulfilment of Conditions Precedents (CP's), Sale of non-core assets of the company and Debt Resolution / OTS along with funding.

Subsequently, the Board of Directors at their Meeting held on October 09, 2023, have noted 1) order of the Hon'ble NCLAT, Chennai, dated October 05, 2023, setting aside the order dated August 27, 2021, passed by Hon'ble NCLT, Hyderabad Bench, 2) the CP's needed for Slump Sale transaction, 3) Sale of non-core assets of the company and 4) Debt Resolution / OTS. Further, the Company is working towards fulfilment of CPs.

ACRE subsequently taken symbolic possession of the scheduled assets of the Company in its favour on October 12, 2023. The company while continuing to work and was optimistic on fulfilling the critical CPs for the closure of the slump sale transaction has formally applied to ACRE for OTS as approved by the Board and Shareholders (without any prejudice to the rights of NFCL regards to ongoing debt disputes). ACRE on the 31st of October 2023 replied to the company's OTS proposal that the Settlement Proposal submitted to ACRE is not binding and tentative on fulfilment on CPs (which was tentative amongst other things energy claim approval/disbursal by Govt) and therefore was unable to consider and/or appraise the Settlement Proposal and communicated that it would continue to pursue the SARFAESI process.

Given the uncertainties of energy claim approval/reimbursement by GOI, the consequences of SARFAESI process in case the lender is unable to recover the total amounts due and to ensure an amicable debt resolution to ensure continuation of operation post debt resolution The Board of Directors on December 24, 2023, while asking the company to continue and speed up closure of CPs for the approved Slump Sale transaction, without prejudice, considered and approved the company to engage and work with ACRE on a One Time Settlement (OTS) under SARFAESI/directly (or a combination of both) if any in parallel to the current efforts on the Slump Sale transaction to amicably settle debt.

The OTS amount as benchmark provided by the Board for negotiations with ACRE on December 24, 2023, was the amount equal to or lower than the amount realised from sale of core and non-core assets and lower than the amounts due to ACRE. In terms of the mandate of the Board of Directors the company engaged with and vide letter agreement dated 12th January agreed to cooperate with ACRE, without prejudice to the rights of the company and guarantors for a One Time Settlement (OTS) under SARFAESI/directly. The OTS amount is the amount recovered by ACRE under SARFAESI through sale of core assets plus Rs 200 Crores through sale of non-core assets (non-current assets of the company). While the current assets are also fully charged to the secured creditor in case the OTS with ACRE is successful the current assets including energy claims would be primarily utilised by the company to settle operating creditors dues.

The Board of Directors on January 26, 2024, took note of the updates on slump sale process, SARFAESI process by Assets Care and Reconstruction Enterprise Limited (ACRE). ACRE, as part of the SARFAESI process after taking symbolic possession of assets, has issued a Public Notice for physical auction for sale of Movable and immovable properties of the Company under SARFAESI Act, 2002, vide email to the company dated January 17, 2024. ACRE in their public auction notice stated that as of December 2023 the company owed ACRE around Rs 3858 Crs including interest.

The Company has received an email communication dated April 17, 2024, from ACRE that it has received an offer from a bidder above the reserve price and the bidder has submitted an upfront amount of 25% of the purchase consideration, in line with the terms of the sale.

It was further stated in the said mail, that consequent to the issue of sale confirmation to the highest bidder by ACRE, in terms of the provisions of SARFAESI Act, 2002, read with rules made thereunder, a sale certificate shall be executed in favour of the successful bidder on payment of the balance consideration in accordance with the terms of SARFAESI Act, 2002 and the rules.

ACRE vide email dated April 24, 2024, asked the company to deposit the proceeds/advances received from the sale of non-core assets as mandated by ACRE into fixed deposits lien marked in favour of ACRE. The sale of non-core assets shall take effect along with or after receipt of sale consideration from the sale of Core Assets under SARFAESI Act, 2002, by ACRE. The borrower/NFCL has since deposited the proceeds/advances it received from the sale into the lien marked Fixed Deposits as mandated by ACRE.

Considering the uncertainties and final outcome of the result of the actions taken as discussed above by ACRE for sale of core and non-core assets, further taking into account of the future plans of the company for continuation of business operations post debt settlement and given the above background on its efforts for OTS as Debt Resolution, the management is of the opinion that the preparation of the financial statements for the year ended 31st March 2024 as a Going Concern basis is still appropriate.

ACRE has taken symbolic possession to enable them to start the auction process, but has not imposed any restrictions on the operations of the company as on the date. There is no discontinuance of plant operations and usual operations are being carried out by the company. Revenue, both, sales from Urea & Micro Irrigation and subsidy on Urea are being generated in the normal course of business. Subsidy claims are being raised in the name of the company as per the procedures laid by the Government and Subsidy amounts are also received / receivable in the name of the company. Considering the above facts and that the financial statements are prepared on a going concern basis, the Property, Plant and Equipment are continued to be disclosed as non-current operating assets at its carrying value.

### 31. Impairment of Property Plant & Equipment

Basis the economic indicators on performance of Plant and Machinery, buildings attached there to have been put to test for impairment as of 31st March 2024 by the management and perceive that there is no further impairment loss required to be recorded as there are no changes in the conditions prevalent as on the date of this balance sheet compared to the Balance Sheet as at 31 March 2023 (Previous year impairment loss of Rs. 67,519.40 Lakhs accounted for Plant & Machinery located at Kakinada Rs. 63,224.23 lakhs, Micro Irrigation Plants at Nacharam Rs. 379.01 Lakhs, Sadasivpet Rs. 30.98 Lakhs and Halol Rs. 203.18 Lakhs and Buildings of Urea plant at Kakinada Rs. 3,509.40 lakhs and Corporate Office Rs. 172.60 Lakhs).

Impairment test of property (land) was carried out as of 30th June 2023 during the year and recorded an impairment loss of Rs. 63,407.20 Lakhs as per the Registered Valuer's Report dated 12th August 2023. The management is of the opinion that there is no further impairment of land as at 31.03.2024.

32.1 (a) In relation to some of the contracts for purchase of fertilisers, an international Arbitration Award has been passed against the Holding Company in September 2016 for USD 14,398,188 and GBP 690,630 and interest as applicable apart from costs based on a claim filed by one of the Suppliers of Fertilizers to the Company.

The Company is of the view that the Award has been obtained based on documents tampered with and mis-representations of facts by said supplier. The Company is contesting the enforcement of the Award in the Courts in India and has also filed a Criminal Complaint before the Metropolitan Magistrate of Hyderabad against the supplier and its officials. Matter yet to be listed for hearing.

(b) The Company entered into two Contracts dated December 15, 2012 on Early Works, Offshore and Onshore towards certain engineering drawings to be utilised towards its plant for third ammonia and urea project on conditions that balance amounts payable only upon (a) the announcement of a fertilizer policy and (b) that the fertilizer policy being found favorable for the Project of the Company. The Company could not proceed further as the policy was not conducive for the project.

The service provider raised invoices for the balance amounts claiming that the work carried out was per contract. As the amounts were not paid the service provider invoked arbitration. The arbitral Tribunal passed an award on October 23, 2017 for USD 877,500, GBP 52,314, EUR 455,000 and INR 221.39 Lakhs and interest as applicable apart from costs in favour of the claimant. NFCL challenged the Awards by filing two petitions separately for each case under section 34 of Arbitration & Conciliation Act as the tribunal ignored vital evidence such as Govt communication dt 9th May 2013 where in the industries we're asked not to proceed further without necessary approvals from Govt, amongst other grounds. Matter yet to be listed for hearing.

Based on the current legal progress, the management has provided for 25% of the claim made on the Offshore contract and deposited 15% of the onshore contract value with the court. The Company continues to proceed legally and hence the balance claims have been disclosed as contingent liabilities.

32.2 The Holding Company has been using the Nagarjuna Brand / Trademarks for its urea and other products under a license agreement Dt 29/01/1998 with the grantor, a related party. The company, during the year 2021-22, received a claim from the grantor asserting its right for royalty for the period from 29/01/1998 to 31/12/2021. The said claim is being negotiated with the granter for settlement.

### **32.3 Cases / Petitions filed against the company in NCLT / Courts / Other Tribunals:**

Few other creditors have filed petitions against the company in various Courts / Tribunals for recovery of dues / claims for compensation for their services / supplies and all these matters are at various stages in the respective courts. The legal counsel confirmed that the cases / petitions filed against the company are not tenable and are of the view that these cases may not have any impact on the financials of the company.

The management is of the view that the pending litigations will not have any adverse impact on the financial position of the company as at the year end.

32.4 Amlika Mercantile Private Limited (AMPL), Core Promoter of the Company had preferred an appeal before Hon'ble National Company Law Appellate Tribunal (NCLAT), Chennai, against the Order' dated 27.08.2021, passed by the 'National Company Law Tribunal', Hyderabad Bench, admitting the Nagarjuna Fertilizers and Chemicals Limited (NFCL) into Corporate Insolvency Resolution Process (CIRP) under Insolvency and Bankruptcy Code, 2016.

Basis the appeal of AMPL, Hon'ble NCLAT, Chennai, vide order dated October 05, 2023, has allowed the appeal by setting aside the impugned order dated August 27, 2021, passed by Hon'ble NCLT, Hyderabad Bench. Thereby, the Company exited CIRP under IBC, 2016 effective October 05, 2023.

AMPL has claims the legal expenses for the NCLAT appeal filed on behalf of the Company and the company is liable to reimburse the legal expenses to AMPL.

### 37. Financial risk management objectives and policies

#### Financial Risk Management Framework

The Company's principal financial liabilities, other than derivatives, comprise loans and borrowings, trade and other payables. The main purpose of these financial liabilities is to finance the Company's operations. The Company's principal financial assets include loans and advances, trade and other receivables, and cash and cash equivalents that derive directly from its operations.

The Company is exposed primarily to Credit Risk, Liquidity Risk and Market risk (fluctuations in foreign currency exchange rates and interest rate), which may adversely impact the fair value of its financial instruments. The Company's senior management oversees the management of these risks. The Company assesses the unpredictability of the financial environment and seeks to mitigate potential adverse effects on the financial performance of the Company based on the policies agreed by the Company's senior management. The same are summarised below:

#### A. Credit Risk

Credit risk is the risk that counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. Credit risk encompasses of both, the direct risk of default and the risk of deterioration of creditworthiness as well as concentration of risks. The Company is exposed to credit risk from its operating activities (primarily trade receivables) and from its financing activities, including deposits with banks and financial institutions, foreign exchange transactions and other financial instruments. Financial instruments that are subject to concentrations of credit risk principally consist of trade receivables, investments, derivative financial instruments, cash and cash equivalents, bank deposits and other financial assets. None of the financial instruments of the Company result in material concentration of credit risk except trade receivables where more than 50% is due from Government of India and various State Governments. The same are realisable in due course.

To manage this, the Company periodically assesses the financial reliability of customers, taking into account the financial condition, current economic trends, and analysis of historical bad debts and ageing of accounts receivable. Individual risk limits are set accordingly.

The company considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk the company compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers reasonable and supportive forwarding-looking information such as :

- (i) Actual or expected significant adverse changes in business,
- (ii) Actual or expected significant changes in the operating results of the counterparty,
- (iii) Financial or economic conditions that are expected to cause a significant change to the counterparty's ability to meet its obligations,
- (iv) Significant increases in credit risk on other financial instruments of the same counterparty,
- (v) Significant changes in the value of the collateral supporting the obligation or in the quality of third-party guarantees or credit enhancements.

Financial assets are written off when there is no reasonable expectation of recovery, such as a debtor failing to engage in a repayment plan with the company. The company categorises a loan or receivable for write off when a debtor fails to make contractual payments greater than 2 years past due. Where loans or receivables have been written off, the Company continues to engage in enforcement activity to attempt to recover the receivable due. Where recoveries are made, these are recognised in profit or loss.



**Excessive risk concentration**

Concentrations arise when a number of counterparties are engaged in similar business activities, or activities in the same geographical region, or have economic features that would cause their ability to meet contractual obligations to be similarly affected by changes in economic, political or other conditions. Concentrations indicate the relative sensitivity of the Company's performance to developments affecting a particular industry.

In order to avoid excessive concentrations of risk, the Company's policies and procedures include specific guidelines to focus on the maintenance of a diversified portfolio. Identified concentrations of credit risks are controlled and managed accordingly.

**C. Market Risk**

Despite the Company's continuous persuasion, these lands could not be registered in the name of the company as title of all these lands is defective and the original owners who sold the land are not traceable.

Based on the legal opinion wherein it was opined that as these lands are in excess of the limit specified under the Andhra Pradesh Land Reforms (Ceiling on Agricultural Holdings) Act 1973, it was concluded that these lands are not transferable on to the name of the Company. Accordingly, considering the restriction under the applicable Law to hold these lands, the passage of over two decades of time since original acquisition, non-traceability of original owners who sold these lands and

defective titles, the Company has impaired the entire carried value of these lands during FY 2020-21, along with some other lands, aggregating to Rs 11,777 lakhs. (Refer Note no: 3).

	1.	We refer to Note No: 3 to "the statement" wherein "the Company" explained that the lenders of "the Company" have not implemented the Corrective Action Plan (CAP) approved by them in the Joint Lenders Forum (JLF) meeting held in 2015 and though "the Company" represented the matter to the lenders for necessary corrective action, the same has not been rectified till date. As a result, "the Company" filed cases against the lenders in the Hon'ble High Court of Telangana, which has restrained the lenders from taking any coercive action against the company. Currently in this regard Writ Appeal 708/2022, is pending before Telangana High Court. Further, there is no clear information on when the loans were declared as NPAs by the lenders. Due to these disputes, the lenders have not been sending the interest demands and the loan statements/confirmation of balances to "the Company" since 6 years. In this background, "the Company" has been accounting the interest on the loans as per the terms of CAP funding sanction letters with a qualification of dispute and furnishing the default details as available with it in the financial statements.		

We refer to Note No: 4 to "the statement" wherein "the Company" stated that on 3rd April 2023, "the company" received a letter dated 31st March 2023, copying to all the Lenders, from Assets Care & Reconstruction Enterprise Ltd (ACRE) communicating the Assignment of Debt by all Consortium Lenders to ACRE (in its capacity as the trustee of the ACRE-112-TRUST) under section 5 of the SARFAESI Act. There was no communication to the Company from the Lenders about the assignment of their loans / credit facilities / interest etc., as stated above to the ACRE-112-TRUST by 31.03.2023. Without prejudice to the rights of the company and guarantors, the company has accordingly recorded the communication from ACRE-112-TRUST.

In the absence of independent audit evidence from the lenders on the date(s) from which the loan accounts have been classified as NPAs, outstanding amount of borrowings at the end of every year, interest accrued thereon, period and amount of default in repayment of loans and payment of interest thereon disclosed in the financial statements and continuing the outstanding borrowings with the existing lenders (Banks), we are unable to express an opinion whether any adjustments are required to be made to the outstanding balance of borrowings as at the year end, interest on the borrowings charged to the statement of profit and loss for the year and the period and amount of default in repayment of principal and payment of interest disclosed in the financial statements.
