With respect to the captioned issue, the statutory advertisement cum Corrigendum to the Tranche I Prospectus dated December 30, 2022, in relation to opening of the Tranche I Issue was published in national daily newspaper with wide circulation being Financial Express (English) and in Navshakti (Marathi) on January 02, 2023 ("Statutory Advertisements").
