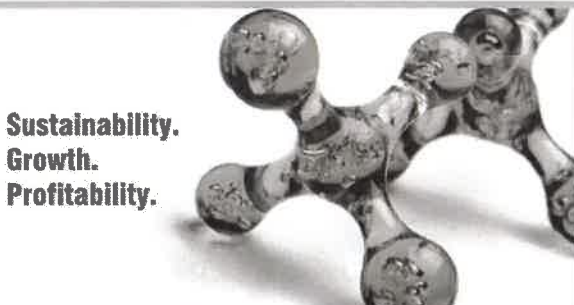

The Company is operating in a single segment viz. content production and distribution. Hence the results are reported on a single segment basis.  
The Company's loan facilities from banks has become Non-performing. However, some of the banks are still charging interest from the data the accounts has been classified as non-performing, as per the bank statements provided. No such interest provision has been made in books of accounts and correspondingly in the financial result for the quarter ended 31<sup>st</sup> March 2023, since interest provision is to be charged on initiation of CIRP due to moratorium under IC.
