Opinion

We have audited the accompanying standalone annual financial results of Garware Synthetics Limited ('the Company') for the year ended 31st March, 2023 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, as amended (the "Listing Regulations").
