This is for the information to the general body of the workmen and their three union representatives of Wellington Jute Mill that as the price of the Raw Jute has increased beyond the capacity of the company due to acute financial stringency as well as high manning low production / productivity and non co operation of some union representatives of the Mill, which culminated for the Management in such a position that Management is unable to run the Mill for the time being.

Therefore the Management has decided to keep the Mill's working suspended with effect from 27.02.2021 at 10:00 PM for the time being and it is hoped that within a very short time the position can be overcame and Management will be able to run the Mill further.

Management requests the workmen and their representatives to bear with the situation and to co operate in this respect with the Management for betterment of the future situation and it is the greatest interest of the workmen and their family members also. In this situation Management can not afford to pay wages / allowances / compensation so long the Mill remain suspended.

The workmen who are still in the Mill requested to leave the Mill and those who are outside the Mill not to enter the Mill premises for the sake of Law and Order and to built the back bone strong of the Mill for the interest of the Management and workmen for the future.
