हाई कोर्ट ने मुख्य सचिव समेत कईयों को किया जवाब तलब

शिमला, 7 सितंबर (जनसता)।

ऊना में माता चिंतपूर्णी मंदिर के नजदीक तलवाड़ा बाइपास पर पार्किंग की सुविधा न होने पर प्रदेश हाई कोर्ट ने मुख्य सचिव, प्रधान सचिव लोक निर्माण विभाग और ऊना के जिला उपायुक्त और अंब के एसडीएम को नोटिस जारी कर जवाब तलब किया है। मुख्य न्यायाधीश रवि मलिमठ और न्यायमूर्ति ज्योत्सना रेवाल दुआ ने यह आदेश एक विजय कुमार नामक शख्स की ओर से मुख्य न्यायाधीश को लिखी चिट्ठी को जनहित याचिका करार देते हुए जारी किए ।

विजय कुमार में अपनी चिट्ठी में लिखा था कि माता श्री चिंतपूर्णी मंदिर प्रदेश में सबसे अमीर मंदिरों में से एक है व यहां दो सड़कें एक भरवाई व दूसरी तलवाड़ा की ओर से आती है। इनमें से एक सड़क पर दो पार्किंग है, जो कांगड़ा जिला में पड़ती है लेकिन दूसरी सड़क जो ऊना में पड़ती है, में एक भी पार्किंग नहीं है। इसलिए जो श्रद्धालु इस सड़क से आते है वह अपने वाहन मंदिर के बाहर खड़े कर देते है जिसकी वजह

से यहां पर जाम लग जाता है। उसने चिट्ठी में लिखा कि पार्किंग न होने से कुछ साल पहले तलवाड़ा बाइपास पर एक एंबुलेंस जाम में फंस गई और एक व्यक्ति की अस्पताल पहुंचने से पहले ही मौत हो गई। तब से लेकर अब तक जाम की समस्या से निजात नहीं मिली है। यही नहीं प्रदेश हाई कोर्ट ने भी 2008 में मंदिर के नजदीक पार्किंग बनाने के निर्देश दिए थे लेकिन आदेशों की भी अनुपालना नहीं की गई है।
