Gurugram, **15**th **September**, **2022**: Ester Industries Limited on 6th May, 2022 had entered into a definitive agreement to sell its Engineering Plastic Business to Radici Plastics India Private Limited, in an all-cash slump sales transaction amounting to INR 289.33 crore.

Ester Industries has informed that the divestment of Engineering Plastics Business to Radici Plastics India Private Limited has been completed and closed today.
