With reference to the above cited subject, we would like to inform you that the meeting of Board of Directors of the company held on Wednesday, 18<sup>th</sup> August, 2021 at 04.00 P.M. at the registered office of the company, Hyderabad. The Board has approved and considered the following:

Pursuant to Regulation 30 of (SEBI Listing Regulations, 2015) read with SEBI Circular No. CIR/CFD/CMD1/114/2019 dated October 18, 2019 and in furtherance to an intimation dated August 06, 2021, we wish to inform that based on the recommendation of the Audit Committee, the Board of Directors of the Company at its meeting held on August 18, 2021 noted and accepted the resignation of M/s. C. Ramachandram & Co., Chartered Accountants (Firm Registration number: 002864S) who have tendered their resignation vide their letter dated August 06, 2021 informing their inability to continue as the Statutory Auditors of the Company. The said appointment will be placed for shareholders approval at the ensuing Annual General Meeting.

The said appointment is pursuant to applicable provisions of the Companies Act 2013 and the SEBI Listing Regulations, 2015. M/s. Niranjana & Narayan, Chartered Accountants (Registration No. 005899S) vide their consent letter dated August 18, 2021, have confirmed their eligibility for appointment.

On appointment, M/s. Niranjana & Narayan, Chartered Accountants (Registration No. 005899S) will hold the office for a period of 1 (One) years from the conclusion of 28<sup>th</sup> Annual General Meeting of the Company till the conclusion of the 29<sup>th</sup> Annual General Meeting of the Company.
