her point blank if she's dumb when she can't figure out how to exit a revolving door, though her colleagues definitely have some healthy skepticism that is designed to show how much she's capable of doing when faced with adversity.

Overall the watchers are not forced to squirm as they watch drama unfold!

top 10 for a total of four weeks, including three No. 1 finishes.

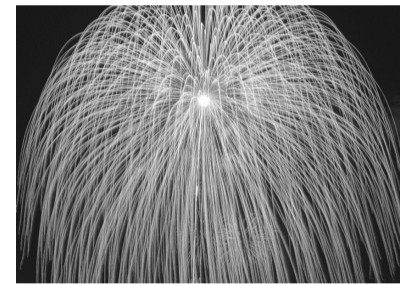
