- ii) The National Stock Exchange of India Limited vide their letter No. NSE/LIST/125778-K dated 15th December, 2009 for ESOS 2008, letter No.NSE/LIST/132317-R dated 8th March, 2010 for ESOS 2009 Plan B and letter No. NSE/LIST/252389-U dated 9th October, 2014 for ESOS 2014.

The meeting commenced at 05.30 P.M. and concluded at 05.40 P.M. The Company shall apply for the listing and trading permission shortly.
