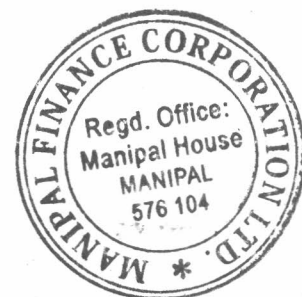
1. Resignation of Mr Srikara Mallya (DIN 08409522) for the post of Non-Executive Non-Independent Director of the Company.
