# 'Kaatrin Mozhi' to be screened at Dubai Expo



Chennai, Nov 9: South Star Jyotika's Kaatrin Mozhi, a comedy drama directed by Radha Mohan, has been chosen to be screened at the Dubai Expo, which is considered to be the largest trade fair in the world. Almost every major country in the world is taking part in this expo, in which they showcase their nation's industries, culture and cinema.

As part of promoting Indian cinema, The Federation of Indian Chambers of Commerce & Industry Ladies Organisation (FICCI FLO) is organising a women-centric film festival that will be held on January 18-19, 2022 at the India Pavilion at the Dubai Expo. Sooryavanshi begins after the 1993 bomb blasts in Mumbai. 13 years later, when a terrorist group is back in action and planning another mission, DCP Veer Sooryavanshi, (Akshay Kumar), the head of the Mumbai Anti-Terrorism Squad, is assigned the task of finding their whereabouts and stop the attacks.

DCP Veer Sooryavanshi who

heads the Anti-Terrorism Squad takes up the task of nabbing Riaz Hafiz (Abhimanyu Singh), the son of Lashkar Chief, Omar Hafiz (Jackie Shroff) their intention is to organize bombs blasts. Sooryavanshi has more tasks coming in, as he has to find out where those bombs have been stored as well as to nab the members of the sleeper cell.

The film is an action thriller. So cinematically, it feels out of place to see the protagonist delivering long speeches on secularism and patriotism in the middle of many tense operations.

Sangram Bhalerao (Simmba, Ranveer Singh) an Inspector of

Police, and DCP Bajirao Singham (Ajay Devgn) extend their support to Sooryavanshi in his mission.

Akshay Kumar pulls off the stylish and racy action with elan. However, the pre-climax scene embraces Rohit Shetty's over-the-top style.

The film ends with Veer Sooryavanshi, Sangram Bhalerao, and Bajirao Singham dancing for the song track, 'Ailaa Re Ailaa'.

# 'Eternals' skip Saudi release

Chennai, Nov 9: Marvel's 'Eternals', which features the first MCU gay superhero, Phastos, has been

banned in Saudi Arabia and several other Arab countries ahead of its planned November 11 rollout across the Gulf

region. Actor Haaz Sleiman, who came out as gay in 2017, plays the character Ben in 'Eternals'. He is

the husband of Phastos, played by Brian Tyree Henry. Phastos, in the movie, is in a long-time relationship with another man on Earth, but is forced to leave his partner to rejoin the Eternals to take on the Deviants. The Direct, an entertainment news website, has reported how review-bombers are inundating the 'Eternals' page on the Internet Movie Database (IMDB) over the film's inclusion of LGBTQ characters and a kiss between the characters Ben and Phastos.

Sources, meanwhile, confirmed to 'Variety' that despite the film being publicised across the Gulf region on the websites of local multiplex chains, such as top local exhibitor Vox Cinemas, 'Eternals' won't be playing in Saudi Arabia and Kuwait.

# Govt registers logos of iconic 'TOY TRAIN'

Darjeeling, Nov 9: More than two decades after the Darjeeling Himalayan Railway (DHR) was designated a UNESCO World Heritage Site, India has finally registered the logos of the iconic 'Toy Train' internationally as its intellectual property.

The use of these logos anywhere in the world will now require written permission from India and the payment of a fee.

The DHR, which started operations in 1880, more than 140 years ago, has two logos, both of which have been patented. One has "DHR" in bold



black, intertwined letters; the other is a circular seal with a picture of mountains, forests and a river, with "Darjeeling Himalayan Railway" in white lettering on a green background around it.

# Kedarnath temple closes for winter

Uttarakhand, Nov 09: The portals of the Kedarnath temple were on Saturday closed for the winter season, when the shrine remains snowbound. The temple gates were closed at 8 am after rituals were performed by priest Bagesh Ling, the Chardham Devasthanam Board's media cell said.

After the closure of the temple gates, the five-faced idol of Baba Kedar (Lord Shiva) was carried in a palanquin decorated with flowers to the Omkareshwar temple at Ukhimath where he is worshipped during the winter months. Over 2.40 lakh pilgrims visited the Kedarnath temple since the Chardham Yatra began in September this year.

The portals of the Gangotri shrine were closed on Friday. The gates of the Yamunotri temple will



be closed later on Saturday and those of the Badrinath temple will be closed on November 20, marking the end of the Chardham Yatra.

# Shri Ramayana Yatra train

Chennai, Nov 9: In a bid to promote religious tourism, the IRCTC has planned a series of Shri Ramayana Yatra Tours, which will mark a gradual resumption of domestic tourism by trains in view of the improved COVID-19 situation.

The first departure on the Ramayana Circuit train will commence on November 7 from New Delhi followed by four other departures in the subsequent month. Other packages include 12 nights / 13 days Shri Ramayana Yatra Express-Madurai, which will depart on November 16.

The train will start from Madurai with boarding points at Dindigul, Tiruchirappalli, Karur, Erode, Salem, Jolarpettai, Katpadi, Chennai Central,



Renigunta, and Cuddappah. It will cover Hampi, Nasik, Chitrakoot, Allahabad, Varanasi and will return to Madurai. For budget segment tourists of North India, the IRCTC is operating the Shri Ramayana Yatra Express-Sri Ganganagar with its pilgrim special tourist trains, it said. The train will start from Sri Ganganagar with boarding and

de-boarding points at Abohar- Malout, Bhatinda, Barnala, Patiala, Rajpura, Ambala Cantt., Kurukshetra, Karnal, Panipat, Delhi Cantt, Gurgaon, Rewari, Alwar, Jaipur, Agra Fort, Itawah and Kanpur, the statement said. It will cover Ayodhya, Sitamarhi, Janakpur, Varanasi, Prayagraj and Chitrakoot, Nasik, Hampi

and Rameswaram, Kanchipuram and will return to Sri Ganganagar.
