- d) Envelopes containing Postal Ballot Forms received after 5:00 P.M. on Wednesday, 5th June, 2019 if any, was not considered for my scrutiny.
- e) I did not find any de-faced Ballot Paper.
- f) The Company had appointed **Central Depository Services (India) Limited** ("CDSL") as the agency for providing the remote e-voting platform. (https://www.evotingindia.com)
- g) The e-voting period remained open from Tuesday, May 7, 2019 (9.00 a.m.) to Wednesday, June 5, 2019 (5.00 p.m.).
- a) The Shareholders holding shares either in physical form or dematerialized form as on the cut-off date i.e. May 3, 2019 were entitled to vote on the proposed resolution as set out in the notice of Postal Ballot and e-voting dated May 3, 2019.
- b) The result of electronic voting was downloaded on Thursday, June 6, 2019 at 3.16 p.m from CDSL Website providing the platform for e-voting system (<a href="https://www.evotingindia.com">https://www.evotingindia.com</a>) and was unblocked in presence of two witnesses namely Mr. Ashish Patel and Mr. Saurabh Jain who are not in the employment of the Company.
