We refer to our letter dated August 03, 2023 wherein the Company had informed the Stock Exchanges regarding execution of Share Purchase Agreement dated August 03, 2023 whereby Ambuja Cements Limited (ACL), proposed to acquire up to 14,65,78,491 equity shares of the Company representing 56.74% of the equity share capital of the Company.

In view of the same, we wish to inform that the acquisition of 14,08,21,941 equity shares (representing 54.51% of the equity share capital) of the Company by ACL has been consummated.
