नागपूर : मनपाचे आरोग्य येऊनये असे मौखिक आदेश दिल्याची धक्कादायक माहिती प्राप्त झाली आहे. युपीएचसी चाचणी केंद्रासमोरील नोटीसवर मात्र दुकानदारांनी गर्दीकरुन नये,अशी झाकमझाक केल्याचे शब्द

नागपूर, वेगवेगळ्या घटनांमध्ये मंगळवारी प्रकृती खालावल्याने ८ लोकांचा मृत्यू झाल्याचे समोर आले आहे. यामध्ये ३ महिलांचाही समावेश आहे. पहिल्या घटनेत कोराडी हद्दीत वॉर्ड क्र. ४, न्यू कोराडी निवासी किशोर रामदास मडावी (७०) यांचा मृत्यू झाला. प्रकृती खालावल्याने कुटुंबीयांनी त्यांना उपचारार्थ मेयो रुग्णालयात नेले असता डॉक्टरांनी तपासून मृत घोषित केले. दुसऱ्या घटनेत मानकापूर हद्दीत ढोरे लेआऊट निवासी मीराबाई केवलदास मुकाने (६०) यांना मेथोच्या डॉक्टरांनी तपासून मृत घोषित केले. तिसऱ्या घटनेत कपिलनगरहद्दीतसमतानगर, नारीरोडनिवासी कैलासकचरूमल मेश्राम (५४) यांना प्रकृती खालावल्याने उपचारार्थ मेडिकल रुग्णालयात नेले असता डॉक्टरांनी तपासून मृत घोषित केले. चवथ्या घटनेत सक्करदरा हद्दीत गवंडीपुरा, जुना सक्करदरा निवासी अभिमन्यू दादू माने (७३) यांना प्रकृती खालावल्याने मेडिकलमध्ये भरती करण्यात आले होते. उपचारादरम्यान डॉक्टरांनी त्यांना मृत घोषित केले. पाचव्या घटनेत लकडगंज हद्दीत गंगा जमुना वस्तीत राहणारे सुरेंद्र बनवारी मेघ (४०) यांचा प्रकृती खालावल्याने मृत्यू झाला. मेयोच्या डॉक्टरांनी गंना तपासून मृत घोषित केले. सहाव्या घटनेत अजनी हद्दीत रहाटेनगर टोळी निवासी नकूल लखन हातागडे (३५) यांचा प्रकृती खालावल्याने मृत्यू झाला. त्यांना मेडिकलच्या डॉक्टरांनी तपासून मृत घोषित केले. सातव्या घटनेत रामटेकेनगर, बेलतरोड़ी रोड, गल्ली क्र. २ निवासी ललीताबाई श्रीराम अवसरे (४५) यांची मध्यरात्री अचानक प्रकृती खालावली. त्यांना उपचारार्थ मेडिकल रुग्णालयात भरती करण्यात आले. उपचारादरम्यान दुसऱ्या दिवशी रात्री ८ वाजताच्या समारास डॉक्टरांनी त्यांना मत घोषित केले.

सिव्हिल लाइन्स परिसरातील जिल्हा परिषदेच्या मुख्यालयात जिल्ह्याच्या तेराही तालुक्यांतील विविध गावांमधून

प्रवेश बंदी केली आहे. आता जिल्हा परिषदेत मध्ये केवळ आणि केवळ पदाधिकारी. सदस्य. अधिकारी व कर्मचारी यांनाच प्रवेश दिला जात आहे. विशेष म्हणजे, जन्या व नवीन इमारतींना असलेली प्रवेशव्दारे बंद करून प्रत्येक इमारतीमधील एकच प्रवेशव्दार खले ठेवण्यात आले आहे.

स्वच्छ भारत सर्वेक्षणात नागपूर १८ व्या क्रमाकावर

नागपूर :- केंद्र शासनाकडून स्वच्छ भारत प्राप्त झाले आहे अभियानांतर्गत स्वच्छ भारत सर्वेक्षण जानेवारी २०२० मध्ये करण्यात आले होते. या सर्वेक्षणात नागपुर शहराने १८ वा क्रमांक पटकावला आहे. मागच्या वर्षीचे सर्वेक्षणात नागपुर हे ५८ व्या क्रमांकावर होते. या वर्षी रॅंकिंगमध्ये नागपूर शहराने मोठी भरारी घेतली आहे. केंद्र शासनाचे गृह निर्माण आणि शहर विकास मंत्री मा. श्री. हरदीप सिंह पूरी यांनी दिल्लीमध्ये सर्वेक्षणाचा निकाल घोषित केला.

गृह निर्माण आणि शहर विकास मंत्रालयाव्दारे घोषित केलेल्या निकालानुसार महाराष्ट्रातील १० शहरांपैकी नागपर शहर हे पाचव्या क्रमाकावर घाषित करण्यात आल आहे. नागपूरला ४३४५ गुण स्पर्धेमध्ये प्राप्त झाले आहे. नागपूर शहराला सर्व्हींस लेवल प्रोग्रेस मध्ये १५०० पैकी वर्षी ६३.२२ टक्के गुण भेटले होते यावर्षी ७२.४ टक्के गुण व्यक्त केली.




