### AAP, BJP good only at publicity': Priyanka Gandhi at election rally in Delhi

New Delhi: Congress general secretary Priyanka Gandhi Vadra on Tuesday launched a scathing attack on Prime Minister Narendra Modi and Delhi chief minister Arvind Kejriwal, accusing them of splurging money on publicity to hide their lack of work. "AAP and BJP are good only at publicity... Prime Minister Narendra Modi spent Rs 5200 crore on publicity. Kejriwal spent Rs 611 crore on publicity. What is the need to spend so much money on publicity if your work speaks for itself?" she said at an election rally in Sangam Vihar ahead of the February 8 polls. Priyanka claimed that it was under the leadership of late Sheila Dikshit that Delhi had developed. "Sheila Dikshit built Delhi's roads, flyovers and the Metro," she said. The Congress leader lashed out against the AAP over health care and education. "All schools and colleges in Delhi have been built by the Congress. APP promised five hospitals but did not build a single one." The Congress in its manifesto has promised free education from nursery to doctorate in government institutions.

करण्यात आला आहे. या कालावधीत ९३ हजार ९३९ ठिकाणी टाकलेल्या छाप्यांमध्ये हा गुटखा जप्त करण्यात आला आहे. यापुढे गुटखा विक्री करणाऱ्या सूत्रधारांवर मोक्का अंतर्गत कारवाई करण्याचा हालचाली राज्य सरकारने सुरू केल्या

राज्यातील तरुणांमध्ये गुटख्याचे वाढते व्यसन लक्षात घेता २०१२ साली गुटखाबंदी

लागू करण्यात आली. यानुसार राज्यात गुटखा विक्री आणि उत्पादनावर बंदी आली. मात्र तरीही बंदी असताना राज्यात अनेक ठिकाणी अवैद्यरित्या मोठ्या प्रमाणात गुटखाविक्री सुरू आहे. इतर राज्यातून हा गुटखा महाराष्ट्रात येत असून पानपट्ट्यांवर तो सहज उपलब्ध असतो. त्यामुळे राज्यातील गुटखाबंदी फसल्याचं चित्र

दाखल करण्यात आले. मात्र कायद्यात कठोर शिक्षेची तरत्द नसल्याने आरोपी जामीनावर मुक्त होऊन पुन्हा गुटखाविक्री करत असल्याचं समोर आले आहे. त्यामुळे आता महाराष्ट्र खऱ्या अर्थाने गुटखामुक्त करण्यासाठी आणि गुटखाविक्री करणाऱ्या सूत्रधारांना लगाम घालण्यासाठी त्यांच्याविरोधात मोक्का अंतर्गत

मगळसूत्र चोरीच्या आरोपावरून नवी मुंबईत महिलेची निघृण हत्या

हत्या केली. ५५ वर्षीय शारदा गोविंद माळी असं हत्या करण्यात आलेल्या महिलेचे नाव आहे.

पनवेल मधील दुन्द्रे गावात ही खळबळजनक घटना घडली. मंगळसूत्र चोरले असल्याचा आरोप मयत महिलेवर आरोपींनी केला होता. घरात कोणी नसल्याचे पाहन महिलेला

गळफासावर लटकवले, असल्याची प्राथमिक माहिती आहे. या प्रकरणी पीडितेला न्याय मिळालाच पाहिजे. या प्रकरणी पोलिसांनी लक्ष घालून आरोपींना तात्काळ अटक करावे आणि त्यांना कडक शिक्षा द्यावी, अशी मागणी पीडितेच्या नातेवाईकांनी केली आहे. माहितीनुसार क्षुल्लक कारणावरून झालेल्या भांडणात शेजारी राहणाऱ्या आरोपींनी त्यांची हत्या केली आहे. शारदा माळी यांना पहिल्यांदा जाळण्याचा प्रयत्न झाला. यानंतर त्यांना फासावर लटकवून त्यांची हत्या करण्यात आली. पहिल्यांदा ही आत्महत्या असल्याचे

भासविण्यात आले होते. मात्र शारदा यांची अवस्था पाहता त्यांना पहिल्यादा जाळण्याचा प्रयत्न झाला आणि नंतर फासावून लटकवून हत्या केल्याचा आरोप मयताची मुलगी आणि पतीने केला आहे. याप्रकरणी पनवेल तालुका पोलीस ठाण्यात गुन्हा दाखल करण्यात आला आहे. फरार झालेल्या पाच आरोपींचा शोध सुरू आहे. यामध्ये अलका गोपाळ पाटील (४५), वनाबाई अर्जुन दवणे (६०), गोपाळ विट्ठल पाटील (४८), हन्मान भगवान पाटील (४२), अशी आरोपींची नावे असून एक आरोपी अल्पवयीन तरुणी आहे.
