<b>Reason for change (re-appointment)</b>	<p>Latha Pillai (DIN:08378473) was appointed as an Additional Director designated as an Independent Director of the Company under the provisions of the Companies Act, 2013, with effect from 8 March 2019. Subsequently, at the 65<sup>th</sup> Annual General Meeting held on 21 September 2019, her appointment was regularized by the shareholders of the Company by passing an Ordinary Resolution. As per the said resolution, the term of appointment of Latha Pillai was for a period of five consecutive years with effect from 8 March 2019 to 7 March 2024. Accordingly, the term of appointment of Latha Pillai as an Independent Director ends on 7 March 2024.</p> <p>On the basis of recommendation of the Nomination and Remuneration Committee, the Board approved re-appointment of Latha Pillai as an Independent Director for a tenure of five years from 8 March 2024 to 7 March 2029 (both days inclusive), subject to approval of shareholders in the ensuing AGM.</p>
