
# Mohan Bairahi is coordinator of WHLC

On Goswami's advice Vinita invested Rs 50 Lakh from July 2019 to June 2020 in share market through Pankaj Khanchandani's firm.

Vinita alleged that after investing such a huge amount she got nothing and when Vinita asked Pankaj and Mahendra to return her money.

But, both of Pankaj and Mahendra refused to do so alleging that her investment to the tune of Rs 50 lakh sank due to the volatility of share market.

The police told that Pankaj runs an advisory firm in the name of 'Capital Share Research Advisory' in Indore, through which he provides tips pertaining to buying or selling of shares to investors.

Vinita alleged that Pankaj took Rs 50 lakh in
