Madam/Sir,

In terms of Regulation 29 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the Board of Directors of Power Finance Corporation Ltd. (PFC) in its meeting scheduled to be held on Thursday, March 12, 2021 will, inter-alia consider a proposal for payment of Interim Dividend to the shareholders for the Financial Year 2020-21.

Further, it is informed that as per Company's Code of Conduct for regulating, monitoring and reporting of trading by designated persons and their immediate relatives, the trading window is closed with immediate effect till 14<sup>th</sup> March, 2021 for trading in PFC equity shares and listed debt securities (tax free bonds etc.) for all designated persons and their immediate relatives, on account of consideration of proposal for declaration of dividend,

Further, the said trading window shall re-open with effect from March 15, 2021.

During the above mentioned closure period, all designated persons and their immediate relatives are advised not to deal in PFC's equity shares/securities.
