Summary of the proceedings of the 68th Annual General Meeting conducted through Video Conferencing / Other Audio Visual Means

The 68th Annual General Meeting of the Members of National Peroxide Limited ('the Company') was held on Tuesday, September 13, 2022 at 4:00 P.M. (IST) through Video Conferencing ('VC') / Other Audio Visual Means ('OAVM') in compliance with the Circular of Ministry of Corporate Affairs ('MCA') dated May 5, 2020, April 8, 2020, April 13, 200, January 13, 2021, December 14, 2021 and May 5, 2022 (collectively referred to as 'MCA Circulars') along with Circulars of Securities and Exchange Board of India ('SEBI') dated May 12, 2020, January 15, 2021 and May 13, 2022 respectively (collectively referred to as 'SEBI Circulars') and other applicable provisions of the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Mr. Ness N. Wadia, Chairman of the Company, chaired the Meeting conducted through Video Conference. He welcomed the Members and informed that live streaming of the Meeting was being broadcast on NSDL website. He ascertained the presence of requisite quorum and called the Meeting to order. The Company has taken requisite steps to enable Members to participate and vote on items specified in the Notice of the Annual General Meeting. He further informed that the Statutory Registers required to be kept for inspection during the Annual General Meeting were available on the Company website for inspection by Members.

The Notice of the 68th Annual General Meeting and Annual Report for the Financial Year 2021-22 were sent by e-mail to the Members whose e-mail addresses are registered with the Company or the Depository Participants.

The Chairman further informed the Members that the Notice, Directors' Report, Standalone and Consolidated Auditors' Report along with the Standalone & Consolidated Audited Financial Statements were taken as read as the same had already been circulated to Members. As there were no qualifications or adverse remarks in the Statutory Auditors' Report and Secretarial Auditors' Report, the same were taken as read.

The Chairman then delivered his speech and thereafter, the Members who had registered themselves as Speakers were invited to express their views.

The Members were informed that the Company had responded to the queries submitted in advance. The Chairman then requested the Members to raise any additional queries which would be responded either at the Meeting or at their respective email ids.

He thanked the Directors and Members for participating in the Meeting and wished everyone the best of health and safety in the year ahead.

The Chairman authorised CS Heena Shah, Company Secretary to conduct e-Voting and conclude the Meeting.
