## ‘आयकर विवरणिका में बड़े लेन-देन की जानकारी देने की जरूरत नहीं’

नई दिल्ली, 17 अगस्त (भाषा)। कदाताओं को अपने

आयकर रिटर्न नाम में बड़े मुल्य के लेन-देन के बारे में जानकारी नहीं देने होंगी। सरकारी सूत्रों ने यह जानकारी दी।

प्रधानमंत्रालय के वरिष्ठ सरकारी सूत्रों ने एक संज्ञान के जर्नाल में कहा कि आयकर रिटर्न नाम में बड़े मुल्य का फिलहाल को प्रस्ताव नहीं है। उनसे इन संबंध में अंकुश खारों के बारे में पूछा गया था। इन खबरों के मुताबिक 20,000 रुपय से अधिक के होलम भुगतान, 50,000 रुपय से अधिक के जीवन बीमा प्रीमियम भुगतान, 20,000 रुपय से अधिक स्थायत्व चीना प्रीमियम

भुगतान, स्कूल या कॉलेज को साल में एक लाख रुपय से अधिक का अनुदान इत्यादि जैसे वित्तीय लेन-देन की जानकारी देने के लिए रिटर्न नाम का विवरण किए जाने का प्रस्ताव है।

सूत्रों ने कहा कि वित्तीय लेन-देन के बारे में जानकारी को विवरण किए जाने का मतलब होगा कि आयकर विभाग को इस प्रकार के अंकुश मुल्य वाले लेन-देन की जानकारी वित्तीय संस्थान दें। आयकर कानून के हिस्सेय से केवल तबस पर ही इस तरह के लेन-देन की जानकारी आयकर विभाग को देना है।

भारतीय स्टेट बैंक (एसबीआई) के अर्थशास्त्रियों ने हालत वित्त पर देश के सकल घरेलू उत्पाद (जीडीपी) में 16.5 फीसद गिरावट की आशंका जताई है। इससे पहले यह मुंबई की एसबीआई रिपोर्ट में जांच वित्त वकी पकरी तिमाही में जीडीपी में 20 फीसद से अधिक की गिरावट की आशंका जताई गई थी। हालांकि बर्तमान अर्थवित्त पर 16.5 फीसद से अधिक का सकल घरेलू उत्पाद में गिरावट की आशंका जताई गया है।

एसबीआई के अर्थशास्त्रियों ने संयोग्यता को जरा अमान्य रिपोर्ट करारमें कि पहला त्रमा सुनिश्चक कंपनीमें के कामका ससाहा है, कांरपरेय जीवीए (कूव वित्त अंश) गैर-वित्तीय कंपनियों के उभाय से बेहतर परिणाम 2020-21 में आय में गिरावट के मुकाबले बेहतर रहा है। अब तक का 1,000 सुनिश्चक इकायों में पहली तिमाही के वित्तीय परिणामों को संपाक की है। परिणाम बताता है कि कंपनियों की सकल आय में 25 फीसद से अधिक की गिरावट आई है जबकि कुल आय मात्रा मात्र में 55 फीसद से अधिक की कमी देवी की गई है। हालांकि कांरपरेय जीवीए (सकल मुल्य बर्तन) में गिरावट केवल 14.1 फीसद है।

इसके कहा गया है कि जूलाई और आगल में कोराना विषुयुणु की पूय प्राणणु क्षेत्रों में हुई है। कुल तन मामलों में प्राणणु व छोटे वित्त की हरिसदीयारी बरकरार 54 फीसद हुई है। रिपोरट के अनुसार एपेय नुसलण जिला को सखा घटी है जहां 10 से कम कोराना के

मामले थे। आंध्र प्रदेश को महाराष्ट्र प्राणणु क्षेत्र कोराना के बरते मामलों से जूया प्रभावित है। इन जिला को अपन-अपने रणों के सकल राख प्रेरलु उपाय में हरिसदीयारी बरकरार 2 से 4 फीसद है। राजसारा वित्तशाणु सख्त देव है कि कुल जीवीपी नुसलण में शीत 10 रणों की हरिसदीयारी 73.8 फीसद है। इसमें महाराष्ट्र का योगदान 14.2 फीसद है। उसके बाद क्रम से तमिलनाडु (9.2 फीसद) और उतर प्रदेश (8.2 फीसद) का सखा है। इकरारों के अनुसार हरके कारण अखिल भारतीय स्तर पर प्रति वखित नुसलण कुल 27,000 रुपय में है। तमिलनाडु, गुजरात, गुजराण, दिल्ली, हरियाणा, गोवा में यह नुसलण 2020-21 में करीब 40,000 रुपय प्रति वखित है।
