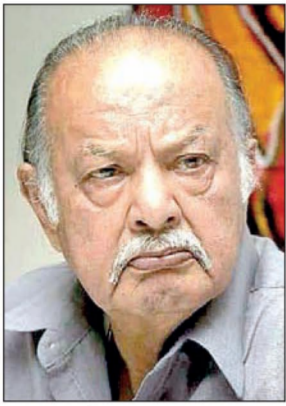

বাংলাদেশের মুক্তিযুদ্ধে ৪ নম্বর সেক্টরের কমান্ডার 'বীর উত্তম' মেজর জেনারেল (অবসরপ্রাপ্ত) চিত্তরঞ্জন দত্ত প্রয়াত। তিনি সি আর দত্ত নামেই বেশি পরিচিত ছিলেন। সোমবার রাত সাড়ে ১১টা নাগাদ মৃত্যুবরণ করেছিলেন।

গোড়ালি ভেঙে যায় তাঁর। হাসপাতালে নিয়ে গিয়ে পায়ে অস্ত্রোপচারও করা হয়। তিনি ইপানির রোগী ছিলেন। সার্জারির পর তাঁর শ্বাসকষ্ট মারাত্মক ভাবে বেড়ে যায়, কিডনিও অচল হয়ে পড়ে। কৃত্রিম শ্বাসপ্রশ্বাসের মাধ্যমে সংজ্ঞা ফেরানো সম্ভব হলেও, পরে অবস্থার আরও অবনতি হয়। সোমবার দুপুরেই চিকিৎসকেরা তাঁকে ফেরানোর আশা ছেড়ে দিয়েছিলেন বলে জানিয়েছেন প্রতীপবাণী।

সুশান্তের রহস্যমত্যা: হবে সাইকোলজিক্যাল অটোপ্লি

সুশান্ত
মুহূর্ত, ২৫ আগস্ট
সুশান্ত সিং রাজপুত মৃত্যুর হঠাৎ মঙ্গলবার সাতাঙ্কুরের কলিয়া ডিয়ারভিও-এর গেষ্ট হাউসে জিজ্ঞাসাবাদের জন্য সিবিআইয়ের গোয়েন্দারা ডেকে পাঠিয়েছিলেন অভিনেতার আ্যাকটিউস্টার রজত সেনগুপ্তকে। এদিনও জিজ্ঞাসাবাদ করা হয় সুশান্তের বন্ধু সিদ্ধার্থ সিংকে। জেরার তালিকা ছিলেন রাধীক শর্মা, সঞ্জয় সিং এবং পরিচালক দীপেশ সাওয়ান্ত। কারণ, ১৪ জুন সুশান্ত মারা যাওয়ার সময় তাঁর বাড়িতেই ছিলেন এই তিনজন।

বুরারিতে একই পরিবারের ১১ সদস্যের একসঙ্গে আত্মহত্যা হওয়ার মর্মান্তিক ঘটনা। এদিকে সুশান্তের বন্ধু সন্দীপ সিং-এর কল রেকর্ড খিরে চাঞ্চল্য। সুশান্তকে যে আত্মহত্যা কুপার হাসপাতালে নিয়ে যাওয়া হয়েছিল তার চালক দাবি করেছিলেন, ১৪ থেকে ১৬ জুনের মধ্যে একাধিকবার সন্দীপ তাঁকে ফোন করেছিলেন। সেই কল রেকর্ড খতিয়ে দেখেছিল একাটি সতর্কতার স্বংবাদ চ্যানেল। সেখানে দেখা গেছে, আত্মহত্যার চার ঘণ্টাও শ্বাসের মৃত্যুর পর একাধিকবার সন্দীপের সঙ্গে কথা হয়েছে কংগ্রেস নেতা সঞ্জয় নিরুপম এবং অভিনেতা সুরজ পাঞ্চোলির মা জারিনা ওয়াহাবের। ২০১৯-এর ১৬ নভেম্বর থেকে ২০২০-র ২৯ জুলাই পর্যন্ত মোট ২৮ বার ফোন করা হয়েছে সন্দীপ ও সঞ্জয় নিরুপমের মধ্যে। সঞ্জয় অবশ্য আগেই জানিয়েছিলেন, ১৪ জুন সুশান্ত মারা যাওয়ার খবর পাওয়ার পর থেকেই তিনি সন্দীপের সঙ্গে ছিলেন। ২০১৯-এর ৪ সেপ্টেম্বর থেকে ২০২০-র ২০ জুন পর্যন্ত মোট ৮ বার দুইদিকে কথা হয় সন্দীপ-জারিনার মধ্যে। অন্যদিকে কল রেকর্ডে দেখা যাচ্ছে, ১৪ জুন সন্ধ্যা ৬-৪০ মিনিটে আত্মহত্যার চার ঘণ্টা অক্ষয় বান্দগারের সঙ্গে ৪৮ সেকেন্ড কথাবার্তা হয়েছিল সন্দীপের। পরের কলটি ছিল ৯-৫৭ মিনিটে। যেখানে ৫১ সেকেন্ড কথা হয়েছে তাঁদের। এতদ্বারা ১৬ জুন যাত্রা দেও সিন্টি ফোনে কথা বলেছিলেন অক্ষয়-সন্দীপ। এর আগে আত্মহত্যার চার ঘণ্টা দাবি করেছিলেন যে, সন্দীপ সিংকে তিনি চেনেন না।

সব বাংলা সহায়তা কেন্দ্র চালু রাখতে নির্দেশ মমতার

রাজ্যের সব কটি বাংলা সহায়তা কেন্দ্র চালু রাখার নির্দেশ দিলেন মুখ্যমন্ত্রী মমতা বানার্জি। মঙ্গলবার জেলা প্রশাসিক বৈঠকে জেলাশাসকদের বলেন, 'গ্রাম বাংলায় মানুষ যাতে ক্যান্ট্রী, শিক্ষাক্রী থেকে শুরু করে সব প্রকল্পের সুবিধা পায়, তার জন্য সব সরকারের সাহায্য করবে এই সহায়িকা কেন্দ্র। রাজ্যে এই মুহূর্তে ২৮০টি বাংলা সহায়তা কেন্দ্র রয়েছে। রাজ্যের সব বিডিও, মহকুমা, জেলাশাসকের দপ্তর এবং জেলার গ্রন্থাগারগুলিতে এই সহায়তা কেন্দ্র খোলা হয়েছে। এই সহায়তা কেন্দ্র কম্পিউটার থাকে এবং দু'জন কম্পিউটার অপারেটর থাকেন। তাদের প্রশিক্ষণও ব্যবস্থা করা হয়েছে। মুখ্যমন্ত্রী বলেন, 'যদি সহায়তা কেন্দ্র কোনও সমস্যা হয়, তা হলে দ্রুত সমাধান করে দেওয়া হবে। জেলাশাসকদের মুখ্যমন্ত্রীর নির্দেশ দেন, এদের অন্য কোনও কাজে লাগানো চলবে না। মানুষের সাহায্যের জন্যই এদের পুরোপুরি ছেড়ে দিতে হবে। প্রত্যন্ত অঞ্চল এলাকার মানুষের কাছে এখনও ইন্টারনেট পৌঁছানো। কীভাবে আবেদন করতে হয়, অনেকের তা জানা থাকে না। সহায়তা কেন্দ্রগুলি সে কাজই সামলাবে। মুখ্যসচিব রাজীব সিনহা জানিয়েছেন, আগ্রহের শ্রেণি কল্যাণ দপ্তরে ডেটা এন্ট্রি অপারেটর হিসেবে এরাই কাজ করবেন।
