In compliance with the provisions of Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 (the 'Act') read with the Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules"), made thereunder, Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the SEBI Listing Regulations"), the Secretarial Standard on the General Meetings ('SS-2') issued by the Institute of Company Secretaries of India each as amended, read with the General Circular Nos. 14/2020 dated 8th April, 2020, 17/2020 dated 13th April, 2020, 22/2020 dated 15th June, 2020 and 09/2023 dated 25<sup>th</sup> September, 2023 issued by the Ministry of Corporate Affairs (collectively the "MCA Circulars") and Circular Nos. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated 11th July, 2023 and SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated 7th October, 2023 issued by the Securities and Exchange Board of India for seeking approval of the Members of the Company to transact the Business as set out in the Notice of 35<sup>th</sup> Annual General Meeting of the members to be held on Thursday, 25<sup>th</sup> July, 2024, by way of remote e-voting process and e-voting at the time of Annual General Meeting.
- 4. The Management of the Company is responsible to ensure the compliance of the requirements of the Act and Rules relating to remote e-voting and e-voting during the 35<sup>th</sup> AGM on the proposed resolutions contained in the Notice. My responsibility as a Scrutinizer for the process of voting through remote e-voting and e-voting during the 35<sup>th</sup> e-AGM is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to making a Scrutinizer's Report for the votes cast in "favour" or "against" on the resolutions proposed in the Notice, based on the reports generated from the e-voting system provided by National Securities Depository Limited (NSDL), the agency authorized under the Rules and engaged by the Company to provide platform for voting through remote e-voting and e-voting during the 35<sup>th</sup> e-AGM and platform for VC/ OAVM facility for participation in the 35<sup>th</sup> e-AGM.
- 5. The Company has confirmed that the electronic copy of the Notice and Explanatory Statement along with the process of remote e-voting and e-voting in terms of the MCA and SEBI Circulars were sent to those members whose e-mail addresses were registered with the Company/Depositories and whose

names appeared in the Register of Members of the Company or Register of Beneficial Owners maintained by the Depositories as on Thursday, 29<sup>th</sup> August, 2024 ("cut-off date"). In order to facilitate those Members who had not yet registered their email IDs, a proper procedure was laid down to get their email IDs registered with the RTA so that they could also participate in the e-voting facility extended by the Company.

- 6. Prior to dispatch of the Notice and Annual Report 2023-24, the requisite advertisement pursuant to the Rules and the MCA Circulars was published by the Company on 4<sup>th</sup> August 2024 in "The Times of India" (English) and "Navprabha" (Marathi) Goa Edition including electronic editions. Post-dispatch of the Notice and Annual Report 2023-24, the requisite advertisement pursuant to the Rules and the MCA Circulars was published by the Company on 12<sup>th</sup> August 2024 in "The Times of India" (English) and "Navprabha" (Marathi) Goa Edition.
- 7. The Company and the EVSP had uploaded the Notice together with the explanatory statement on their respective websites viz. <u>www.igpetro.com</u> and <u>www.evoting.nsdl.com/</u>. The Notice was also uploaded on the website of the stock exchanges where the securities of the Company are listed viz. <u>www.bseindia.com</u> and <u>www.nseindia.com</u>. The Company and the EVSP have complied with all the necessary formalities specified under the Act, the Rules and the Circulars issued in this regard
- 8. The Company has engaged the services of National Securities Depository Limited, as the Electronic Voting Service Provider (hereinafter referred to as "NSDL" or "EVSP") who had made necessary arrangements to facilitate evoting by the Members of the Company on their website www.evoting.nsdl.com/. Members were required to communicate their assent or dissent through remote e-voting and e-voting in terms of the said Circulars. The remote e-voting was kept open from Monday 2<sup>nd</sup> September, 2024 09:00 a.m. to Wednesday 4th September, 2024 05:00 p.m.
- The Members of the Company as on the "cut-off' date, i.e. 29th August 2024 (end of day) were entitled to avail the facility of remote e-voting or voting during the AGM on all the resolutions proposed in the Notice.
- 10. At the end of the remote e-voting period on, 4<sup>th</sup> September, 2024 at 5:00 P.M. (IST), the voting portal of the service provider i.e. NSDL was blocked forthwith.
- 11. At the 35<sup>th</sup> AGM of the Company held on, 5<sup>th</sup> September, 2024, the Chairman at the end of discussions on the resolutions announced that the facility for e-voting is available for voting by the Members attending the Meeting through

VC / OAVM facility and who have not participated in the remote e-voting and who are not otherwise debarred from voting.

- 12. Immediately after the conclusion of the e-voting during the AGM on 5<sup>th</sup> September, 2024, the register containing the details of the e-voting, vis-a-vis the compilation of the data containing the Member's name, DP ID, Client ID and/or folio number, number of shares held, number of votes exercised, votes in favour, votes against were unblocked by me in the presence of two witnesses (who are not in employment of the Company).
