# **CBI** court grants bail to suspended IAS officer Rajesh

**EXPRESS NEWS SERVICE** AHMEDABAD, NOVEMBER 7

A SPECIAL CBI court in Ahmedabad on Monday granted bail to suspended IAS officer Kankipati Rajesh who is facing charges of bribery and illegal gratification in cases related to the grant of arms licences and allotment of government land to ineligible beneficiaries during his tenure as Surendranagar district collector.

The court of special CBI judge Chinmay Ghanshyambhai Mehta took into consideration that Rajesh has a family and has "deep roots in the society", and that he has no criminal antecedents.

Seeking bail, Rajesh stated that he suffers from hyperthyroidism and hypercalcemia, and is "in need of surgery and post operative care". He also submitted that no supplementary chargesheet has been filed against him yet and that he is not required to be kept present before the investigating officer as the entire case is based on documentary evidence and govern-

ment records. The CBI first arrested Rajesh on July 13, nearly two months after an FIR lodged on May 20 on the basis of a written complaint filed by AK Rakesh IAS, additional chief secretary, General Administration Department of

the Gujarat government.

The 2011 Gujarat-cadre IAS officer was booked by the CBI after conducting multiple raids at his Gandhinagar office, residence and in his native place Rajahmundry in Andhra Pradesh.

In May, the CBI had arrested Surat-based businessman Md Rafiq Memon, proprietor of Jeans Corner in Haripura area, for allegedly collecting bribes on behalf of the IAS officer.

Opposing Rajesh's bail plea, the CBI stated that the allegations as made in the FIR "should be viewed seriously and cannot be treated sympathetically" considering his position. The CBI also stated that

Rajesh bought two shops in Surat while he was the district development officer there, at a price significantly below the market rate. "The applicant has abused his official position as a public servant in purchasing these two shops...," the CBI argued while opposing his bail

Gamit from Vyara, Samir Naik from Nizar, Nilesh Zambre from Dang, Suresh Patel from Dharampur and Mahesh Sarad Vasava from Nandod. All of these are candidates for the ST seats.

Apart from the nine seats, the party has also declared three candidates for the general seats of Karjan where Ghanshyam Vasava who is a tribal is being fielded. Similarly, in Olpad, it has fielded another tribal candidate Vijay Vasava and in Jambusar, it has fielded Manilal Pandya.

In 2017, the party contested six seats in a seat-sharing alliance with the Congress. Interestingly, the party is yet to declare candidates in these six seats.

Last month, the party announced it was parting ways with the Aam Aadmi Party after jointly participating in two election rallies in May and August. Following the break-up, the BTP has decided to contest the upcoming assembly polls on its own.
