

Taliban cancels girl education despite pledges

KABUL: Afghanistan's Taliban rulers decided against opening schools to girls above the sixth grade, renegeing on a previous promise and opting to appease their hardline base at the expense of further alienating the international community.

The unexpected decision,

confirmed by a Taliban spokesman Wednesday, came at the start of the new school year in Afghanistan. It is bound to disrupt Taliban efforts to win recognition from potential international donors, at a time when the country is mired in a worsening humanitarian crisis.

The international community

a concession to the rural and deeply tribal backbone of the hardline Taliban movement, that in many parts of the countryside are reluctant to send their daughters to school.

The decision to cancel the return of girls to school came late in the night on Tuesday, Waheedullah Hashmi, external

relations and donor representative with the Taliban-led administration, told The Associated Press.

It was late last night that we received word from our leadership that schools will stay closed for girls, said Hashmi. We don't say they will be closed forever." AGENCIES
