- 1. Un-audited financial results for the third quarter and nine months ended December 31, 2018 of the financial year ending March 31, 2019 and we enclose herewith the unaudited financial results along with Limited Review Report for the said period.
- 2. Resolved to seek approval of members through postal ballot to sell and/or deal otherwise with equity share capital held by the Company in its 100% subsidiaries viz. Future Retail Destination Limited and Gati Realtors Private Limited. The said subsidiaries are special purpose vehicle companies of the Company for setting up large warehouse facilities at Jhajjar, Haryana and Nagpur, Maharashtra respectively which in aggregate constitute approximately 1.3 million sq. ft. warehouse facility, expected to complete in 2019-20. The Board authorized the committee of Directors to do all such acts and deeds as may be required to seek the approval of the members by way of postal ballot including but not limited to finalization of calendar of events, etc.

## Notes to the financial results:

- 1 The above results were reviewed by the Audit Committee and were thereafter approved by the Board of Directors of the Company at its meeting held on January 30, 2019.
- The above financial results have been prepared in accordance with Indian Accounting Standards (Ind AS) 34 "Interim Financial Reporting" as prescribed under section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and the Companies (Indian Accounting Standards) Amendment Rules, 2016.
- 3 The Limited review as required under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 has been completed by the Auditors of the Company and the related report is being submitted to the concerned stock exchanges.
- Figures of the previous financial period / year have been re-arranged / re-grouped / reclassified whereever necessary.
- 5 The Company operates in only one segment namely "Property and Related Services".
- In the Arbitration proceedings before the sole Arbitrator, appointed by the Hon'ble High Court of Calcutta, in respect of disputes arose out of the termination of a license agreement related to a shopping mall known as "Puja Mall", the Arbitrator has awarded a net amount of Rs. 12,90,52,379/- to the Claimant after allowing certain counter claims of the Company. The Company filed an appeal / application against the award in terms of the applicable provisions of law before the Hon'ble High Court of Calcutta. The Claimant also filed an appeal against the award.
