**EXPLANATORY STATEMENT
PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013**

The Board, at its meeting held on March 18, 2024, upon the recommendation of the Nomination & Remuneration Committee, appointed Mr. Kumar Venkatasubramanian (DIN 08144200) as an Additional Director up to the ensuing Annual General Meeting and Managing Director of the Company for a period of 5 (five) years with effect from May 1, 2024, subject to the approval of the shareholders of the Company and that of the Central Government, in accordance with Section 196 of the Companies Act, 2013 (Act) read with Schedule V to the Act, Mr. Kumar Venkatasubramanian being a non-resident at the time of his appointment.

We confirm, basis the declarations received, that Mr. Kumar Venkatasubramanian is not disqualified from being appointed as Director in terms of Section 164 of the Act and that he has not been debarred from holding the office of Director by virtue of any order from SEBI/ MCA or any other such authority. He is not related to any of the Directors of the Company. A Notice under section 160 of the Companies Act, 2013 has been received from Mr. Kumar Venkatasubramanian, proposing his candidature for appointment as Managing Director of the Company.

Mr. Kumar Venkatasubramanian has completed his Bachelor of Engineering from National Institute of Technology, Durgapur and has an MBA from Indian Institute of Management, Calcutta. Mr. Kumar Venkatasubramanian started his career with P&G in India in 2000 in the Sales function from Indian Institute of Management, Calcutta, and worked in various sales leadership roles across India. In his 23+ years career, he has led complex categories across some of the world's largest markets including India, Brazil, and Australia. He rose the ranks in P&G India as he managed partnerships with various distributor operations and key customers. Until 2020, for a few years, he led the P&G India Sales function and the Oral Care category. In 2020, Mr. Kumar Venkatasubramanian was elevated to the role of CEO - P&G Australia and New Zealand where he has delivered record business performance through strong category growth. Over the years, he has led large and diverse teams, with extensive leadership experience to complement his strong strategic business acumen.

Mr. Kumar Venkatasubramanian has also been appointed as Managing Director of Gillette India Limited effective May 1, 2024, subject to requisite approvals. The Board of Directors have provided unanimous consent for his appointment as the Managing Director of Gillette India Limited, at a remuneration that shall be shared by the companies in proportion of their Net Outside Sales (NOS).

Further, we would like to highlight to you that Procter & Gamble Hygiene and Health Care Limited and Gillette India Limited are fellow subsidiaries (P&G group companies) and have been operating in India under common leadership since several years. The Managing Director is supported by a strong line of focused Business Leaders, responsible for each business and function. We believe that this is an optimum way to operate business which has enabled the company to leverage benefits of synergies, which can be seen in the consistent performance of the Company over the past decade. The Board of Directors of Procter & Gamble Hygiene and Health Care Limited and Gillette India Limited have unanimously approved Mr. Kumar Venkatasubramanian's appointment as Managing Director on the two Boards. In our view, appointment of Mr. Kumar Venkatasubramanian as Managing Director on the two Boards is in the best interest of both the Companies. We request you to consider the recommendation in the contextual background and the unique potential it has to serve the best interest of the Company.

Mr. Kumar Venkatasubramanian, being a Non-Resident Indian at the time of appointment, the Company is in the process of making an application to the Central Government for its approval of his appointment as Managing Director as required under law.

The proposed terms and conditions of appointment of Mr. Kumar Venkatasubramanian as a Managing Director are as given below:

1. Remuneration by way of salary, allowances & perquisites upto Rs. 8 Crores shall be paid from Procter & Gamble Home Products Private Limited, a P&G group company.
2. In addition to the above, Mr. Kumar Venkatasubramanian shall be entitled to other benefits, as per P&G group policies, including but not limited to home loan, long service awards, global stock options etc.
3. He shall also be entitled to variable compensation, including but not limited to-
 - Short-Term Achievement Reward (STAR), in line with Company's compensation policies, as may be amended from time to time, being variable payment linked to contribution and impact on business results achieved by the Company and is determined basis certain critical measures including- sales growth, profit growth, value share and internal controls; and
 - Long-term Incentive Program (LTIP)- being grant of Parent Company, The Procter & Gamble Company's (USA) stock options/units, in line with Company's compensation policies, as may be

amended from time to time.

4. The Company, viz., Procter & Gamble Hygiene and Health Care Limited shall contribute to the total compensation in proportion to its Net Outside Sales, in terms of a common service agreement.
5. Contribution from the Company, viz., Procter & Gamble Hygiene and Health Care Limited towards total compensation, including all benefits by way of fixed and variable components, shall not exceed Rs. 6 Crores per annum.
6. He will not be entitled to sitting fees for attending meetings of the Board or any Committees thereof.
7. He shall not be liable to retire by rotation.
8. The terms of remuneration shall not exceed the ceiling as set out in Section 197 of the Act read with Schedule V to the Act, as amended from time to time.

In respect of the said appointment, the Nomination & Remuneration Committee and the Board of Directors, have taken into consideration that Mr. Kumar Venkatasubramanian has expertise in strategic & business operations and experience in the fast-moving consumer goods industry. The Board of Directors are of the opinion that his knowledge and varied experience, will be of great value to the Company and hence recommends passing of the resolution as an Ordinary Resolution by the members of the Company exercising their vote through the Postal Ballot.

None of the Directors, Key Managerial Personnel of the Company and their relatives, except Mr. Kumar Venkatasubramanian to whom the resolution relates, is interested in or concerned with the resolution.
