In terms of provisions of the Companies Act, 2013 and regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company had provided the facility of remote e-voting and e-voting at AGM to the Shareholders to enable them to cast their vote electronically on the resolution proposed in the Notice of the 35th Annual General Meeting (AGM). The remote e-voting was open from 27th September, 2021 (9.00 A.M. IST) to 29th September, 2021 (5.00 P.M. IST).

In line with the provisions of the Companies Act, 2013 read with Circulars issued by MCA and SEBI, the meeting was held through Video Conferencing Mode/ Other Audio Visual Means and e-voting system was provided at the AGM to cast vote. Therefore, at the 35th AGM, evoting system was open for voting during the meeting and for next 15 Minutes after the conclusion of the meeting for members who attended the meeting and have not opted to vote through remote e- voting and were not otherwise barred from voting.

The Chairman of 35th Annual General Meeting (AGM) of the Members of Southern Magnesium And Chemicals Limited held on Thursday, 30th September, 2021 at 11:30 A.M. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM").

Dear Sir,

I, Mohit Kumar Goyal, Partner, D. Hanumanta Raju & Co., Practicing Company Secretaries, had been appointed as the Scrutinizer by the Board of Directors of Southern Magnesium And Chemicals Limited (the Company) pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to scrutinize the remote e-voting process in respect of the below mentioned resolution proposed at the 35th Annual General Meeting ("AGM") of the Company on Thursday, 30th September, 2021 at 11.30 A.M. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"). I was also appointed as Scrutinizer to scrutinize the e-voting process during the said AGM.

The Company has confirmed that the notice dated August 11, 2021 in respect of the below mentioned resolution was sent to the shareholders of the Company on September 6, 2021 through electronic mode to those Members whose email addresses were registered with the Company/Depositories, in compliance with the MCA Circular January 13, 2021 read with circulars dated April 8, 2020, April 13, 2020 and May 5, 2020 (collectively referred to as "MCA Circulars") and SEBI Circulars dated May 12, 2020 and January 15, 2021.

The Company had availed the e-voting facility offered by Central Depository Services (India) Limited ("CDSL") for conducting remote e-voting by the Shareholders of the Company.

The shareholders of the Company holding shares as on the "cut-off" date i.e., Thursday, September 23, 2021 were entitled to vote on the resolution as contained in the Notice of the AGM.

The voting period for remote e-voting commenced on Monday, September 27, 2021 (09:00 A.M. IST) and ended on Wednesday, September 29, 2021 (05:00 P.M. IST) and CDSL e-voting platform was blocked thereafter.

The Company had also provided e-voting facility to the shareholders present at the AGM ANTAR through VC / OAVM who had not casted their votes earlier.

After the conclusion of AGM at 11.45 A.M. the e-voting remained opened for 15 minutes. After conclusion of AGM, the remote e-voting facility provided for AGM and e-voting at AGM was unblocked and no votes were received during the AGM. The report has been generated based on the remote e-voting data downloaded from CDSL e-voting system.

I have scrutinized and reviewed the remote e-voting prior and during the AGM and votes cast therein, based on the data downloaded from CDSL e-voting system.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to quorum, voting through electronic means, etc on the resolution contained in the notice to the 35th Annual General Meeting (AGM) of the members of the Company. My responsibility as a scrutinizer for the e-voting process is restricted to make a Scrutinizer's report of the votes cast "in favour" or "against" the resolution stated in the 35th AGM notice, based on the reports generated from e-voting system provided by CDSL, the authorized agency to provide e-voting facilities, engaged by the Company.
