Amit Sahu held for killing Nagpur based woman BJP worker

Nagpur, Aug 12 (UNI) : A Nagpur-based woman BJP worker Sana Khan was killed by her husband Amit Sahu and he was arrested, police said. According to the police Amit Sahu alias Pappu (37), a resident of Jabalpur in Madhya Pradesh, who runs a dhaba, killed his wife Sana Khan (34) by hitting her with a stick in his house and later dumped her body into a river. The accused said he killed his wife over monetary and personal issues by hitting her with a

stick in his house and later threw her body into the Hiran river from a bridge near Meregaon village under Belkheda police station limits, police told UNI on Saturday.

He was arrested from Jabalpur's Gorabazar area on Friday on the charge of killing Sana Khan, who was the BJP's minority cell functionary in the eastern city of Nagpur, police said.

A search operation is underway to find the victim's body in the river and its nearby areas, police

further said. The accused also revealed the name of his accomplice who was present with him during the offence and a manhunt for that man is also on, police said. Nagpur police registered a case on August 1 and its team visited Jabalpur on August 4 in search of the woman after the probe revealed that as per her last location, she was at a house in Jabalpur.

The Jabalpur and Nagpur police jointly carried out a search at Sahu's house, police added

President Droupadi Murmu gives assent to DPDP Bill 2023

New Delhi, Aug 12 (UNI) : President Droupadi Murmu on Saturday granted assent to the Digital Personal Data Protection Bill, 2023 (DPDP Bill) after it was passed by both the houses of Parliament.

The DPDP bill was passed unanimously by the Rajya Sabha on Wednesday (August 9) while the Lok Sabha passed the bill on Monday (August 7) by voice-vote.

The Bill aims to manage

digital personal data by balancing individuals' right to safeguard their data with the need to lawfully process such data for relevant purposes.

According to the Bill, a person may process the personal data of an individual for a lawful purpose on the basis of their consent and for certain legitimate uses. The Bill has a provision to set up the Data Protection Board of India. The Board on receipt of an intimation of a

personal data breach will inquire into the matter and impose penalty. While determining the amount of monetary penalty to be imposed, the Board will consider the nature, gravity and duration of the breach and the type, and nature of the personal data affected by the breach.

The Bill states that individuals have the right to correction, completion, updating and erasure of their personal data of which they have previously given

consent. Earlier, the Electronics and Information Technology Minister Ashwini Vaishnaw said, the legislation is intended to protect the digital personal data of 140 crore Indians.

"Around 90 crore people of India are connected with the internet and this bill has been brought for the protection of security and privacy of the people in this digital world" he said while participating in the discussion in Lok Sabha

Prithviraj Chavan expresses doubt over release of NCP's Nawab Malik on bail

Satara, Aug 12 (UNI) : Senior Congress leader and former Maharashtra chief minister Prithviraj Chavan on Saturday raised a question over the manner in which NCP leader Nawab Malik was arrested and released on bail. Talking with reporters at Karad of the district, he claimed that the way Malik was arrested was wrong and hinted that there must be politics behind granting bail to him. He claimed that the former minister must have been forced to take a political stance by putting pressure on him because his bail was not opposed by the Enforcement Directorate, CBI or any other investigation agency and this was very indicative, he noted. Malik has still not announced his political affiliation to either Ajit Pawar group or Sharad Pawar group of NCP, Chavan added.

Man gets lifer for murder of his lover in Ratnagiri

Kolhapur / Ratnagiri, Aug 12 (UNI) The district and sessions court at Ratnagiri on Saturday sentenced a man to life imprisonment for murdering his lover at Hatkhamba-Tarvevadi in Ratnagiri district on 10 January 2019.

Accused Santosh Baban Savant, a truck driver, who lived with his wife Sonali in Hatkhamba-Tarvevadi, was in a relationship with Joyti alias Shamika Pilankar, who blackmailed him and demanded money from him for not showing photographs of them in a compromising position to his wife, public prosecutor P R Salvi told the court.

On ill-fated day, there was a dispute between Santosh and Joyti when she demanded money again. Furious over this, Santosh attacked Joyti with a sharp knife, killing her on the spot.

Then, Santosh informed about the incident to his wife Sonali, who in turn informed to Ratnagiri Rural police.

After examining witnesses, Sessions Judge Vinayak Joshi convicted and sentenced Savant to imprisonment for life.

The court also imposed a fine of Rs 10,000 on him.

Addiction leads to destruction; stay away from it: Yogi

Lucknow, Aug 12 (UNI) : Uttar Pradesh Chief Minister Yogi Adityanath on Saturday said that addiction is the cause of destruction and it is one of the reasons which destroys the youth and therefore it is better to stay away from it. The CM was addressing the people after inaugurating 'Nasha Mukh Pradesh-Shashakt Pradesh' (Drug Free State-Empowered State) campaign at KD Singh Babu stadium in Lucknow on the occasion of International Youth Day.

He also administered an oath to the youths belonging to various

organisations, including NSS, Scouts and Guides, to have an addiction-free life on the occasion.

Yogi said, "Addiction is the cause of destruction. It leads to the decline of the youth and the farther we distance ourselves from it, the better we can foster healthy thinking."

The CM further said that it is imperative to connect the 9 crore youth of the state with this campaign in order to give their dreams new wings and to shape UP according to their aspirations.

He said that the theme of International Youth Day this year is 'Green Skill for

Youth: Towards a Sustainable World'.

Yogi said, "According to this theme, it's our collective responsibility to connect with this campaign which aims to make the most populous state, UP, addiction-free and subsequently empowered."

He said that UNICEF is associated with several programmes in the state. "Many diseases that have been plaguing the youth and children for years, including encephalitis, are now being addressed."

When organisations like UNICEF coordinated with the central and state governments, diseases like encephalitis were eradicated. Remember, if a government programme against diseases can achieve success, why can't solutions be found for artificially induced diseases," he said.

The Chief Minister emphasised that while being youth individuals should be nurturing new dreams aligned with their personal, societal and national futures, but if they become addicted it renders them hollow from within, making them incapable of functioning effectively.

He said, "Their work

ethic declines, their ability to think creatively diminishes and they become detached from campaigns requiring strong commitment. Eventually, they become passive and lose the potential to contribute positively towards the society," Yogi said.

Citing examples, the CM said that many people are addicted to tobacco and tobacco products, which damages their teeth. He said that it also has adverse effects on the tongue, the lungs, the oesophagus and the stomach.

He said that to make the state drug-free, the Youth Welfare Department is running an extensive public awareness campaign in collaboration with UNICEF. "Responding to the appeal of Prime Minister Narendra Modi, a campaign is being carried out in the state to link its youth with these creative programmes," Yogi said.

He said, "In every village, there should be a playground, a mini stadium at every block level and a stadium in every district. All these programmes instil a sense of sportsmanship in the youth."
