Brief Proceedings of the 26th Annual General Meeting of the Company

He further informed that the remote e-voting period had commenced on Monday, September 27, 2021 at 9:00 a.m. (IST) and had ended on Wednesday, September 29, 2021 at 5:00 p.m. (IST).

The Chairman informed the members that the facility to vote through ballot paper had been provided at the venue of the AGM. The Chairman informed that the members present at the meeting and who had not already cast their vote through remote e-voting, could cast their vote through ballot paper and deposit it in the ballot box kept at the venue of the AGM.

The Chairman informed that the Board of Directors have appointed Mr. Rahul Falodiya, Chartered Accountant, as the Scruitniser to scrutinise the remote e-voting and the voting by the use of ballot paper at the AGM, in a fair and transparent manner.

The Chairman informed that the Scrutiniser shall submit a consolidated scrutinisers report, not later than 48 hours of the conclusion of the AGM.
