VJIM LEADERSHIP SERIES: MUMBAI DABBAWALLAS

They say, to build your organisation around people with a sense of purpose and value; this was what the students of V.J.I.M. saw in their recent monthly leadership series. The students got the opportunity to interact and learn from Mumbai's famous Dabbawalla. Dabbawalla's representatives, Mr Ritesh Shantaram Andre – spokesperson of Dabbawalla and Mr Sapan Gangaram Medge who works as a dabbawalla in the organisation who came in the traditional attire of Dabbawallas, which was appreciated by the audience. Their clothing spoke a million words about their journey and their organisational culture.

The dabbawallas spoke about identifying their niche in an environment filled with food delivery services. They found the need for fresh home-cooked meals in the city of dreams – Mumbai and worked towards satisfying that need, differentiating them from their competitors. The speaker explained how the Dabbawallas started in 1890 as an informal group with 100 workers. Later, with changing times, they evolved into an organized structure with almost 5000 dabbawallas serving home-cooked meals all over Mumbai. The Dabbawalla created a strong organisation based on their principles: work is worship, the customer is God, and Human values. The aspect that caught the audience's attention was how they spoke about their organisation and how the presenters were filled with passion and pride in their work. The Dabbawallas talked about their beyond six-sigma performance; they achieved this through their coding system. They have been at the top of their game due to their pricing structure, organizational structure and, more importantly, their code of conduct.

This session was an excellent opportunity for the students to know how determination and hard work bring out the best in a person and an organisation. The spectators also understood that Dabbawallas' is not just a delivery service agency; it stands for discipline and principles.
