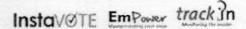

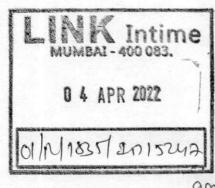

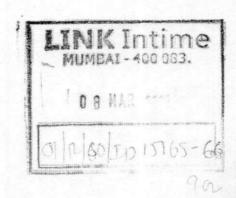

This is applicable for all the security holders in physical mode.

The sallent features and requirements of the circular are as follows:
