The 37th AGM of Oswal Greentech Limited (hereinafter "the Company") was held on Wednesday, 25th September, 2019 at 10:30 A.M. at Registered Office at Near Jain Colony, Vijay Inder Nagar, Daba Road, Ludhiana -141003 (Punjab). In Compliance with provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as substituted by the Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulation), the Company provided to its members the remote e-voting facility to exercise their right to vote in respect of the resolution proposed at the AGM, convened vide notice dated 9th August, 2019, through e-voting platform hosted by NSDL from Sunday, 22nd September, 2019 (09:00 A.M.) to Tuesday, 24th September, 2019 (05:00 P.M.). Members who could not cast their votes through remote e-voting but attended the AGM, were also provided with the opportunity to vote through poll at the said AGM.

In the absence of Chairman of the Company, Mr. Anand Agrawal, Director present was elected as the Chairman of the meeting. Thereafter, the quorum was ascertained, position of members and proxies were announced, and the meeting was called in order. The Notice and Directors Report was taken as read with the permission of present members. The Chairman asked Mr. H.K. Gupta, Company Secretary to read the Auditors' Report on the Accounts for the year ended 31st March 2019.

Thereafter, shareholders raised questions and the management replied to the same.
