CERTIFICATE UNDER REGULATION 40(9) OF THE SEBI (LISTING OBLIGATIONS AND DISCLOSURE REQUIREMENTS) REGULATIONS, 2015

FOR THE HALF YEAR ENDED SEPTEMBER 30, 2019

We have examined all Share Transfer Deeds, Memorandum of Transfers, Registers, files and other documents relating to **I G Petrochemicals Limited** ("The Company") as maintained by **M/s Bigshare Services Pvt. Ltd.**, the Registrar and Share Transfer Agent, pertaining to transfer of Equity Shares of the Company for the period from **April 1, 2019 to September 30, 2019** for the purpose of issuing a Certificate as per Regulation 40(9) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Based on the information provided and confirmed by Registrar and Share Transfer Agent, we hereby certify that during half year ended on **September 30, 2019**:

- A) Share certificates relating to transfer of shares, as entered into Memorandum of Transfers, were issued within fifteen (15) days from respective date of lodgment of each deed of transfer, except those rejected on technical grounds and mentioned below. Also, cases in which seller notices had been issued, Share Certificates have been issued within thirty (30) days from respective date of lodgment
- Thirty Five (35) cases, where seller notice were not issued, involving 5,350 shares were processed after 15 days but within 30 days; and*
 - Nineteen (19) cases involving 2300 shares were processed with significant delays.*
- B) The Company has received Nine (9) requests covering 1700 Equity Shares for Transmission of shares. Share Certificates relating to the transmission of Shares received by the Company, as entered in the Memorandum of Transmission, were issued within 21 days from respective date of lodgment of each request for transmission, *except Seven (7) requests involving 1,500 shares were processed and certificates were issued after 21 days from the date of lodgment of request for transmission;*

The Company has received Fourteen (14) cases covering 1800 Equity Shares for name deletion. Share Certificates relating to name deletion received by the Company were issued within 15 days from date of lodgment of each request, *except Twelve (12) involving 1700 shares were processed and certificates were issued after 15 days from the date of lodgment of each request for name deletion; and*



The Company has received Thirty Four (34) request covering 5400 Equity Shares for issue of Duplicate share certificates. Share Certificates relating to issue of Duplicate Share Certificates received by the Company were issued within 30 days from date of lodgment of each request, *except Twenty Four (24) requests involving 4200 shares were processed and certificates were issued after 30 days from the date of lodgment of each request for name deletion.*

- C) There were no requests for change of name, split, rematerialization, sub-division, consolidation, renewal, exchange, endorsement, replacement.
