This year's APEC conference has been the focus of global attention, with Presidents Joe Biden and Xi Jinping using the event for their first meeting in a year in a bid to ease US-China tensions that have threatened economic growth worldwide.

Later Wednesday, Xi had dinner with US business leaders including Apple Inc. CEO Tim Cook and BlackRock Inc.'s Larry Fink.

A month ago, Fraser initiated the biggest restructuring of Citigroup in two decades as she seeks to simplify the firm and boost returns. The bank intends to cut back to eight layers from 13 as part of the work. Fraser has said Citigroup is doing away with as many coheads as possible to ensure there are "single points of accountability" across the firm.

With the moves, Citigroup is abandoning its two core operating units and instead focusing on five key businesses: trading, banking, services, wealth management and US consumer offerings.

Fraser also is weighing whether to shutter the firm's municipal-bond trading and origination business, which for decades was a powerhouse in reserves took a hit the \$4 trillion market for US state and local debt, Bloomberg News reported earlier this month, citing people familiar with the matter.


