- The meeting commenced at 04.00 P.M. and concluded at 04.20P.M.
- Requisite quorum was present throughout the Meeting. Total 22 members were present in the video conference.
- With the consent of the Board and with the permission of the members, Shri Candra Winoto Salim - Director, chaired the Meeting.
- The Chairman informed that, in view of the Pandemic COVID-19 the Annual General Meeting of the Company is being conducted through VC/OAVM pursuant to the guidelines of the Ministry of Corporate Affairs and Securities Exchange Board of India. The live streaming of the meeting was also being webcasted on the CDSL platform.
- The Chairman of the Meeting delivered his speech.
- Notice of the Annual General Meeting was read by the Shri V V Subrahmanyam and Auditors Report was taken as read with permission of the members.
- The Chairman requested the Members to express their views and to raise queries. None of the shareholder raised any queries.
- Shri V V Subrahmanyam informed the members that pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, as amended, and Regulation 44 of the SEBI (LODR) Regulation, 2015, the Company has arranged for e-voting facility to its members in respect of all the businesses to be transacted at the 35<sup>th</sup> AGM of the Company. The e-voting commenced on 26<sup>th</sup> September, 2022 (9:00 hours) and ended on 29<sup>th</sup> September, 2022 (17:00 hours).
- Shri V V Subrahmanyam informed the members, who have not cast their vote through e-voting facility, to cast their votes in respect of all the resolutions proposed in the notice during the AGM.
