
Pursuant to Regulation 30 of SEBI (LODR) Regulations, 2015, this is to inform you that the Board of Directors of the Company at their meeting held on today, i.e. August 3, 2019, has considered and approved the addition of capacity by setting up "New State of Art Plant at Bhiwadi" unit.

S No	Basis of points	Clarification
1	Rationale	Relaxo Footwears Limited (RFL) had existing capacity of 7.50 lakh pairs per day for manufacturing footwear. To derive benefits of synergies and to meet peak season demand and to be ready for future growth, RFL is proposing to add capacity of 1.00 Lakh pairs per day of footwear in Bhiwadi Rajasthan. The capacity will be added in three years.
2	Mode of financing	RFL will fund setting up of plant through Internal accruals.
3	Investment required	The total investment required to for installation of the proposed Plant is ~ Rs. 90 Crores.
4	Period within which the proposed capacity is to be added	Proposed capacity will be added in three years.

5	Existing capacity utilization & Existing capacity	RFL has existing capacity of 7.50 lakh pairs per day of footwear in existing plants in last FY19. The capacity utilization of the existing plants is ~ 75% which goes upto ~ 90% in the peak season.
	,	Considering the future growth and potential for footwear growth, this new plant will be set up with additional capacity of 1.00 lakh pairs per day of footwear to cater future demand.
