Pursuant to Regulation 30 read with Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we are pleased to provide hereunder the proceedings of Extra-ordinary General Meeting ("EGM") of the Members of TIRTH PLASTIC LIMITED ("the Company") held on Friday the 12th January, 2024 at 04:00 P.M. (IST) through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") in accordance with the circular(s) issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India in this regards and business (s) mentioned in the Notice dated 14th December, 2023, convening the EGM were transacted thereat.

Proceedings in brief:

- The Extra-ordinary General Meeting (EGM) of the Company was held on Friday the 12th January, 2024, through two-way Video Conference (VC) /Other Audio Visual Means (OAVM) in accordance with the applicable provisions of Companies Act, 2013 read with the Rules issued thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. The proceedings of the meeting commenced at 04:00 P.M.
- Mr. VARIS MAHENDRABHAI DOSHI, Chairman of the meeting, chaired the proceedings of the meeting.
- The requisite quorum being present through Video Conference, the Chairman called the meeting to order and welcomed all the Directors and shareholders of the Company to the EGM.
- The Chairman informed the members that the Company had taken all feasible efforts under the current circumstances to enable members to participate through video conference and vote at the EGM and then provided general instructions to the members regarding participation in the meeting. The remote e-voting period which had commenced on Tuesday, 9th January, 2024 (09:00 A.M. IST) and ended on Thursday, 11th January, 2024 (05:00 P.M. IST). The Company had provided facility to the members to cast their votes electronically, on all resolutions set forth in the Notice convening the EGM of the Company. The Board of Directors of the Company at their meeting held on 14th December, 2023 had appointed, Mr. Anish Shah, Practicing Company Secretaries (FCS: 4713 CP: 6560), as the Scrutinizer for scrutiny of the votes cast through the remote e-voting platform and electronic voting during the EGM.

After the conclusion of the Speech, the members were informed the following:

- Members who had not cast their votes through remote e-voting platform were provided an opportunity to cast their votes, electronically during the EGM.

No speaker shareholder spoke/raised queries/made comments on the Agenda items. Necessary clarifications/ responses were provided to the members by the Management of the Company.

The following items of business, as per the Notice convening the EGM of the Company dated 14th December, 2023 were transacted at the meeting:

1. To approve Appointment of Mr. Ashish Hasmukhlal Shah (DIN: 08297813) as Non-Executive and Independent Director of the Company

The members were informed that voting on the NDSL platform would continue for another 15 minutes so as to enable the members to cast their votes during the EGM.

The Chairman, thereafter, thanked all the members for their participation at the EGM and for their constructive suggestions and observations.

On completion of the e-voting process, the meeting concluded ((including the time allowed for e-voting at the EGM) at 04:28 P.M.

The Members were informed that a consolidated report on total votes cast in favour and against would be submitted by the Scrutinizer within 48 hours of the conclusion of EGM and the same would be forthwith declared by the Company by notifying to the Stock Exchanges and publishing it on its website www.tirthlimited.in and the website of NDSL www.evoting.nsdl.com.
