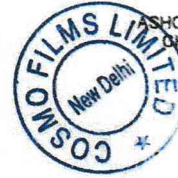
Notes:

- 1 The above audited financial results were reviewed by the Audit Committee and approved by the Board of Directors on 4th June 2020. The figures for the quarter ended 31st March 2020 and 31st March 2019 are the balancing figures between audited figures in respect of the full financial year and published year to date figures upto to the third quarter of years ended 31 March 2020 and 31st March 2019 respectively.
- 2 These financial results have been prepared in accordance with the recognition and measurement principles of applicable Indian Accounting Standards ('Ind AS') notified under the Companies (Indian Accounting Standards) Rules, 2015 as specified in section 133 of the Companies Act, 2013.
- 3 The Board of Director had declared interim dividend of Rs. 15/- per equity share on 13th February 2020 for the financial year 2019-20. No final dividend is recommended by the Board.
- 4 The outbreak of Coronavirus (COVID-19) pandemic globally and in India is causing significant disturbance and slowdown in economic activity. The Company is engaged in the business of flexible packaging films which is part of essential commodities, and therefore, the pandemic has so far had negligible impact on the business operations of the Company. The management has exercised due care, in concluding on significant accounting judgements and estimates, inter-alia, recoverability of receivables, impairment assessment of financial and non-financial assets, realisability of Inventory and accordingly noted no significant impact on its financial results. Further, management believes that the Company will be able to discharge the liabilities as and when falling due. The Company will continue to monitor current and future conditions and impact thereof on Company's operations.
- 5 The Company has adopted IND AS 116 "Leases" effective 1 April 2019, as notified by the Ministry of Corporate Affairs (MCA) in the Companies (Indian Accounting Standards) Amendment Rules, 2019 using modified retrospective method. The adoption of this standard did not have any material impact on the profit of the quarter and year ended 31 March 2020.

Further, in terms of the provisions of the Act, the respective Board of Directors of the companies included in the Group, covered under the Act, are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act, for safeguarding of the assets of the Group, and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively, for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial results, that give a true and fair view and are free from material misstatement, whether due to fraud or error. These financial results have been used for the purpose of preparation of the Statement by the Directors of the Holding Company, as aforesaid.
5. These annual financial results have been audited by other auditors whose audit reports have been furnished to us by the management, and our opinion in so far as it relates to the amounts and disclosures included in respect of these subsidiaries is based solely on the audit reports of such other auditors, and the procedures performed by us as stated in paragraph 11 above.

Further, of these subsidiaries, annual financial results of three subsidiaries located outside India have been prepared in accordance with accounting principles generally accepted in their respective countries, and have been audited by other auditors under auditing standards generally accepted in the United States of America, Korean Standards on Auditing and Singapore Standards on Auditing. The Holding Company's management has converted the financial results of such subsidiaries from accounting principles generally accepted in their respective countries to accounting principles generally accepted in India. We have audited these conversion adjustments made by the Holding Company's management. Our opinion, in so far as it relates to the balances and affairs of these subsidiaries, is based on the audit report of other auditors and the conversion adjustments prepared by the management of the Holding Company and audited by us.

Our opinion is not modified in respect of this matter with respect to our reliance on the work done by and the reports of the other auditors.

- 2 These financial results have been prepared in accordance with the recognition and measurement principles of applicable Indian Accounting Standards ('Ind AS') notified under the Companies (Indian Accounting Standards) Rules, 2015 as specified in section 133 of the Companies Act, 2013.
- 3 The Board of Director had declared interim dividend of Rs. 15/- per equity share on 13th February 2020 for the financial year 2019-20. No final dividend is recommended by the Board.
- 4 Net profit before tax and after tax for March 2020 quarter have been impacted by provisioning of Rs. 11 crores as impairment in market value of assets in overseas subsidiaries.
- 5 The outbreak of Coronavirus (COVID-19) pandemic globally and in India is causing significant disturbance and slowdown in economic activity. The Group is engaged in the business of flexible packaging films which is part of essential commodities, and therefore, the pandemic has so far had negligible impact on the business operations of the Group. The management has exercised due care, in concluding on significant accounting judgements and estimates, inter-alia, recoverability of receivables, impairment assessment of financial and non-financial assets, realisability of Inventory and accordingly noted no significant impact on its financial results. Further, management believes that the Group will be able to discharge the liabilities as and when falling due. The Group will continue to monitor current and future conditions and impact thereof on Group's operations.
- 6 The Group has adopted IND AS 116 "Leases" effective 1 April 2019, as notified by the Ministry of Corporate Affairs (MCA) in the Companies (Indian Accounting Standards) Amendment Rules, 2019 using modified retrospective method. The adoption of this standard did not have any material impact on the profit of the quarter and year ended 31 March 2020.
