PROCEEDINGS OF THE 14TH ANNUAL GENERAL MEETING OF THE COMPANY HELD ON TUESDAY, 26TH SEPTEMBER, 2023

- 3) Re-appointment of M/s P. G. Bhagwat LLP, Chartered Accountants, Pune (Firm Registration No.101118W/W100682) as Statutory Auditors of the Company and to fix their Remuneration (Ordinary Resolution).

SPECIAL BUSINESS:

- 4) Re-appointment of Mr. Sanjeev G. Joglekar (DIN: 00073826) as an Independent Director of the Company (Special Resolution).
- 5) Payment of Commission to Non-Executive Director (Special Resolution).

The Chairman informed that the members who have not casted their votes through Remote e-Voting can exercise their votes at the AGM and the e-Voting facility will remain open for 15 minutes after conclusion of the meeting and will be disabled thereafter.

The members were informed that Mr. Sridhar Mudaliar, Practicing Company Secretary has been appointed as the Scrutinizer to scrutinize the votes cast through remote e-Voting and at this meeting. The Chairman authorised Company Secretary to declare the results of e-Voting on receipt of Scrutinizer's Report within two working days of conclusion of the meeting and the same shall be forwarded to the Stock Exchanges and also uploaded on the Company's website and on the website of NSDL.

There being no other business, Chairman concluded the meeting with a vote of thanks to the Directors and members present for attending the AGM. The meeting concluded at 11.27 a.m. (including the time allowed for e-voting at the AGM).
