### Rationale

Axis Bank Limited's (Axis Bank) ratings are supported by its strong position in the Indian financial system by virtue of being the third-largest private sector bank with a 5.9% share in advances and a 5.0% share in the deposits of the banking system as on December 31, 2022. Further, the bank concluded the acquisition of Citibank's consumer business on [March 1, 2023](#), which will help widen its customer base and market share across some retail and wealth segments, while allowing it to gain from the addition of a granular deposit base. Axis Bank has guided towards near-to-medium-term integration costs and a one-time impairment of the goodwill, intangibles, policy alignment and other transaction related costs on the acquisition in Q4 FY2023. Despite this, its capitalisation profile will remain comfortable with the cushions above the regulatory levels expected to remain over 400 basis points (bps).

Further, the overall improvement seen in the profitability levels is expected to largely sustain, which will be supportive from a growth and capital perspective. Axis Bank's ratings also factor in the strong liability profile, with a steady increase in granularity, which is reflected in the high share of retail term deposits (RTDs) and current account and savings account (CASA) deposits in total deposits. Additionally, the bank's headline asset quality metrics have remained on an improving trajectory, supported by the gradual decline in fresh non-performing assets (NPA) generation as well as strong recoveries and upgrades. However, macroeconomic factors, including elevated input and commodity prices, and their associated impact on a wider set of customers and their servicing abilities, will remain monitorable. Nevertheless, the overall asset quality metrics are expected to remain at much better levels compared to the weaker levels seen in past years. Over and above this, the bank continues to operate with large prudent provisions, which can help absorb some of this impact if the same materialises.

Going forward, apart from the ability to sustain the improvement in the granularity of the deposit base and deposit costs, the ability to realise synergies from Citibank's business will remain critical for further improvement in the operating profitability level while pursuing growth. The Stable outlook on the ratings reflects ICRA's view that Axis Bank will continue to maintain its strong position in the Indian banking sector while maintaining its asset quality, profitability and solvency position.

ICRA has withdrawn the rating assigned to the Rs. 2,500-crore Basel II Lower Tier II bonds as these are fully redeemed and no amount is outstanding against the rated instrument. The rating was withdrawn in accordance with ICRA's policy on withdrawal ([click here for the policy](#)).

## Key rating drivers and their description

### Credit strengths

**Strong position in financial services industry supports the share of granular assets** – Axis Bank is the third-largest private bank and the seventh-largest bank in the overall Indian banking sector, with the share of advances in banking sector credit at 5.9% as on December 31, 2022 (against 6.2% as on March 31, 2022). Furthermore, Axis Bank through its subsidiaries, namely Axis Capital Limited, Axis Asset Management Company Limited, Axis Finance Limited and Axis Securities Limited, offers various financial services across investment banking, asset management, securities broking and lending. It has also expanded its foothold in the insurance distribution business following the Group's acquisition of a ~13% stake in Max Life Insurance Company Limited, with the option to acquire an additional ~7% stake in the near future.

Axis Bank's net advances witnessed a strong pickup in growth over the past few quarters with a year-on-year (YoY) growth between 14% and 15%. This supported the growth in net advances to Rs. 7.62 lakh crore as on December 31, 2022. The growth momentum was largely driven by the granular retail book, which continued to increase at a comparatively higher pace of ~17% YoY as on December 31, 2022. Going forward, ICRA expects the bank to remain focused on growing its granular retail book, which will support an improvement in its profitability metrics as well.

**Capital cushions expected to remain strong** – Axis Bank's capitalisation profile remains strong with common equity tier I (CET I), Tier I and CRAR (as a percentage of risk-weighted assets; RWAs) at 15.5%, 16.1% and 19.5%, respectively, as on December 31, 2022. The capital position was strengthened by equity capital raises, totalling ~Rs. 33,700 crore during FY2018-FY2021. The meaningfully large capital raise has helped widen the capital cushions, offsetting the impact of weak internal capital generation due to elevated credit costs during the aforesaid period. Meanwhile, the bank's overall earnings profile has improved gradually with the moderation in credit costs, thereby supporting its growth and capitalisation.

Furthermore, the goodwill and intangibles impairment related to the acquisition of Citibank's consumer business (acquired for Rs. 11,603 crore) in Q4 FY2023 has been estimated at ~137 bps (on the basis of the bank's RWA position in December 2022), while the capital charge of the acquired book is estimated at 40 bps. In ICRA's view, despite the one-time impact of the acquisition, the overall capital cushions above the regulatory levels are expected to remain better than ICRA's negative rating trigger. Besides this, internal capital generation is expected to remain healthy and support Axis Bank's near-to-medium-term growth. Further, the bank has demonstrated ability to raise equity capital in the past.

**Steady growth in granular deposit base, although cost of interest-bearing funds remains higher than peer banks** – The bank's overall deposit base grew by a strong 9.9% YoY to Rs. 8.48 lakh crore as on December 31, 2022. This was driven by the 9.6% YoY growth in the lower-cost CASA deposits, while term deposits also grew by 10.1% YoY during this period. Accordingly, CASA/total deposits stood at 44.6% as on December 31, 2022, which remains higher than the private sector average, although it remains lower than the >50% levels seen in the past. Nevertheless, the bank continues to steadily grow its granular RTD base, which accounted for 61.8% of the total term deposits as on December 31, 2022 (63.4% as on March 31, 2022). Together, CASA and RTD dominate the deposit profile at 79% of the total deposits, which, to an extent, helped narrow the asset-liability gaps for the bank over time. Furthermore, Citibank's retail deposits base, amounting to Rs. 39,900 crore (4.70% of Axis Bank's deposit base as on December 31, 2022) has a healthy share of CASA deposits at 77% which is expected to improve the CASA ratio by 150 bps.

However, Axis Bank's interest rate proposition remains marginally higher than peer banks, resulting in a relatively higher cost of interest-bearing funds for the bank compared to peer private sector banks. Further, with an increase in policy rates, the cost of interest-bearing funds rose to 4.26% in Q3 FY2023 (3.92% in 9M FY2023 and 3.71% in FY2022) and is likely to rise further in the near to medium term. Going forward, the bank's ability to achieve stronger growth while maintaining or improving the cost differential will remain key for supporting an improvement in its operating profitability.

**Earnings profile improves; sizeable prudent provisions provide cushion to profitability** – While net interest margin (NIM)/average total assets remained steady at 3.06% in FY2022 (3.07% in FY2021 and 2.94% in FY2020), it improved to 3.47% in 9M FY2023 largely led by the expansion in interest spreads. As the impact of the Covid-19 pandemic subsided and the growth momentum improved, non-interest income also witnessed an improvement. However, this was offset by the sharper rise in the overall operating expense level as the bank continues to grow its franchise. As a result, the operating profitability remained between 2.1% and 2.6% during FY2021-9M FY2023. While elevated credit costs had weighed down the return on assets (RoA) in the past, it improved steadily to 1.7% in 9M FY2023 from 1.2% in FY2022 and 0.7% in FY2021, despite the mark-to-market (MTM) losses on the investment book in 9M FY2023. Furthermore, the bank continues to hold prudent provisions, excluding standard asset provisions and including provision on restructured assets, of ~Rs. 6,000 crore or 0.8% of standard assets as December 31, 2022.

Furthermore, with the impairment of goodwill and intangibles in Q4 FY2023 itself, incremental impairment or capital-related impact from the acquisition is expected to remain limited. However, the bank will need to retain and grow the acquired customer franchise to offset the steady-state increase in the operating costs as well as the integration-related costs (guided at ~Rs. 1,500 crore spread over next two years). Axis Bank has stated that the acquired businesses have been reasonably profit accretive and there could be cost synergies as well as cross-selling opportunities in future, which are the key benefits of the acquisition. However, these will be highly dependent on the bank's ability to retain and expand the wallet share of the acquired customers. In case of high attrition in the acquired customer franchise, the expected revenue and cost synergies may not materialise and could moderate the profitability metrics over the next few years. Nevertheless, ICRA expects Axis Bank to maintain RoA >1.0%, which shall be sufficient for its growth capital requirements over the medium term.

### Credit challenges

**Impact of macroeconomic factors on asset quality remains monitorable** – The gross fresh NPA generation rate moderated to 2.1% (annualised) in 9M FY2023 from 2.9-3.3% during FY2021-FY2022, and was meaningfully lower than the levels seen prior to the onset of the pandemic. Further, slippages have largely been from the retail segment which was relatively more severely impacted by Covid-19, while lumpy slippages in the corporate book remained limited in relation to earlier levels. Supported by lower slippages as well as strong recoveries and upgrades, the gross and net NPA% improved to 2.6% and 0.5%, respectively, as on December 31, 2022 (3.4% and 1.0%, respectively, as on December 31, 2021). Axis Bank's overall restructured book remains manageable (0.3% of standard advances), while the corporate book rated BB and below (excluding restructured accounts; 0.5% of standard advances) could remain a potential source of near-to-medium-term stress. However, this is expected to be manageable, considering the healthy operating profitability and sizeable prudent provisions. Going forward, the impact of various macroeconomic factors including rising input and commodity prices, which could pressurise the servicing abilities of certain vulnerable borrowers, will remain a monitorable.

### Environmental and social risks

While banks like Axis Bank do not face material physical climate risks, they are exposed to environmental risks indirectly through their portfolio of assets. If the entities or businesses to which banks and financial institutions have an exposure, face business disruptions because of physical climate adversities or if such businesses face climate transition risks because of technological, regulatory or customer behaviour changes, it could translate into credit risks for banks. However, such risk is not material for Axis Bank as it benefits from adequate portfolio diversification. Further, the lending is typically short-to-medium term, allowing it to adapt and take incremental exposure to businesses that face relatively lesser downside environmental risks.

With regard to social risks, data security and customer privacy are among the key sources of vulnerability for banks as any material lapses could be detrimental to their reputation and invite regulatory censure. Axis Bank has not faced such lapses over the years, which highlights its sensitivity to such risks. It is seen to be operating responsibly in terms of its selling practices with no instances of fines imposed by the regulatory authorities because of misconduct. Customer preferences are increasingly shifting towards digital banking, which provides an opportunity to reduce the operating costs. Axis Bank has been at the forefront of making the requisite investments to enhance its digital interface with its customers. While it contributes to

promoting financial inclusion by lending to the under-served segments, its lending practices remain prudent as reflected in the healthy asset quality numbers in this segment compared with its peers.

### Liquidity position: Strong

Axis Bank's liquidity remains strong with the daily average liquidity coverage ratio (LCR) at 116% in Q3 FY2023 against the regulatory requirement of 100%. Besides this, the bank's reported net stable funding ratio (NSFR) stood at 136% as on December 31, 2022, above the regulatory ask of 100%. Further, it reported excess statutory liquidity ratio (SLR) holding of ~Rs. 60,500 crore, translating into ~7% of net demand and time liabilities, which is above the regulatory requirement of 18%. The excess SLR holding above the regulatory levels can be utilised to avail liquidity support from the Reserve Bank of India (RBI; through reverse repo) apart from the marginal standing facility of the RBI in case of urgent liquidity requirement.

### Rating sensitivities

**Positive factors** – Not applicable as all the ratings are at the highest possible levels

**Negative factors** – ICRA could assign a Negative outlook or downgrade the ratings if there is a material weakening in the bank's liability franchise, thereby impacting its resource profile. This apart, a deterioration in the asset quality or capital position, leading to the weakening of the solvency profile with net NPA/core capital of >15% on a sustained basis, could be a negative trigger. Further, a sustained RoA <1.0% and/or a fall in the capital cushions over the regulatory levels, to less than 4% at the CET I level, on a sustained basis will remain negative triggers. Additionally, the weakening of the distributable reserves eligible for the coupon payment on the AT-I bonds will be a negative trigger for the rating for these bonds.

Consolidation/Standalone	For arriving at the ratings, ICRA has considered the standalone financials of Axis Bank. However, in line with ICRA's limited consolidation approach, the capital requirement of the key subsidiaries of the Group, going forward, has been factored in. In ICRA's view, Axis Bank's subsidiaries will largely remain self-sufficient in meeting their capital requirements in the near to medium term and the bank will continue to comfortably meet the regulatory capital requirements at the consolidated level

### About the company

Incorporated in December 1993, Axis Bank Limited is a private sector bank. The bank's promoter group includes Life Insurance Corporation of India (LIC) and Specified Undertaking of the Unit Trust of India (SUUTI), which collectively held 8.19% of the shares as on December 31, 2022 compared to 9.70% of the shares as on March 31, 2022, 11.64% as on March 31, 2021 and 13.88% as on March 31, 2020. As on December 31, 2022, Axis Bank had the third-largest network of branches among private sector banks with 4,849 branches and an international presence through branches in DIFC (Dubai) and Singapore along with representative offices in Abu Dhabi, Sharjah, Dhaka and Dubai and an offshore banking unit in GIFT City.

### Key features of the rated instruments

The Basel III Tier II Bonds are expected to absorb losses once the point of non-viability (PONV) trigger is breached in the RBI's opinion. The rated Basel III Tier I (AT-I) and Basel III Tier II instruments are hybrid subordinated debt instruments with equity-like loss-absorption features. Such features may translate into higher loss severity vis-à-vis conventional debt instruments.

The rating for the Basel III AT-I Bonds is one notch lower than the rating for the Basel III Tier II Bonds as these instruments have the following loss-absorption features that make them riskier.

- The coupon payments are non-cumulative and discretionary, and the bank has full discretion at all times to cancel the same. The cancellation of discretionary payments shall not be an event of default.
- Coupons can be paid out of the current year's profits. However, if the current year's profit is not sufficient or if the payment of the coupon is likely to result in a loss, the coupon payment can be made through the reserves and surpluses created through the appropriation of profits (including statutory reserves). However, the coupon payment is subject to the bank meeting the minimum regulatory requirements for the CET I, Tier I and total capital ratios (including capital conservation buffer, CCB) at all times, as prescribed by the RBI under Basel III regulations.

These Tier I bonds are expected to absorb losses through the write-down mechanism at the objective prespecified trigger point fixed at the bank's (CET I) ratio as prescribed by the RBI, i.e. 6.125% of the total RWAs of the bank or when the PONV trigger is breached in the RBI's opinion.

The distributable reserves<sup>1</sup>, that can be used for servicing the coupon in a situation of inadequate profits or a loss during the year, stood at a comfortable 9.1% of RWAs as on December 31, 2022. The rating on the Tier I bonds continues to be supported by the bank's sound capitalisation profile and the expectation of improved profitability, going forward.

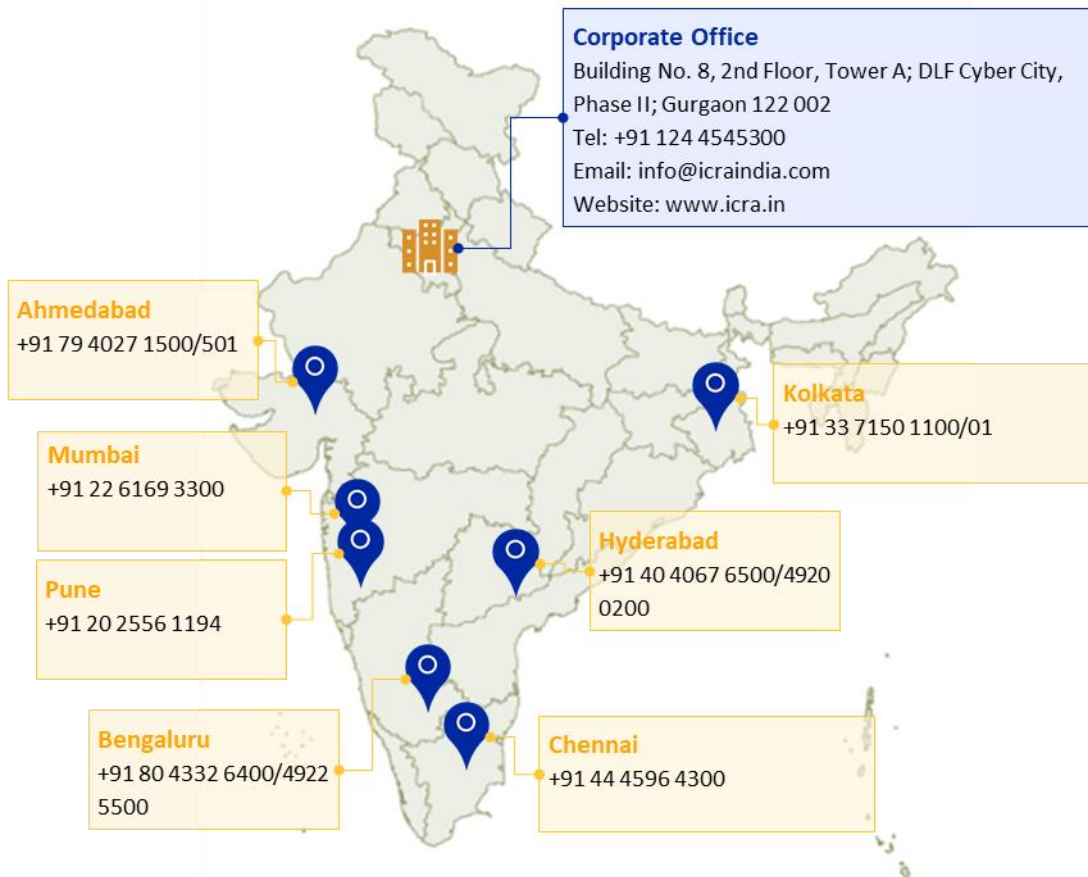
